Dear Mr Norton:

I am writing to file a formal complaint against the Committee to Elect Gabriel Pearse for Congress 2004. This Committee has committed a number of violations as outlined by the Federal Election Campaign Act.

After carefully searching the appropriate FEC website, we have been unable to find any Receipts and Disbursements (FEC Form 3) filings on behalf of this candidate even though Mr. Pearse did file a Statement of Organization on December 31, 2003. In addition, this candidate also filed a Statement of Candidacy form on January 2, 2004 and was listed on the Democratic Party ballot as a candidate for the New York September 14, 2004 Primary. (Enclosed: Primary Election Results).

What I find particularly troubling is the fact that as a candidate for Congress for the 11th Congressional District of Brooklyn, New York, Mr. Pearse maintained an active Web Site, distributed hundreds of campaign posters, printed materials and other related material without filing one disclosure form as mandated by the Federal Election Campaign Act under the Campaign Finance Law. I am certain that such expenditures for his campaign activity did in fact exceed the statutory minimum \$5,000.00 as required by the FEC.

Finally, because of the seriousness of this matter, I would appreciate a thorough investigation as soon as possible.
