To Whom It May Concern:

For the reporting period of 07/15/2004-09/30/2004 (October Quarterly), Steve Reifman for Congress reported no debts or obligations owed to CompleteCampaigns.com, however this is a misstatement. As of 09/30/2004, Steve Reifman for Congress owes CompleteCampaigns.com \$450.00. Enclosed is a copy of the contract between Steve Reifman for Congress and CompleteCampaigns.com, a statement reflecting the amount due as of 09/30/2004 and a copy of the collection letter sent to the committee on 10/06/2004.

Since CompleteCampaigns.com specifically informed Steve Reifman for Congress of the FEC regulations on reporting debt and obligations, we can only assume that their actions are willfully fraudulent.

CONTRACT FOR SERVICE

This Contract for Service (the "Agreement") is made and effective this 12 day of July '04 (the "Effective Date") by and between CompleteCampaigns.com, LLC, a California limited liability company ("Developer"), having its principal place of business at 610 Gateway Center Way, Suite K, San Diego, California 92102, and the Committee to Elect Steve Roifman ("Licensee"), having its principal place of business at PO Box 251234 West Bloomfield, MI 48325.

RECITALS

- A. WHEREAS, Developer provides and markets computerized political campaign services and has developed and offers software for campaign management, fundraising, accounting and website development;
B. WHEREAS, Developer is the owner of the Software and Documentation (as defined in the "Terms of Service"); and
C. WHEREAS, Developer desires to grant to Licensee and Licensee desires to obtain from Developer a non-exclusive license to use the Software and Documentation solely in accordance with the terms and on the conditions set forth in this Agreement

AGREEMENT

NOW, THEREFORE, in consideration of the mutual promises set forth herein, the parties hereto agree as follows.

This is an Agreement between Licensee and Developer regarding Licensee's use of Developer's data hosting and information management service on the Internet. This Agreement governs the terms and conditions under which Developer makes the Developer's Service available on the Internet. Under this Agreement, you must comply with Developer's "Terms of Service," as updated from time to time by Developer, which can be viewed at http://www.completecampaigns.com/legal/policy.html, which is incorporated in this agreement by reference. PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY. BY ACCEPTING SERVICES FROM DEVELOPER, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE, DO NOT SIGN THIS AGREEMENT

1. License

2. Amendment

Developer may modify the "Terms of Service" at any time in its sole discretion. Any modification is effective immediately upon either a posting on the Developer's Home Page, currently located at URI: http://www.completecampaigns.com, or by a message from Developer sent by electronic mail, or by conventional mail. If any modification to this Agreement is unacceptable to you, you may immediately terminate your subscription as provided below. However, if you do not terminate your registration within ten days of the amendment being posted by Developer, or continue to use the Developer's Service, following notice of any modification to this agreement, your continued use will mean that you have accepted that modification

3. Term


This Agreement shall take effect upon the Effective Date and shall continue in full force and effect, unless earlier terminated as provided herein, for a period of one (1) month. Thereafter, this Agreement shall be automatically renewed and continue in full force and effect in successive monthly subscription periods unless otherwise terminated by either party upon not less than thirty (30) days prior written notice to the other, or until otherwise terminated pursuant to this Agreement.

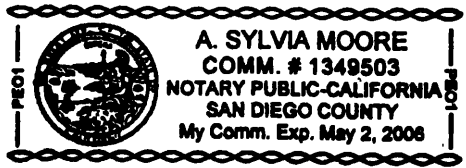
