5. Upon information and belief, including verifying with FEC Informational staff via telephone as to the 2002 Great Northwest Classic Committee, all these committees are federal committees and any contribution to these committees counts toward the aggregate limit set forth in 441(a)(3).

6. The contributions to federal committees which are listed above total \$28,000 for the year 2002, violating the \$25,000 aggregate limit set forth in 2 U.S.C. §441(a)(3), which was applicable prior to the passage of the Bipartisan Campaign Reform Act of 2002.

7. With one slight variant on the Doolittle filing, Mr. Gelwix lists his address on each filing as:

Poway, CA 92064

He listed 15751 El Camino Intrada as his address on the Doolittle filing.

RELIEF

8. TheRestofUs.org respectfully requests that the Federal Elections Commission investigate this matter and take appropriate enforcement action.


