Dear Commissioner,

David Bruderly, FEC ID # C00381210, has been a candidate for the U. S. House of Representatives for Congressional District 6 of Florida for the past 2 general elections and is again for the upcoming general election in November 2006. During his candidacies, he has had to submit 20 FEC reports, the same as everyone else who has been a candidate/incumbent for the same period of time. Of these 20 required reports, he has received 15 requests from the FEC for additional information to correct inconsistencies/deficiencies. Even though he has received those 15 requests, he has submitted 28 amended reports attempting to correct deficiencies caught not only by the FEC but also by himself. (Exhibit (9)) Unfortunately, as will be shown below, glaring inconsistencies still exist making it impossible for anyone looking at his campaign's financial situation to know exactly how much he has received in contributions, how much he has disbursed, and how much cash-on-hand he had at the end of each quarterly report.

1. In trying to determine exactly what Mr. Bruderly's campaign committee's financial situation is, the reports, or last amended report for a particular quarter, submitted for the current election cycle (2006) were read and spreadsheets compiled in attempting to establish the financial condition of his campaign. The beginning cash on hand figure used was the ending cash for the Pre-General Report, 10/1 – 10/13/04. The following errors leaped out:
 - a. The Post-General Report for 10/14-11/22/04, Page 1, Reports of Receipts and Disbursements, has the wrong election date of 11/23/04 instead of 11/02/04. (Exhibit 1)
 - b. The Post-General Report for 10/14-11/22/04, has the wrong date for the Column B, Election Cycle Total (11/23/2004 instead of 11/02/2004) and the wrong dates for Column C (11/24/2004 through 11/22/2004 instead of 11/03/2004 through 11/22/2004). (Exhibit 2, pg 3/33)
 - c. The Post-General Report for 10/14-11/22/04, pages 5/33 and 5/34, does not break down Disbursements for the General Election 2004 and for the Primary Election 2006. A review of Schedule B of the Itemized

Disbursements shows that \$23,494.56 was disbursed between 10/14 and 11/02 while \$9615.80 was disbursed between 11/03 and 11/22/04. (Exhibit 3)

- d. On Page 18/33 of Schedule B, Itemized Disbursements of the Post-Election Report, he lists expense reimbursements to himself of \$3,469.33 and \$4,191.47 but with no memo entries explaining the ultimate recipient/s of those expenses \$200.01 and above or aggregating \$200.01 and above to the same vendor. (Exhibit 3, pg 18/33)
- e. Page 6/33 of the Post-Election Detailed Summary Page, Part V Cash Summary, Item 26 shows Total Disbursements At This Period to be \$33,613.37. (Exhibit 4) However, Page 29/33 of Schedule B Itemized Disbursements, the total figure at the bottom of the page shows a total of \$33,110.36. (Exhibit 4) There is a \$503.01 unexplained discrepancy.
- f. Although there was a Request for Additional Information from the FEC requesting Mr. Bruderly to correct certain errors in the Post-Election Report and to submit an amended report, there was no request to correct the contributions and disbursements to show those attributed to Election Cycle 2004 and Election Cycle 2006 nor did he correct them himself when he submitted the amended report. (Exhibits 5, 3 and 4)
- g. In the Year End Report for 2004, Election Cycle-to-Date figures reported in Column B on the Summary Page for Receipts and Disbursements (Page 2), the Detailed Summary Page of Receipts (Page 3) and the Detailed Summary Page of Disbursements (Page 4) are grossly incorrect as follows:
- (1) He received no contributions since the cycle began on 11/03/04 but there is a Cycle-to-Date figure of \$109,614.18 (Exhibit 6, pg 2);
 - (2) On Page 5/9, he reports an itemized disbursement to himself of \$4949.68 on 11/23/04 but no breakdown by memo entries as to what expenses in excess of \$200.01 were being reimbursed (Exhibit 6, pg 5/9);
 - (3) The \$4949.68 was not reported in the Summary Page of Receipts and Disbursements, Page 2, Column A, Line 7(a), nor was it reported on the Detailed Summary Page of Disbursements, Page 4, Column A, Line 17. (Exhibit 6, pg 5/9 and Pg 2, lines 7(a) and 7(c)) As a result, the cash on hand figure at the end of the reporting period is grossly overstated and is carried through in all subsequent reports. (Exhibit 7)
 - (4) There was a Request for Additional Information from the FEC for this report, however, there does not appear to be an amended report for this period. (Exhibit 8, Pg 2 of 4 and Exhibit 9))

- h. Exhibit (10) is a spreadsheet compiled from the latest reports Mr. Bruderly has submitted covering the 2006 Election Cycle 11/03/04 through 12/31/05. All entries in the spreadsheet in columns C through H were the figures taken from those lines in the Summary pages of each report. (Note that the \$4949.68 is not shown since it was not in Mr. Bruderly's original Year-End Report.) Column I was compiled from the figures reported in Columns C through H. Comparing the figures in Column I with what his submitted reports show in Column B of the Summary Pages indicates great discrepancies.
- i. Exhibit (11) was compiled from the Cash Summary of each report and shows that, in spite of all the amendments, he still carried forward the wrong Beginning Cash-On-Hand figure for the Year-End Report 10/01/05-12/31/05. (Exhibit 11 and Exhibit 12, pg 4)
- j. Exhibit 7 is a spreadsheet that was compiled using the ending Cash-on-Hand figure of \$24,943.36 from the 2004 Pre-General Report as the beginning Cash-on-Hand figure for the Post-General Report. For each period reported on by Mr. Bruderly, the total Receipts/Contributions reported and the total Disbursements reported for that period are shown as columns C and E respectively. Each entry in Column E was then subtracted from Column C, and using the beginning cash on hand as the ending cash for the current period being reported on, column G was computed. Column G shows what the ending cash on hand figures should have been if Mr. Bruderly had used the correct cycle-to-date figures for the cycle beginning on 3 November 2004 and had included the \$4949.68 figure he reported in the Itemized Disbursements in his Year-End report for 2004. Column H lists the figures he actually reported.

Based on all the foregoing, I urgently request that a compliance audit be conducted of Mr. David Bruderly's campaign committee Bruderly For Congress funds. The public has become very conscious of where elected officials, and those candidates seeking election, are getting their money, where it is being expended, and how much is left. Accuracy and transparency is of paramount importance.

Your attention to this matter is greatly appreciated.




