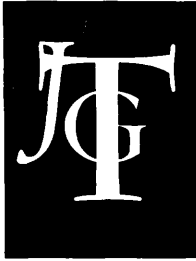

I am responding on behalf of Congressman Joe Schwarz and the Schwarz for Congress campaign. You sent a letter regarding two complaints filed by the Walberg for Congress campaign (MUR 5782 and MUR 5793)


Our campaign ads, titled "Response" and "Family" contained the proper disclaimers, with the Congressman's photo appearing at the same time as his voice disclaimer. Contrary to claims by the Walberg campaign, not one television station pulled these ads. In fact, several of the stations on which we purchased time, have their lawyers review the ads to make sure everything is done in accordance with the law.

It appears the Walberg campaign is basing their complaint on versions of the ad that appeared on the Schwarz campaign web site. These were not the actual ads that were placed with the television stations.

I am not an attorney, but served as a consultant on the Congressman's campaign. We would be glad to provide you with the actual ads that ran on the air. Just let me know the format you would like to receive the actual video versions.

If this matter is to be pursued, please inform us and we will retain legal counsel.
