Dear Mr. Jordan,

I am the treasurer for Citizens for Altmire, the committee associated with Jason Altmire's congressional campaign in Pennsylvania's Fourth District. I am writing in response to your letter of October 4, 2006 which indicated that a complaint has been filed against the campaign. As soon as the problem to which the complaint refers came to the attention of the campaign, the problem was immediately remedied and steps have been taken to ensure that such a problem will not occur again.

Specifically, on or around Friday, September 15, 2006, Citizens for Altmire erected thirteen billboard advertisements. These billboards were paid for directly by Citizens for Altmire. The invoices from Design Dynamics, Inc., the company that created the paper for the billboards, and Crest Advertising, the company that erected the billboards, are attached to this letter.

On or around the evening of Tuesday, September 19, 2006, the campaign was notified that the billboards in questions did not include the required disclaimer indicating that Citizens for Altmire was responsible for paying for the billboards. As Design Dynamics, Inc. and Crest Advertising had already closed for the evening, the campaign contacted both companies the following morning on or around Wednesday, September 20, 2006. Design Dynamics, Inc. immediately began printing disclaimers which Crest Advertising posted on each of the 13 billboards in question on or around Friday, September 22, 2006.

As an example, pictures of the billboard posted on Route 18 North near Rochester, PA are attached to this letter. Each of the thirteen billboards now displays the disclaimer "Paid For By Citizens for Altmire."


The failure to include the disclaimer on the original billboards was caused by miscommunication between the campaign and Design Dynamics, Inc. The campaign

took action immediately after being notified of the problem and remedied the problem within three days of its notification, the least amount of time necessary to print the disclaimers and post them on the billboards.
