III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)

Hawkeye PAC ("the Committee") filed an Amended 2006 October Quarterly Report on January 30, 2007 disclosing additional disbursements totaling \$64,940.17 (Attachment 2).

On October 15, 2006, the Committee filed the 2006 October Quarterly Report, covering the period of July 1, 2006 through September 30, 2006 (Image 26940435106). The original report disclosed \$26,607.47 in disbursements on Line 21(b) (Other Federal Operating Expenses) and \$210,000.00 in disbursements on Line 29 (Other Disbursements) of the Detailed Summary Page (Image 26940435109).

On January 30, 2007, the Committee filed an Amended 2006 October Quarterly Report, covering the period of July 1, 2006 through September 30, 2006, (Image 27960025231). The Amended 2006 October Quarterly Report disclosed \$26,797.64 in disbursements on Line 21(b) (Other Federal Operating Expenditures) and \$274,750.00 in disbursements on Line 29 (Other Disbursements) of the Detailed Summary Page (Image 27960025234).

On March 14, 2007, a Request for Additional Information ("RFAI") was sent to the Committee referencing the Amended 2006 October Quarterly Report, received January 30, 2007. The RFAI sought clarification regarding \$64,940.17 in additional disbursements on Line 21(b) (Other Federal Operating Expenses) and Line 29 (Other Disbursements) that were not disclosed on the Committee's original 2006 October Quarterly Report (Image 27039402889).

On April 20, 2007, the Reports Analysis Division ("RAD") analyst called Gina Noll, Treasurer, and advised her that an issue on the Committee's Amended 2006 October Quarterly Report,, could be referred to our Alternative Dispute Resolution Office for further review. The Analyst explained the issue dealt with an increase in activity. Ms. Noll responded that she knew she should have responded last week, and said she would take care of the matter. The Analyst gave her a response deadline of Thursday, April 26, 2007 (Attachment 3).

To date, no further communication has been received from the Committee regarding this matter.


