III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)

The Chicago Board of Options Exchange Inc. Political Action Committee ("the Committee") amended its 2007 April Monthly Report to disclose additional receipts totaling \$128,715.79 (Attachment 2).

On April 18, 2007, the Committee filed its original 2007 April Monthly Report covering the reporting period from March 1, 2007 through March 31, 2007. This report disclosed \$0.00 in receipts on Line 11(a)(i) (Itemized Contributions from Individuals/Persons Other Than Political Committees), \$0.00 in receipts on Line 11(a)(ii) (Unitemized Contributions From Individuals/Persons Other Than Political Committees) and \$0.00 in receipts on Line 17 (Other Federal Receipts) of the Detailed Summary Page (Image 27930647809).

On May 18, 2007, the Committee filed an Amended 2007 April Monthly Report, which disclosed \$2,300.00 in receipts on Line 11(a)(i) (Itemized Contributions From Individuals/Persons Other Than Political Committees), \$124,200.00 in receipts on Line

11(a)(ii) (Unitemized Contributions From Individuals/Persons Other Than Political Committees) and \$2,215.79 in receipts on Line 17 (Other Federal Receipts) of the Detailed Summary Page (Image 27930735540).

On June 15, 2007, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2007 April Monthly Report, received May 18, 2007. Among other discrepancies, the RFAI requested clarification regarding the \$128,716¹ in additional receipts on Lines 11(a)(i), 11(a)(ii) and 17 that were not disclosed on the Committee's original 2007 April Monthly Report (Image 27039453432).

On July 5, 2007, the Committee filed an Amended 2007 April Monthly Report, which disclosed \$126,000.00 in receipts on Line 11(a)(i) (Itemized Contributions From Individuals/Persons Other Than Political Committees), \$500.00 in receipts on Line 11(a)(ii) (Unitemized Contributions From Individuals/Persons Other Than Political Committees) and \$2,215.79 in receipts on Line 17 (Other Federal Receipts) of the Detailed Summary Page (Image 27990187179).

On July 16, 2007, the Committee filed an Amended 2007 April Monthly Report. This report disclosed no change in the amount of receipts disclosed by the Committee (Image 27990305568).

Subsequently on July 16, 2007, the Committee filed a miscellaneous electronic submission (Form 99) referencing the 2007 April Monthly reporting period, which stated in full:

“Due to keypunch errors manual receipts for \$128,716 were recorded into the wrong reporting period, April instead of March. An audit of the bank statement and the FEC report revealed that the receipts were recorded to the wrong month. The receipts were updated in the PAC Manager System to reflect the correct reporting period and the April report for March activity was amended immediately. It is our intention to report receipts properly. Additional staff has been added to assist with the preparation and review of the FEC reports and reconciliations.” (Image 27990305705)

On July 26, 2007, the RAD Analyst called the Committee regarding the RFAI sent referencing the Amended 2007 April Monthly Report, received May 18, 2007. The Analyst notified Ms. Irma Love, the reports preparer, that due to the increased financial activity that was not originally disclosed on the 2007 April Monthly Report, the matter would be referred to ADRO. The Analyst encouraged Ms. Love to submit any additional relevant information via a miscellaneous electronic submission (Form 99), for review by ADRO staff (Attachment 3).

To date, no further communication has been received from the Committee regarding this matter.
