As and for a Complaint pursuant to relevant provisions of the Federal Election Campaign Law and Commission Regulations, Thomas D. Buchanan, Chairman, Schenectady County GOP hereby alleges as follows:

1. Complainant is the Chairman of the Schenectady County Republican Committee, and files this Complaint both individually, and on behalf of said Committee.
2. Respondent, Schenectady County Democratic Committee is a local political organization, organized pursuant to the laws of the State of New York.
3. Upon information and belief, based upon filings with the New York State Board of Elections, the Schenectady County Democratic Committee maintains an address at 831 Maxwell Drive, Schenectady, New York 12309.

4. Upon information and belief, on or about October 22, 2007, Respondent Schenectady County Democratic Committee solicited, received and deposited in its account, a campaign contribution in the amount of \$5,000.00 from "Canarx Services, Inc.". A copy of the public filing, located on line at the New York State Board of Elections website, is attached hereto as Exhibit A.

5. Upon information and belief, Canarx Services, Inc. is a foreign principal pursuant to Federal Law.

6. Pursuant to 11 CFR §110.20(c) a local party committee may not receive contributions, in any amount, directly or indirectly, from foreign nationals.

7. Accordingly, the Schenectady County Democratic Committee has violated Federal Law, and is subject to fines and sanctions pursuant thereto.

8. Upon information and belief, Canarx Services, Inc.'s principal place of business is in Ontario, Canada. Attached hereto is a D&B Company profile, listing their principal place of business, with a single location, at 525 Windsor Avenue, Windsor, Ontario, Canada (Exhibit B). The address listed on the financial disclosure, from which the contribution arrived, was at P.O. Box 21086 Tecumseh Ontario.

9. Upon information and belief, the source of the funds, directly or indirectly, were derived from a foreign national.

10. Upon information and belief, Canarx Services, Inc. is not a domestic subsidiary of a foreign national.

11. Upon information and belief, even if Canarx Services, Inc. were a domestic subsidiary of a foreign national, which it was not, the source of the funds from which the contribution was derived, were subsidized, in whole or in part, by a foreign corporate parent.

12. Upon information and belief, Canarx Services, Inc. has no interest in government within the County of Schenectady other than to secure favorable treatment by being awarded a County Contract for sale of foreign drugs.

13. There can be no dispute that this contribution was received, that it was reportedly received from a foreign national on public filings with the State of New York, and that same constitutes a violation of Federal Law.

WHEREFORE, your Complainant respectfully requests an investigation and audit of Respondents campaign fund raising tactics, together with an Order finding a violation with respect to the contribution at issue, ordering Respondent to return said contribution to its source, and levying a civil penalty on the

Respondent in an appropriate amount to discourage such conduct in the future.
