The Complaint.

During the 2010 election year the Lapeer County Democratic Party of Michigan ID#001417, made campaign donations to Henry Yanze for Congress totaling \$2737.75. As these donations were made through their County Party organization they illegally exceeded the \$1000.00 per. year aggregate spending limit county political party committees are allowed to spend on Federal Elections and Federal Candidates as set forth by the Bipartisan Campaign Reform Act.

These expenditures caused great concern to the Republican voters and individual contributors in Lapeer County. Their County Parties insistence at following the letter of the law and limiting Republican Party expenditures for all federal Candidates to the annual \$1000.00 gave their competitors almost a 3 to 1 spending advantage. Although they have been assured the Federal Election Commission will address the matter, it has caused great cynicism due to (1) the damage will have already been done before any action is taken, and (2) they doubt if any action will be taken.

It is appropriate at this time to note that the recipient of these illegal donations, **Henry Yanze for Congress ID:HOMI10212** never bothered to report these or thousands of dollars of other contributions to his campaign for U.S. Congress 10<sup>th</sup> Congressional District, State of Michigan. A separate complaint in regard to this accusation is in the process of being filed.

While the damage to the integrity of the election system in Lapeer County has been already been done, resolute action in regard to this complaint will aid in restoring confidence that the "little guy" still has some rights in the political process and that those rights will be protected.

The Complaint.

This complaint is in regard to Candidate for the Michigan 10<sup>th</sup> Congressional District Representative, Henry Yanez, failure to report ANY campaign donations for the 2009-2010 election cycle. The donations I can prove total more than \$6000.00, exceeding the \$5000.00 threshold that holds any candidate for Federal Office responsible for reporting donations and expenditures in a timely manner.

Candidate Yanze did file for a committee: ID C00489955 and designated Arianna Welsh as the committee treasurer. But the committee never filed a report of any kind during any of the required reporting periods. Please see the attached evidence for donations from:

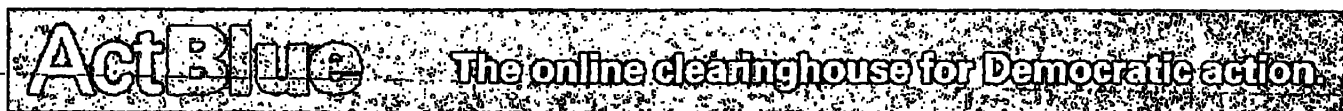

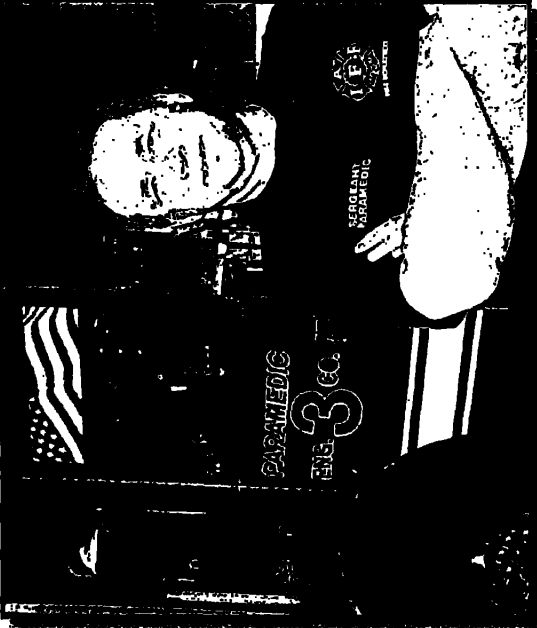
