In response to your letter dated February 24, 2012 regarding the complaint filed by Kelly Cassidy regarding Jason Buck for Congress. We disagree on all three items listed in his complaint. Each item is addressed below:

- 1) At the time the report was filed there were no outstanding invoices that were not reported. The items mentioned in Mr. Casaday's complaint were all in dispute because the billed amounts were for services that were not approved and services that were promised but never actually performed. Mr. Buck and his attorney were, and currently are in the process of finalizing these invoices in question. I have enclosed letters from Mr. Buck addressing these issues along with the letters that Mr. Bucks attorney had sent to Letter 23, LLC.
- 2) Kimberly Williams, Assistant Treasurer, talked with Daniel Buckley, the Senior Campaign Finance Analyst, for the Report Analysis Division was contacted on March 1 2012 to clarify that the accepted contributions were within the limit. He said that the Report Analyst has gone over the report piece by piece and that there was no issue with any of the contributions and there were no excess contributions. The only finding that was addressed was a date issue that had to do with the contributions they received during their exploratory stage. That issue has since been amended and taken care of.
- 3) The contributions received via the "Fondly" account are the same contributions that were received within the exploratory stage that was addressed in item 2 and has since been amended on the report.


