Dear Mr. Little:

The Federal Election Commission (FEC or Commission) referred a compliance issue to the FEC's Alternative Dispute Resolution Office (ADR Office) for processing. The referral by the Office of General Counsel was based on a complaint filed by Charles Measley which alleges a violation of the Federal Election Campaign Act of 1971, as amended by Friends of Anna Little.

The FEC established the ADR Program to provide an informal means for resolving matters that come before the Commission and to facilitate negotiations directly with Friends of Anna Little and Robert Lee Little, III, Treasurer (Respondents or the Committee). The ADR Program provides Respondents with an opportunity to negotiate settlement of a matter that is mutually agreeable. The negotiations occur prior to any Commission consideration of whether there is reason to believe a violation has occurred. If negotiations are successful, the resulting settlement would conclude the matter.

The Commission, in referring the matter to the ADR Office, determined that the case is eligible for processing in the ADR program. If Respondents decide to participate in the ADR Program, you must: 1) indicate in writing a willingness to have your case submitted for ADR processing; 2) agree to participate in the bilateral interest based negotiations; and 3) waive the statute of limitations while the matter is being processed under the FEC's ADR program.

The issues referred to the ADRO, and the focus of our subsequent negotiations are summarized as follows:

Charles Measley filed a complaint dated May 29, 2012, alleging that Respondents failed to file reports for Anna Little's 2012 Congressional campaign as well as her prior Senatorial campaign for the same cycle. At the time the complaint was written, no reports were filed except a February, 2012, Statement of Organization. On June 1, 2012, Respondents filed a report disclosing \$161,152 in receipts and \$147,317 in disbursements from the period beginning January 1, 2011 and ending March 31, 2012, a total of \$308,469 in previously undisclosed financial activity.
