To Whom It May Concern:

Please accept this letter as a self-reported complaint against Edwin W. Edwards, hereinafter referred to as the "Candidate", and Friends of Edwin W. Edwards, a principal campaign committee, hereinafter referred to as the "Campaign".

On May 20, 2014, the Campaign discovered violations relating to the failure to include "paid for" disclosures on materials distributed to the public and the failure to disclosure contribution limits on fundraising materials. The Campaign hereby discloses these violations.

Facts

On Monday, May 19, 2014, supporters outside of the Campaign hosted a fundraiser at Impastato's Restaurant in Metairie, Louisiana. In the latter part of the prior week, these supporters prepared and distributed an invitation to the event (Exhibit 1). The invitation included contribution limits information as required by federal law. However, a "paid for" disclosure was omitted in error although required by 11 CFR 110.11(b)(2).

Trina Edwards, wife of the Candidate, publicized the invitation via the social media network, Facebook. The screenshot of the invitation inadvertently cropped out the contribution limits information (Exhibit 2). The screenshots appeared on several Facebook pages, including the Campaign's page.

On Tuesday, May 20, 2014, after the fundraiser, the Campaign discovered the violations when a reporter notified the Campaign that an opposing candidate's attorney filed a complaint. The Campaign has thus taken the following remedial actions and hereby self-reports the violations.

Upon discovery of the violations, the Campaign and Trina Edwards removed all Facebook posts of the invitation screenshot. A formal notice of the error has been posted on the Campaign's Facebook account as well as the Campaign's website, www.edwinedwards4congress.com.

While the Campaign did not prepare the invitation, it failed to recognize that the invitation did not include the proper "paid for" disclosure before disseminating copies of the invitation. In the future, all fundraising materials published by campaign supporters will be checked for compliance by the accounting firm, Postlethwaite & Netterville, APAC to ensure federal election rules are followed. Any such materials must be checked and approved prior to public dissemination of the materials.

Furthermore, any campaign fundraising materials published by the Campaign will follow the same formal check and approval procedure. Any materials not approved will be re-drafted until approval is granted.

After the check and approval process is completed, any and all social media posts of screenshots of fundraising materials will include the required disclosure information. The Campaign strongly asserts this was a simple mistake and any violation appertaining thereto was not intentional.

Finally, the Campaign and Candidate will fully cooperate with the Federal Election Commission's Office of General Counsel in the resolution of this matter.
