III. BACKGROUND:

**Failure to Provide Supporting Schedules (Failure to Timely File 24-Hour Reports)**

All Citizens for Mississippi ("the Committee") failed to timely file four (4) 24-Hour Reports totaling \$26,775.71 to support five (5) independent expenditures disclosed on the 2014 July Quarterly Report made after the 20<sup>th</sup> day but more than 24 hours before the 2014 Primary Runoff election in the state of Mississippi held on June 24, 2014(Attachment 3).

A Prior Notice listing the official filing dates for Quarterly filers was sent via email to the Committee on June 20, 2014. The notice included a section titled *48- and 24-Hour Reports on Independent Expenditures*, which read:

"Any PAC or Party Committee that makes independent expenditures may have to disclose this activity within 48- or 24-hours based upon the date and amount of the expenditure. See 11 CFR 104.4(b)(2) and (c). See generally, 11 CFR 104.4., the WebPage: [http://www.fec.gov/info/charts\\_ie\\_dates\\_2014.shtml](http://www.fec.gov/info/charts_ie_dates_2014.shtml), or the Campaign Guide. These reports are not required when a PAC or Party Committee makes a contribution directly to a candidate" (Attachment 2).

On July 10, 2014, Jacqueline Vann, Treasurer for the Committee, contacted the Reports Analysis Division (RAD) Analyst with questions about completing the Form 3X and reporting independent expenditures. The Analyst directed Ms. Vann to the *Campaign Guide for Nonconnected Committees*, advised her to read the portions covering independent expenditures, and to call back with any reporting questions (Attachment 4).

On July 15, 2014, the Committee filed the 2014 July Quarterly Report, covering the period from June 6, 2014 through June 30, 2014, which disclosed no independent expenditures on Schedule E (Itemized Independent Expenditures) (Image 14961619076).

On July 18, 2014, Ms. Vann, called the RAD Analyst for assistance in amending the Committee's 2014 July Quarterly Report. Ms. Vann asked if independent expenditures should be moved from Schedule B (Itemized Disbursements) to Schedule E. The Analyst stated all independent expenditures should be disclosed on Schedule E and advised Ms. Vann to file an amended report. Ms. Vann explained that the Committee did not file 48-Hour Reports for the independent expenditures because the Committee had just received the invoice. The Analyst stated that 24- and 48-Hour Reports are required based on the date of public dissemination and not on the date of payment. The Analyst advised the Committee to file the missing reports as soon as possible (Attachment 4).

On July 29, 2014, the Committee filed an Amended 2014 July Quarterly Report covering the period from May 24, 2014 through June 30, 2014, which included a Schedule E disclosing six (6) independent expenditures totaling \$27,575.71, made in support of one (1) federal candidate. The Committee failed to file four (4) 24-Hour Reports to support five (5) independent expenditures, totaling \$26,775.71, for the 2014 Primary Runoff Election in the state of Mississippi (Images 14942380953-5).

On the same day, the Committee also filed one (1) 48-Hour Report<sup>1</sup> to support five (5) independent expenditures, totaling \$26,775.71, disseminated on June 11, 2014, June 16, 2014, June 19, 2014, and June 21, 2014 (Images 14942380919-21).

On December 7, 2014, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2014 July Quarterly Report, received July 29, 2014. Among other items, the RFAI noted that the Committee may have failed to timely file one or more of the required 24-Hour Reports for the independent expenditures disclosed on the amended report. A chart was included with the RFAI identifying the five (5) independent expenditures, totaling \$26,775.71, for which 24-Hour Reports had not been timely filed (Images 14330067347-50).

On January 12, 2015, the Committee filed an Amended 2014 July Quarterly Report. The amended report included no changes to the independent expenditures disclosed on the previous amended report (Images 15950020378-80).

<sup>1</sup> The Committee filed a 48-Hour Report, however, the dissemination date provided on the 48-Hour Report occurred during the 24-Hour reporting period.

On the same day, the Committee submitted a Miscellaneous Electronic Submission ("Form 99") in response to the RFAI. The Form 99 stated in part:

"The \$20,577.81 amount was for radio ads that was disseminated on 6/21/14 and paid on 7/2/14. I didn't include it on the original report because my understanding was I needed to file the expense in the quarter it was paid. After investigating I understood that I handle that expense incorrectly and it should have been included in the July report on the Schedule D as well as submit a 24-48 report. I amended the report prior to this notice to correct the error...

My inexperience at completing and filing FEC reports was the purpose of failure to file timely 24-48 report. After researching and understanding when and how to file I amended my report to show the correct report and information. I amended and filed the proper 24-48 expenditures and have complied with these regulations. I have a better understanding of the necessary reports and the filing time frame and will have filed timely since this occurrence" (Image 15950020355).

On February 26, 2015, the RAD Analyst called Ms. Vann and informed her that the Committee may be referred for further action to the Commission for the apparent late 24-Hour Reports to support the independent expenditures disclosed on the Amended 2014 July Quarterly Report. The Analyst invited the Committee to file a Form 99 with any additional clarifying information they wished to include (Attachment 4).

To date, no further communication has been received from the Committee regarding this matter.

The principal campaign committee of any candidate participating in a 2014 state primary, nominating convention or runoff election – even if unopposed – must also file a pre-election report 12 days prior to the primary, nominating convention or runoff. The principal campaign committee of a candidate participating in the general election must file pre- and post-general election reports. Separate notices will be sent to explain these additional reporting obligations. See 11 CFR 104.5(a)(2).

**Parties and PACs**

Committees that make contributions or expenditures (including independent expenditures) in connection with an election must also file a Pre-Election Report, if the activity was not previously reported. See 11 CFR 104.5(c)(1)(ii).

Congressional Committees: the principal campaign committee of a candidate who participates in the general election must file pre-and post-general election reports. See 11 CFR 104.5(a)(2).

**3** Notice that this filing deadline falls on a weekend. Filing deadlines are not extended when they fall on nonworking days. Accordingly, reports filed by methods other than Registered, Certified or Overnight Mail, or electronically, must be received before the Commission's (or for committees supporting only Senate candidates, the Secretary of the Senate's Public Records Office) close of business on the last business day before the deadline.
