I have received your acknowledgement of our complaint regarding Sharon Sund for Congress (FEC ID# C00499137) and their inaccurate reports with regard to outstanding debts. Thank you!

This letter serves as a follow up to MUR 6890. The original complaint was based on their October quarterly report (FILING FEC-959671). Since then, the respondents have filed a pre-general report (FILING FEC-968205) with slightly different, but still inaccurate reporting, which I would like to address.

As our complaint details, the committee for Sharon Sund for Congress now owes BoulderStrategies LLC \$14,840.82. They failed to file this debt whatsoever on their 10/15 October quarterly, as required. The subsequent pre-general report now shows a debt of \$9500 to BoulderStrategies LLC. This amount of debt, however, is still inaccurate and is unfortunately not based on any actual invoice that we have provided them to-date (all invoices were included in our original complaint package).

Please be advised that as the complainant, we are not satisfied with the current debt reporting of \$9500 and still seek FEC intervention to have the respondent committee amend their reports to accurately show true debts currently outstanding (at \$14,840.82) as required by 11 CFR 104.3(d), 104.11 and 11 CFR 116.1(d).


