Dear Mr. Jordan,

I am responding to a complaint submitted to you by my former campaign consultant/manager who used the complaint to pressure me to pay him for an ill advised expenditure which he himself recommended and then insisted that I accept as a critical campaign expense. This advise was given and insisted upon at a time when the campaign was struggling to raise money. As general consultant for the campaign, he had responsibility for the day to day operation as well as oversight over the entire campaign. He hired a friend to do these research books that he insisted upon at a cost of almost twice the original projected estimate. He was later released from his contract and demanded payment. The new campaign manager disputed the payment therefore it was not submitted as a campaign debt. After careful consideration, the campaign committee agreed that we would settle with Boulderstrategies, LLC for an amount of \$9,500 this was reported to the FEC in the 3rd quarter (see the document below called Reporting of Debt to Boulderstrategies.pdf). We have since negotiated through his counsel to pay Boulderstrategies \$11,000. I hope that this response will settle the matter. Please let me know if you need any further information.
