- III. BACKGROUND:

Excessive, Prohibited and Other Impermissible Contributions or Transfers: Failure to Refund Excessive Contributions Within the Permissible Timeframe

Right to Rise PAC, Inc. ("the Committee") received excessive contributions totaling \$32,500.00 for the 2015 calendar year from seven (7) individuals. The Committee did not timely refund, reattribute, or transfer-out these excessive contributions to the Committee's non-federal account (Attachment 2).

On July 31, 2015, the Committee filed a 2015 Mid-Year Report. This report disclosed excessive contributions totaling \$32,500.00 from seven (7) individuals (Attachment 3).

Also on July 31, 2015, the Committee filed an amended 2015 Mid-Year Report which disclosed no changes from the original report with regard to the excessive contributions.

On October 7, 2015, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2015 Mid-Year Report, received July 31, 2015. The RFAI noted the Committee's receipt of excessive contributions that were refunded, and requested that the Committee provide additional clarification regarding these receipts.

On November 6, 2015, the Committee filed a Miscellaneous Electronic Submission ("FEC Form 99") in response to the RFAI, which stated, in part:

MR. DAVID KINDER - \$5,000 WAS REFUNDED ON 5/19/15
MR. JEFFREY VERSCHLEISER - \$5,000 WAS REFUNDED ON 5/19/15

THE COMMITTEE HAS REVIEWED THE CONTRIBUTIONS INDICATED IN YOUR LETTER, AND HAS PROVIDED A WRITTEN EXPLANATION OF ACTIONS TAKEN IN REGARD TO EACH CONTRIBUTOR. THE ACTIONS DESCRIBED IN THIS RESPONSE WERE DISCLOSED IN THE 2015 AMENDED MID-YEAR REPORT. THROUGH THIS RESPONSE, THE COMMITTEE CAN CONFIRM, AS YOU REQUESTED, THAT THE APPROPRIATE STEPS HAVE BEEN TAKEN FOR EACH DONATION IN QUESTION AND NO FURTHER ACTION IS REQUIRED UNDER COMMISSION REGULATIONS FOR THESE PARTICULAR CONTRIBUTIONS"(Image 201511069003292748).

On February 12, 2016, a Reports Analysis Division (RAD) Analyst notified the Committee that the excessive contributions refunded outside of the permissible timeframe on their 2015 Mid-Year Report could be referred for further action to the Commission. The RAD Analyst informed them of the option to provide additional clarification on the public record by filing an FEC Form 99, and requested that any response be submitted by February 19, 2016 (Attachment 4).

To date, no further communications have been received from the Committee regarding this matter.
