To Whom It May Concern:

I write to inform you of a series of serious federal campaign finance violations committed by Peter "Pete" DiCianni, a candidate for Congress in Illinois' Eighth Congressional District. His campaign committee is named "Pete for Congress" (FEC Identification #: C00589036). The apparent violations are outlined below:

Corporate contributions

Congressional candidates are barred from accepting contributions from corporations, as seen in 52 United States Code § 30118. The table below details corporate contributions to "Pete for Congress" that were accepted and reported in 2016Q2:

As outlined above, congressional candidate Peter DiCianni accepted \$10,324 in illegal corporate contributions in the second quarter of 2016. I respectfully request that you take steps to make Mr. DiCianni refund the improper contributions and penalize him appropriately for his failure to comply with the law.

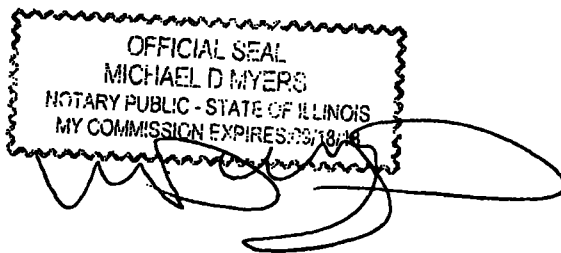

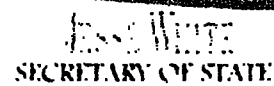
