III. BACKGROUND:

Independent Expenditure Reporting Problems

STOP HILLARY PAC ("the Committee") failed to provide the election state for three (3) independent expenditures totaling \$28,200.00 which were made on behalf of a presidential candidate for the "2016 Dem. Nat. Convention." The independent expenditures with missing information were disclosed on two (2) 48-Hour Reports of Independent Expenditures (Attachment 2). In addition, the Committee failed to provide the election state of the corresponding independent expenditures on its 2015 Year-End Report.

On October 9, 2015, the Committee filed a 48-Hour Report of Independent Expenditures disclosing five (5) independent expenditures totaling \$78,506.00. The report failed to include an

election state for one (1) independent expenditure totaling \$13,200.00 designated for the "2016 Dem. Nat. Convention"² (Image 201510099002828724).

On October 20, 2015, the Committee filed a 48-Hour Report of Independent Expenditures. The report disclosed one (1) independent expenditure totaling \$10,000.00 designated for the "2016 Dem. Nat. Convention" for which no election state was provided (Image 201510209003177352). The Committee attached a memo text which stated,

"This is the national component of a \$15,000 ad campaign including similar ad buys in several key battleground states. Expenditures for individual states have not yet reached the reporting threshold" (Image 201510209003177353).

On October 26, 2015, a Request for Additional Information (RFAI) was sent to the Committee referencing the 48-Hour Report of Independent Expenditures, received October 9, 2015. The RFAI stated that the Committee failed to provide the election state for one (1) independent expenditure and advised the Committee to amend the report to provide the missing information (Image 201510260300006321-3).

That same day, October 26, 2015, the Committee amended the 48-Hour Report originally filed on October 20, 2015. The report disclosed two (2) independent expenditures totaling \$15,000.00 designated for the "2016 Dem. Nat. Convention" for which no election state was provided (Image 201510269003240463). The Committee attached a memo text which stated,

"This is the national component of a \$20,000 ad campaign including similar ad buys in several key battleground states. Expenditures for individual states have not yet reached the reporting threshold. This amended Form 24 report includes production costs invoiced after distribution that were thought to have been part of a prior payment to the same vendor. The additional amount reported on this amendment was invoiced for on 10/23/15 and paid on 10/26/15. This amendment also corrects a data entry error in the dissemination date for transaction SE24.11700" (Image 201510269003240464).

On November 5, 2015, the Committee filed a Miscellaneous Electronic Submission ("FEC Form 99"). The Committee stated, in full:

"This Committee responds to the October 26, 2015 RFAI, with response due November 30, 2015, as follows: The expenditure at issue in the 10/9/15 Form 24 was for a nationally distributed communication that did not reference or target any specific state's primary election. Consistent with those facts and the Commission's proposed interpretive rules on reporting nationwide independent expenditures in

presidential primary elections, the Committee reported these as national expenditures for the 2016 Democratic national nominating convention. All state-specific expenditures that have aggregated to \$10,000 or more were included in the original Form 24 and were properly designated for their respective states. Other state-specific expenditures have not yet aggregated to \$10,000, and so have not yet been reported" (Image 201511059003288250).

On February 1, 2016, the Committee filed the 2015 Year-End Report covering the period from July 1, 2015 through December 31, 2015. The report disclosed three (3) independent expenditures totaling \$28,200.00 designated for the "2016 Dem. Nat. Convention" for which no election state was provided. These independent expenditures were linked to the 48 Hour-Reports received on October 9 and October 26, 2015 (Images 201602019005299790, 201602019005299793, and 201602019005299795).

On February 21, 2016, the Committee filed an Amended 2015 Year-End Report. The report disclosed no change in information provided for the three (3) independent expenditures designated for the "2016 Dem. Nat. Convention" disclosed on the original report (Images 201602219008673626, 201602219008673630, and 201602219008673631).

On April 14, 2016, an RFAI was sent to the Committee referencing the Amended 2015 Year-End Report, received February 21, 2016. Among other items, the RFAI stated that the Committee failed to provide the election state for three (3) independent expenditures and advised the Committee to amend the report to provide the missing information (Image 201604140300041630).

On May 19, 2016, the Committee filed an Amended 2015 Year-End Report. The report disclosed no change in information provided for the three (3) independent expenditures designated for the "2016 Dem. Nat. Convention" disclosed on the original report (Images 201605199015549184, 201605199015549188, and 201605199015549189).

Also on May 19, 2016, the Committee filed an FEC Form 99. The Committee stated, in part:

"2. Though reported alongside expenditures targeted at specific states, the expenditures referenced here were distributed nationally, with the goal of denying Hillary Clinton the 2016 Democratic nomination. Consistent with that goal, and with the Commission's proposed interpretive rules on reporting nationwide independent expenditures in presidential primary elections, the Committee reported these expenditures as being for the Convention, and not, as would be factually incorrect, for one or more states" (Image 201605199015549192).

On May 25, 2016, the Reports Analysis Division (RAD) Analyst called the Committee Treasurer, Dan Backer, regarding the RFAI sent on the Amended 2015 Year-End Report, received February 21, 2016. Mr. Backer asked Mr. Joseph Lilly, the Committee's counsel, to participate in the call. Among other items, the Analyst stated that the Committee's response for

the omitted election states for the three (3) independent expenditures was inadequate and the issue may be referred for further action. The Analyst stated that the Committee's use of the national convention as an election state was inadequate, in part, because the Commission had not approved the Notice of Proposed Rulemaking mentioned in the response. Mr. Backer stated that the Committee would not be amending the designation to disclose something they believed was untrue. The Analyst said that the Committee could place any additional information on the public record (Attachment 4).

On June 1, 2016, the Committee filed an FEC Form 99. The Committee stated, in part:

"With respect to the nationally distributed independent expenditures disclosed on Schedule E, the Committee will once again state that these expenditures were distributed nationally, with the goal of influencing the outcome of the 2016 Democratic National Convention, and were therefore reported as such. While the Committee appreciates that Commission policies on independent expenditures have not yet caught up with 21st century political advertising norms, the Committee's aim in reporting its activity in this way is full and accurate disclosure - clearly not something the Commission should be discouraging" (Image 201606019017457915).

Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)

STOP HILLARY PAC ("the Committee") amended its 2015 Year-End Report to disclose additional disbursements of \$163,732.16, which were not disclosed in the original report (Attachment 3).

On February 1, 2016, the Committee filed the 2015 Year-End Report covering the period from July 1, 2015 through December 31, 2015. The report disclosed \$7,931.85 in disbursements on Line 21(b) (Other Federal Operating Expenditures), \$206,006.00 on Line 24 (Independent Expenditures), \$6,000.00 on Line 26 (Loan Repayments Made), \$745.00 on Line 28(a) (Refunds of Contributions to Individuals and Persons Other than Political Committees), and \$179,003.19 on Line 29 (Other Disbursements) (Image 201602019005299730).

On February 21, 2016, the Committee filed an Amended 2015 Year-End Report. The report disclosed \$859.61 on Line 21(b), \$290,193.64 on Line 24, \$63,223.54 on Line 26, \$995.00 on Line 28(a) and \$208,146.41 on Line 29, a total increase in disbursements of \$163,732.16 from the original report (Image 201602219008673130).

On April 14, 2016, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2015 Year-End Report, received February 21, 2016. Among other items, the RFAI requested clarification regarding the substantial increase in disbursements disclosed on the Amended 2015 Year-End Report, which were not disclosed in the original filing (Image 201604140300041630).

On May 19, 2016, the Committee filed an Amended 2015 Year-End Report. The report disclosed no change in disbursements from the prior amendment (Image 201605199015548688).

Subsequently on May 19, 2016, the Committee filed a Miscellaneous Electronic Submission ("FEC Form 99"). The Committee stated, in part:

"This Committee responds to the April 14, 2016 RFAI, with response due May 19, 2016, as follows: 1. The increase in disbursements was largely the result of final invoice amounts from independent expenditure vendors finally being made available, and the Committee updating the original report with actual - instead of estimated - payment amounts. The debts disclosed on the amended report are all related to the Committee's independent expenditure activity, and, as the Committee has stated in the past, do not accurately reflect the Committee's billing arrangements with its vendors - they were only reported in this manner due to the FEC's insistence on such" (Image 201605199015549192).

On May 25, 2016, the Reports Analysis Division (RAD) Analyst called the Committee Treasurer, Dan Backer, regarding the RFAI referencing the Amended 2015 Year-End Report, received February 21, 2016. Mr. Backer asked Mr. Joseph Lilly, the Committee's counsel, to participate in the call. Among other items, the Analyst stated that the Committee's response was inadequate and the increase in disbursements may be referred for further action. The Analyst said that the Committee could place any additional information on the public record (Attachment 4).

On June 1, 2016, the Committee filed an FEC Form 99. The Committee stated, in part:

"Following a conversation with the Committee's analyst, the Committee writes to provide additional information regarding the April 14, 2016 RFAI. With respect to the increase in disbursements on the amended year-end report, the increase on line 24 was, as previously described, due to the Committee updating the original report with actual - instead of estimated - payment amounts, as final invoices were received. The increase on line 26 was the result of the FEC-mandated treatment of independent expenditures disseminated during the mid-year reporting period but not paid until the year-end reporting period. These amounts were not actually owed to the vendors as of the close of books of the mid-year report, and, since each was timely paid once invoiced for, no debt was ever incurred. Nonetheless, the FEC required the Committee to report these as debts on the mid-year report, and as payments on those debts on the year-end report. The increase on line 28(a) was the result of properly including a few individual refunds inadvertently excluded from the original report. The increase on line 29 was largely the result of recategorizing certain disbursements originally thought to be independent expenditures as Carey account operating expenditures. Due to the delay in determining final payment amounts for the independent expenditures, the initial mis-categorization was not discovered until after the original report had been filed" (Image 201606019017457915).

To date, no further communication has been received from the Committee regarding these matters.
