III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)

Al Lawson for Congress ("the Committee") amended its 2016 October Quarterly Report to disclose additional disbursements of \$58,564.69, which were not disclosed in the original report (Attachment 2).

On October 15, 2016, the Committee filed its original 2016 October Quarterly Report, covering the period from August 11, 2016 through September 30, 2016. The report disclosed \$83,612.15 in disbursements on Line 17 (Operating Expenditures) of the Detailed Summary Page (Image 201610159032874036).

On February 1, 2017, the Committee filed two Amended 2016 October Quarterly Reports. The reports disclosed \$130,387.69 in disbursements on Line 17 of the Detailed Summary Page, an increase of \$46,775.54 from the original report (Images 201702019042400373 and 201702019042400472).

On March 15, 2017, a Request for Additional Information (RAFI) was sent to the Committee referencing the Amended 2016 October Quarterly Report, received February

1, 2017. The RFAI requested clarification regarding the increase in disbursements not disclosed on the original report (Image 201703160300082781).

On May 24, 2017, the Committee filed an Amended 2016 October Quarterly Report disclosing disbursements totaling \$142,176.84 on Line 17 of the Detailed Summary Page, an increase of \$58,564.69 from the original report (Image 201705249055150187, Attachment 2).

On August 3, 2017, an RFAI was sent to the Committee, referencing the Amended 2016 October Quarterly Report, received on May 24, 2017. The RFAI requested clarification regarding the increase in disbursements not disclosed on the original report (Image 201708030300088986).

On October 5, 2017, the Reports Analysis Division (RAD) Analyst called Johnny Session, the Committee's Treasurer, regarding an RFAI sent to the Committee referencing the Amended October Quarterly Reports, received February 1 and May 24, 2017. Mr. Session explained the circumstances resulting in the increase in disbursements on the amended reports. The Analyst informed him that the issues would be referred to another Commission office for further action (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
