Dear Mr. Jordan:

In response to your letter re RR 1 7L-30, I submit that no action should be taken against AM Racing LLC nor myself in Official Capacity as General Manager. Whereas:

1. Neither AM Racing LLC Nor myself knowingly or willfully violated the Federal Election Campaign Act of 1971.
2. On behalf of AM Racing, I submitted what I believed was a completed FEC Form 5 to the Commission via fax and email per the Form 5 instructions within 24 hours of the time the expenditure was publicly distributed. I received a fax receipt at the time of the transmission (attachment 1). This fact is not in dispute as attested to by Jaime Amrhein of the Reports Analysis Division.
3. This contribution and associated submittals represent the first time AM Racing LLC and I have made and reported such. Accordingly, I interpreted the definition of "electronic format" as provided for by 'INSTRUCTIONS FOR PREPARING FEC FORM 5' to be a submittal in any manner of digital format. I consider PDF to be a digital format.

Thank you for affording me the opportunity to demonstrate that no action should be taken against AM Racing LLC and myself, in my official capacity with respect to the subject matter.


