III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Disclose All Financial Activity)

Conservatives United ("the Committee") amended its 2016 October Quarterly Report to disclose additional disbursements totaling \$73,238.64, which were not disclosed on the original report (Attachment 2).

On August 16, 2016, the Committee filed the original 2016 October Quarterly Report covering the period from August 11, 2016 through September 30, 2016. The report disclosed \$0.00 in disbursements on Line 21(b) (Other Federal Operating Expenditures) and \$25,000.00 in disbursements on Line 24 (Independent Expenditures) of the Detailed Summary Page (Image 201608169022460725).

On June 15, 2017, the Committee filed an Amended 2016 October Quarterly Report. The report disclosed \$11,789.64 in disbursements on Line 21(b) and \$86,449.00 in disbursements on Line 24 of the Detailed Summary Page, a total increase of \$73,238.64 from the original report (Image 201706159056532421).

On November 15, 2017, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2016 October Quarterly, received June 15, 2017. The RFAI requested clarification regarding the substantial increase in disbursements disclosed on the Amended 2016 October Quarterly Report that were not disclosed in the original filing (Image 201711150300095067).

On January 17, 2018, the Reports Analysis Division (RAD) Analyst called Eric Robinson, the Committee's Treasurer. The RAD Analyst explained that based on the substantial increase in financial activity disclosed on the Amended 2016 October Quarterly Report, received June 15, 2017, the Committee may be referred for potential further action to another office within the Commission. The RAD Analyst invited the Committee to file additional information regarding the issue. Mr. Robinson stated they had already disclosed all of the missing information by submitting the Amended 2016 October Quarterly Report, and no further clarification would be necessary (Attachment 3).

To date, no further communication has been received from the Committee regarding this matter.
