VII. PROBLEMS FOR WHICH AUDIT POINTS WERE ASSESSED:

A. Standard 5 – Excessive, Prohibited and Other Impermissible Contributions and Transfers:

Report Type	Violation (Description)
2013 M4	Schedule A supporting Line 11(a)(i) disclosed the receipt of an excessive contribution totaling \$2,647.40, or 5.4% of the Committee's total contributions from individuals. This contribution was received from one (1) individual.
2013 MS	Schedule A supporting Line 11(a)(i) disclosed the receipt of a prohibited contribution totaling \$5,000.00, or 4.4% of the total contributions from individuals. This contribution was received from one (1) corporation.

B. Standard 6 - Mathematical Discrepancies:

Report Type	Violation (Description)
2014 YE	<p>The Committee's report contained mathematical discrepancies totaling \$164,450.54, as detailed below:</p> <p>The beginning cash balance, \$32,807.00, was greater than the ending cash balance on the previous report, \$32,651.42, a discrepancy of \$155.58.</p> <p>The report contained mathematical discrepancies on several lines in Column B totaling \$164,294.96.</p>

C. Standard 7 - Failure to Provide Supporting Schedules:

Report Type	Violation (Description)
2013 M2	Schedule A supporting Line 15 disclosed offsets to operating expenditures totaling \$3,750.00. However, the Committee failed to disclose any payments to these vendors.
2013 M4	Schedule A supporting Line 15 disclosed offsets to operating expenditures totaling \$23,050.66. However, the Committee failed to disclose any payments to these vendors.

2014	M7	Schedule A supporting Line 15 disclosed offsets to operating expenditures totaling \$36,014.35. However, the Committee failed to disclose any payments to these vendors.
2014	M8	Schedule A supporting Line 15 disclosed offsets to operating expenditures totaling \$20,611.10. However, the Committee failed to disclose any payments to these vendors.
2014	M9	Schedule A supporting Line 15 disclosed offsets to operating expenditures totaling \$36,095.13. However, the Committee failed to disclose any payments to these vendors.

D. Standard 8 - Failure to Properly Itemize Contributions from Individuals:

Report Type	Violation (Description)
2013 M4	Schedule A supporting Line 11(a)(i) failed to disclose adequate identification for 37 of 54, or 68.5%, of the contributions from individuals that require itemization.

E. Standard 10 - Failure to Properly Itemize Contributions and Transfers to Political Committees:

Report Type	Violation (Description)
2014 30G	Schedule B supporting Line 22 failed to disclose the address for a transfer to one (1) political committee totaling \$30,000.00.

F. Standard 11 – Failure to Properly Itemize Disbursements:

Report Type	Violation (Description)
2013 M5	Schedule B supporting Line 30(b) disclosed \$110,270.54 in disbursements for "Volunteer Exempt Mail" and "Volunteer Exempt Mailing", which were paid to an apparent direct mail firm. However, the Committee failed to clarify whether the activities met the conditions of exempt party activity.

2013 M6 Schedule A supporting Line 12 disclosed a transfer-in from a national party committee; however, Schedule B supporting Line 30(b) disclosed payments for exempt party activities totaling \$98,684.38. The transferred funds may have specifically funded the exempt activities.

G. Standard 12 – Federal Election Activity/Levin Funds:

Report Type	Violation (Description)
2013 M5	Schedule B supporting Lines 21(b) and 30(b) failed to disclose the address for twenty (20) disbursements totaling \$126,825.57.
2013 M6	Schedule B supporting Lines 21(b) and 30(b) failed to disclose the address for thirty-nine (39) disbursements totaling \$118,857.45.

H. Standard 13 - Allocated Federal and Non-Federal Activity:

Report Type	Violation (Description)
2013 M4	Schedules H4 and B supporting Lines 21(a) and 21(b) failed to disclose the mailing address for \$10,339.48 in disbursements.
2013 M7	Schedules H4 and B supporting Lines 21(a) and 21(b) failed to disclose the mailing address for \$8,542.82 in disbursements.
2013 M10	Line 18(a) of the Detailed Summary Page disclosed \$134,902.82 in transfers from the non-federal account for allocable administrative activity for a 3-month period. However, Line 21(a)(ii) disclosed \$120,178.80 in the non-federal share of allocable administrative disbursements, resulting in an apparent excessive transfer of approximately \$14,724.02 from the non-federal account.
2014 M8	Schedule A supporting Line 12 disclosed a transfer-in from a national party committee; however, Schedule H4 disclosed payments for exempt party activities, totaling \$23,000.00. The transferred funds may have specifically funded the exempt activities.
	Schedule H4 supporting Line 21(a) failed to disclose the mailing address for \$55.78 in disbursements.
2014 30G	Schedule H4 disclosed disbursements for salary, wages and/or fringe benefits, resulting

in an apparent impermissible transfer-in from the non-federal account of \$38,842.00.

2014 YE Line 18(a) of the Detailed Summary Page disclosed \$301,665.83 in transfers from the non-federal account for allocable administrative activity for a 3-month period. However, Line 21(a)(ii) disclosed \$132,058.34 in the non-federal share of allocable administrative disbursements, resulting in an apparent excessive transfer of approximately \$169,607.49 from the non-federal account.

Schedule H4 disclosed an event year-to-date total for administrative expenses of \$1,118,619.81; however, FEC calculations disclose this total to be \$1,037,567.92, resulting in a discrepancy of \$81,051.89.

Schedule H4 failed to disclose the mailing address for \$588.05 in disbursements.

Schedule H4 disclosed voided or returned checks totaling \$5,675.44. However, the Committee failed to clarify if the check had been reissued or what steps were taken to avoid the acceptance of a prohibited in-kind contribution.

I. Standard 15 - Coordinated Expenditure Reporting Problems:

Report Type	Violation (Description)
2013 M6	Schedule F failed to clarify two (2) coordinated expenditures totaling \$19,217.80, which were made after the date of the election.
