COMPLAINT

This Complaint is filed pursuant to 52 U.S.C. § 30109(a)(1) against Kaisar Ahmed, Kaisar Ahmed for US Congress 2016, and Kaisar Ahmed for US Congress ("Respondents") for multiple and repeated violations of the Federal Election Campaign Act of 1971, as amended (the "Act") and FEC rules. Respondents have repeatedly failed to file timely Statements of Candidacy and disclosure reports with the Commission. As a result, the public has been deprived of important information about Respondents' campaign for Congress. I respectfully request that the Commission investigate these violations, as detailed herein.

I. FACTUAL BACKGROUND

In 2016, Kaisar Ahmed was a candidate for United States Congress in California's Thirty First Congressional District. According to reports filed with the San Bernardino County Registrar of Voters ("Registrar"), on November 6, 2015, Ahmed registered a committee called Kaisar Ahmed for US Congress 2016 on FPPC Form 410, the form used to register state and local committees in California.¹ He subsequently filed a disclosure report with the Registrar on FPPC

Form 460, the form used by state and local committees in California to file campaign disclosure reports.² According to that report, beginning on January 1, 2016, Ahmed loaned his campaign \$18,440.52, and made disbursements in connection with his election. Among other things, on March 9, he spent \$11,089.54 for filing fees and a candidate statement in the county Voter Information Guide. Though he exceeded the \$5,000 registration threshold in March, he did not file a Statement of Candidacy with the Commission; he did not file a Statement of Organization with the Commission until May 13, 2016; and he did not file a Form 3 with the Commission until March 2018, nearly two full years after the report was due. When he did finally file Form 3, he filed a single report for the period of April 1 through June 30 and failed to properly itemize the payee for disbursements aggregating over \$200, instead disclosing lump-sum disbursements to himself. He has not filed any other reports with the Commission.

After a brief stint running for Redlands City Council in 2016, Mr. Ahmed began running for election to Congress again in the summer of 2017. In August 2017, he announced his candidacy on his Facebook page, and he has since solicited contributions through the website ActBlue.com.³ On January 25, 2018, he filed a Statement of Candidacy with the Commission for his 2018 election, identifying his principal campaign committee as "Kaisar Ahmed for US Congress."⁴

On March 5, 2018, Mr. Ahmed filed candidacy papers with the San Bernardino County Registrar and requested that the Registrar include a statement from Mr. Ahmed in the county's Voter Information

Guide.⁵ According to the Registrar's Candidate Filing Guide, the approximate cost for a candidate statement in the Thirty First Congressional District in the June 2018 election was \$11,376.⁶ Mr. Ahmed has also built and distributed a website supporting his candidacy, www.kaisarahmed.com. Thus, Mr. Ahmed has spent more than \$5,000 in connection with his 2018 election. Despite that fact, Kaiser Ahmed for US Congress has not filed a Statement of Organization or any disclosure reports with the Commission.

In line with his pattern of deceiving the public about his sources of financial support, Ahmed has failed to disclose the sponsorship of his campaign literature. For example, Complainant has received multiple flyers that appear to be from Mr. Ahmed, but that do not disclose the entity that paid for them.⁷

II. LEGAL ANALYSIS

Under the Act, once a person has become a federal candidate by raising or spending more than \$5,000 in connection with his or her election to federal office, the candidate must file a Statement of Candidacy with the Commission within 15 days. 52 U.S.C. §§ 30101(2), 30102(e)(1); 11 C.F.R. § 101.1(a). The Statement of Candidacy must designate a principal campaign committee. The principal campaign committee must then file a Statement of Organization with the Commission within 10 days. 52 U.S.C. § 30103(a); 11 C.F.R. § 102.1(a). Once registered, the committee must file complete and accurate reports with the Commission detailing its financial activity. See 52 U.S.C. § 30104. Moreover, public communications paid sponsored

by political committees and public communications that contain express advocacy are required to identify the entity that paid for the communication and, in the case of a communication that is paid for by someone other than a candidate, identify whether the communication was authorized by a candidate. 52 U.S.C. § 30120(a); 11 C.F.R. § 110.11.

Respondents have repeatedly failed to comply with these requirements. In 2016, according to his own filings with the Registrar, Ahmed exceeded the \$5,000 spending threshold by March 9, 2016. Despite this fact, he never filed a Statement of Candidacy with the Commission. Kaiser Ahmed for US Congress 2016 did not file a Statement of Organization until more than two months later. And the committee did not file a disclosure report with the Commission until March 2018, almost two years late. This disclosure report covered only a portion of Ahmed's time as a candidate and did not even disclose the entities to which the committee made disbursements, in clear violation of the law.

Mr. Ahmed made the same errors again in 2018. Though he began running in August of 2017, he did not file a Statement of Candidacy with the Commission until January 2018; he still has not registered a principal campaign committee for the 2018 election; and he has not disclosed a single cent of his campaign receipts or disbursements.

Lastly, Ahmed may have distributed, or permitted others to distribute, campaign advertisements that violate the Act's disclaimer provisions. Complainant has received campaign literature that purports to be from Mr. Ahmed's campaign, but that does not disclose the entity that paid for it, in violation of the Act's disclaimer requirements.


Though these errors might be understandable if made by a first time candidate, that is not the case with Mr. Ahmed. According to the Registrar, he ran for school board in 2013 and again in 2015; he ran for Congress in 2016; he ran for Redlands City Council in 2016 after losing his congressional primary election; and now he is running

for Congress yet again in 2018. As a five-time candidate, Mr. Ahmed should be well aware of campaign finance disclosure requirements. His repeated failure to comply with them suggests that he is intentionally trying to hide his finances from the public, making his violation of the Act knowing and willful.

III. CONCLUSION

Respondents have repeatedly and flagrantly violated the Act's registration and reporting requirements, depriving the public of important information about his sources of financial support and his campaign expenditures. I respectfully request that the Commission find reason to believe that Respondents have violated the Act; impose the maximum civil penalty permitted by law; enjoin Respondents from any and all future violations; and impose such additional remedies as it finds necessary and appropriate.

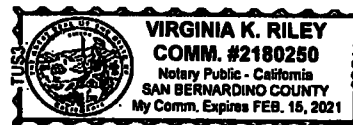

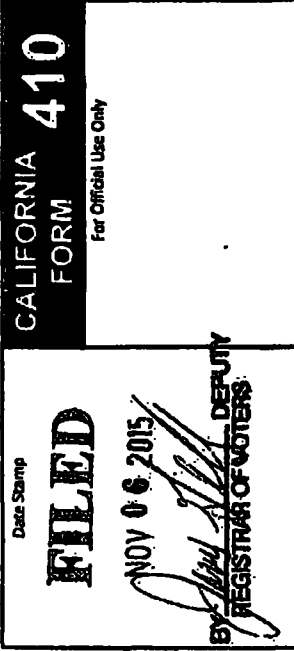



CANDIDATE STATEMENT REQUIREMENTS & OPTIONS

California Elections Code:

- Cal. Elec. Code §13307 dictates that statements shall be a brief description that expresses the candidate's education and qualifications, and shall not include party affiliation of the candidate, nor membership or activity in partisan political organizations.
- Cal. Elec. Code §13308 requires that statements shall be limited to a recitation of the candidate's own personal background and qualifications.
- Cal. Elec. Code §13313 allows for a ten day public examination period of all statements immediately following the candidate filing deadline. During this period, the Elections Official, or any voter of the jurisdiction, may seek a writ of mandate or an injunction requiring any or all of the material in the candidate statements to be amended or deleted.

Elections Office Policy:

- A candidate's background may include details regarding the candidate's platform, which describes what they stand for and what they intend to do if they are elected.
- If a statement is determined to not be in compliance with the California Elections Code, the Elections Office may strike any language not in compliance, may not print or circulate the statement, or may seek a writ of mandate or an injunction requiring that the candidate statement be amended or deleted.
- Candidates shall be fully responsible for ensuring that all spelling, punctuation, and grammar is correct. The Elections Office is not responsible for correcting spelling, punctuation, and grammatical errors.
- Any named individual or specific organization listed as an endorsement in a statement must be verified as endorsing the candidate before printing in the *Voter Information Guide*.

Candidates Statement Size & Format:

- Candidates for Local Offices are limited to 200 words.
- Candidates for U.S. Representative in Congress, State Senator and Member of the State Assembly are limited to 250 words.
- Regardless of the word count limitation, statements must fit inside a half page square in the *Voter Information Guide* measuring 4.75" wide by 3.25" tall. The template below is the actual size allowed for each statement.



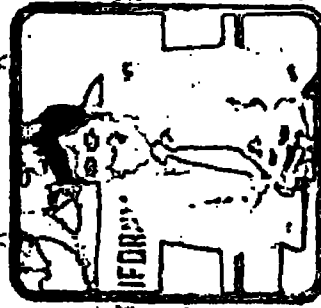
