To the Office of the General Counsel – Federal Elections Commission,

I am writing to bring to this office's attention a clear violation of Federal Election Commission rules. U.S. election code clearly states that "all public communications... made by a political committee" are required to include a disclaimer that "must clearly state that the communication has been paid for by the authorized political committee."¹

J.D. Scholten, candidate for Congress in Iowa's 4th Congressional district, and his campaign committee Scholten4Iowa Campaign Committee have clearly violated this requirement by sending out a mass mailing that does not include the required disclaimer and gives the recipient no information regarding what entity disseminated the piece. A copy of this mass mailing is attached to this complaint as Exhibit A.

This requirement is a core tenet of campaign finance regulations that inform voters receiving political communications who is sending them that information so they can make an informed decision as to the veracity of what they read or hear. By breaking this requirement, Mr. Scholten's campaign is hiding from 4th district voters information that they are required to receive by law.

I hope the Office of the General Counsel will look into this violation and take appropriate action to ensure 4th district voters are able to make an electoral decision with all the facts to which they are entitled.




