III. BACKGROUND:

**Excessive, Prohibited and Other Impermissible Contributions (Failure to Refund, Redesignate, or Reattribute Excessive and Prohibited Contributions within the Permissible Timeframe)**

Scalise for Congress (“The Committee”) received excessive and prohibited contributions totaling \$30,740.00 for the 2018 General Election from seventeen (17) individuals, two (2) limited liability companies (LLC), one (1) multicandidate political committee, and one (1) non-multicandidate political committee. The Committee refunded all of these contributions outside of the permissible timeframe (Attachment 2).

During the 2018 October Quarterly reporting period, July 1, 2018 through September 30, 2018, the Committee received excessive and prohibited contributions totaling \$22,740.00 from twelve (12) individuals, one (1) limited liability company (LLC), one (1) multicandidate political committee, and one (1) non-multicandidate political committee that were not refunded, reattributed, or redesignated within the permissible timeframe (Attachment 2).

On December 23, 2018, a Request for Additional Information (“RFAI”) referencing the Amended 2018 October Quarterly Report, received November 15, 2018, was sent to the Committee. The RFAI noted the Committee’s receipt of excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 201812230300029562).

#### 2018 12 Day Pre-General Report

During the 2018 12 Day Pre-General reporting period, October 1, 2018 through October 17, 2018, the Committee received excessive contributions totaling \$1,250.00 from two (2) individuals that were not refunded, reattributed, or redesignated within the permissible timeframe (Attachment 2).

On December 23, 2018, an RFAI referencing the 2018 12 Day Pre-General Report was sent to the Committee. The RFAI noted the Committee’s receipt of excessive contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 201812230300029579).

#### 2018 30 Day Post-General Report

During the 2018 30 Day Post-General reporting period, October 18, 2018 through November 26, 2018, the Committee received excessive and prohibited contributions totaling \$6,750.00 from five (5) individuals and one (1) limited liability company (LLC) that were not refunded, reattributed, or redesignated within the permissible timeframe (Attachment 2).

On December 23, 2018, an RFAI referencing the 2018 30 Day Post-General Report was sent to the Committee. The RFAI noted the Committee’s receipt of excessive and prohibited contributions and requested that the Committee refund, reattribute, or redesignate these contributions (Image 201812230300029588).

On January 27, 2019, the Committee filed three (3) FEC Form 99s (Miscellaneous Electronic Submission) in response to the RFAIs referencing the Amended 2018 October Quarterly Report, 2018 12 Day Pre-General Report, and 2018 30 Day Post-General Report. The Committee listed the corrective action taken for each of the excessive and prohibited contributions noted in the three RFAIs (Images 201901279144006681-82; 201901279144006683-84; 201901279144006690-93).

On April 29, 2019, the Reports Analysis Division (RAD) Analyst called Michelle Reisner, a representative of the Committee, to inform her the Committee could be referred

to another Commission office for potential further action due to excessive and prohibited contributions not refunded within the permissible timeframe. The Analyst and Ms. Reisner discussed in detail which contributions appeared to be refunded outside the permissible timeframe and could be included in a referral. Ms. Reisner stated she would research each contribution further to confirm they were correctly disclosed. She advised she would file amended reports or a FEC Form 99 if they have any additional clarification to provide (Attachment 3).

On May 2, 2019, Ms. Reisner called the Analyst to provide updates on the Committee's further research on each excessive or prohibited contribution that appeared to be untimely refunded. She stated the Committee plans to file an additional response to the RFAIs (Attachment 3).

On May 3, 2019, the Committee filed a FEC Form 99 which stated:

"This response pertains to the Reports Analysis Division's ("RAD") Requests for Additional Information ("RFAI") dated December 23, 2018. The Committee would like to provide additional context with regard to the over limit donors addressed in these RFAI's.

In the 2017-2018 cycle, the Committee raised over \$13.5 million dollars due to the overwhelming response to the leadership of Whip Scalise. Proportional to the large number of contributions received, the committee issued 1,651 refunds to donors totaling \$382,083.

The refunds addressed in the three RFAI's listed above were related to 42 transactions and 21 individual donors totaling \$40,390. Twenty five of these transactions totaling \$24,915 were refunded on 12/03/2018 - 12/06/2018. While not publicly reported until the Year-End report, the Committee was further reviewing and refunding excess contributions prior to the RFAI received addressing them on 12/23/2018.

The Committee takes its responsibility to refund donors in a timely fashion seriously, and has implemented additional internal processes to address the increased volume to ensure compliance moving forward" (Image 201905039149630679).

On May 8, 2019, Benjamin Ottenhoff, the Committee's Treasurer, and Charlie Spies, the Committee's legal counsel, called the RAD Analyst to ask why the Committee would be referred for potential further action. The Analyst explained the Committee's additional responses have been taken into consideration, and this issue is referable to another Commission office in accordance with the *RAD Review and Referral Procedures*. Mr. Spies asked to speak to RAD Management about this referral and the Analyst advised they would arrange a phone call (Attachment 3).

On June 5, 2019, RAD Management spoke to Mr. Spies and his associate Derrick Ross. They inquired why the Committee will be referred since the excessive and prohibited

contributions accounted for a small percentage of their total contributions and they had taken corrective action for all of them. RAD Management explained RAD's process for reviewing and referring committees to another Commission office for further review. Mr. Spies stated they would then wait to hear from the office that receives RAD's referral (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
