III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to File 24-Hour Report)

Conservative Triumph Fund (“the Committee”) failed to file one (1) 24-Hour Report totaling \$28,495.41 to support five (5) independent expenditures disclosed on the Amended 2018 30-Day Post-General Report, received March 23, 2019, made after the 20th day but more than 24 hours before the 2018 General Election (Attachment 2).

On December 13, 2018, the Committee filed the 2018 30-Day Post-General Report, covering the period from October 18, 2018 through November 26, 2018, which did not include a Schedule E (Itemized Independent Expenditures)¹ (Image 201812139143519640).

On March 23, 2019, the Committee filed an Amended 2018 30-Day Post-General Report. The Report included a Schedule E disclosing five (5) independent expenditures totaling \$28,495.41 made in support of five (5) federal candidates. The Committee failed

to file (1) 24-Hour Report to support the five (5) independent expenditures totaling \$28,495.41 for the 2018 General Election (Images 201903239145921235-37).

On May 6, 2019, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2018 30-Day Post-General Report, received March 23, 2019. The RFAI noted that the Committee may have failed to file one or more of the required 24-Hour Reports regarding independent expenditures. A chart was included with the RFAI identifying five (5) independent expenditures totaling \$28,495.41, for which a 24-Hour Report had not been filed (Images 201905060300039520-22).

On June 3, 2019, Ronald Ramirez, the Committee's Treasurer, contacted the Reports Analysis Division (RAD) Analyst through FEC Service Now asking how to respond to an RFAI. The RAD Analyst responded by explaining how a Committee can amend a report or file an FEC Form 99 (Miscellaneous Electronic Submission) in order to respond to an RFAI (Attachment 3).

On June 5, 2019, Mr. Ramirez called asking if a response to an RFAI could be emailed. The RAD Analyst responded by saying it could not and explained how a Committee could use their software to file an FEC Form 99 to respond to an RFAI (Attachment 3).

On June 7, 2019, the Committee submitted an FEC Form 99 which provided additional information in response to the RFAI referencing the Amended 2018 30-Day Post-General Report, received March 23, 2019. The FEC Form 99 stated, in full:

"The lack of a 24 hour notice for the 2018 election was due to a clerical error on our part of entering independent contributions as independent expenditures.

This has now been corrected. This same issue was the root cause behind our late filing on the Post-General Election, for which we have already received and paid a fine to the FEC.

The source of this clerical issue has now been corrected and we do not anticipate further issues going forward" (Image 201906079149967355).

On June 18, 2019, the RAD Analyst called Mr. Ramirez and received his voice mailbox. The Analyst explained that he was calling in reference to the issue on the RFAI regarding the Amended 2018 30-Day Post-General Report, received March 23, 2019, and explained it may be referred to another office within the Commission. The Analyst stated that the Committee had the option to provide additional clarifying information on the public record if it wished to do so (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
