**SUBJECT:** REFERRAL OF OKLAHOMA DEMOCRATIC PARTY FOR  
THE 2017-2018 ELECTION CYCLE

The Reports Analysis Division (RAD) is referring the Oklahoma Democratic Party ("the Committee") to the Alternative Dispute Resolution Office (ADRO). In accordance with the *2017-2018 RAD Review and Referral Procedures for Unauthorized Committees*, a review by your office is warranted.

The Committee accumulated a total of \_\_\_\_\_ in the 2017-2018 election cycle and \_\_\_\_\_ thus far in the 2019-2020 election cycle. However, since the Committee was referred for an audit of the 2015-2016 election cycle (Audit #2-762), a referral for an audit of the 2017-2018 election cycle was not pursued. A description of the reporting issues and responses to the RFAs is included in this referral for review by your office. The Committee can be referred to ADRO for failure to clarify whether the correct allocation ratio was used for apparent allocated fundraising disbursements for the 2017-2018 election cycle.

Please note, the Committee was referred to the Administrative Fines Program for failing to timely file the 2018 12-Day Pre-General Report. RAD processed the Reason to Believe Recommendation on December 12, 2018 (AF 3557) with a fine of \$7,088. RAD intends to make a Final Determination assessment regarding AF 3557 in November 2019.
