III. BACKGROUND:

**Failure to Provide Supporting Schedules (Failure to Timely File 24- and 48-Hour Reports)**

Fight for Tomorrow (“the Committee”) failed to timely file one (1) 48-Hour Report totaling \$34,345.60 supporting five (5) independent expenditures and failed to timely file two (2) 24-Hour Reports totaling \$7,070.80 supporting nine (9) independent expenditures disclosed on the 2018 April Quarterly Report, made after the 20<sup>th</sup> day but more than 24 hours before the 2018 Primary Election in the state of Texas, held on March 6, 2018 (Attachment 2).

On March 15, 2018, the Committee filed one (1) 48-Hour Report to support five (5) independent expenditures totaling \$34,345.60 disseminated on February 14, 2018 (Images 201803159096558838-40).

Also on March 15, 2018, the Committee filed one (1) 24-Hour Report to support ten (10) independent expenditures totaling \$7,902.80 disseminated on February 23, 2018 and February 28, 2018 (Images 201803159096559056-60).

On April 10, 2018, the Committee filed its 2018 April Quarterly Report, covering the period from January 1, 2018 through March 31, 2018. The report included a Schedule E (Itemized Independent Expenditures) disclosing sixteen (16) independent expenditures totaling \$41,671.40 made in support of one (1) federal candidate. The Committee failed to timely file one (1) 48-Hour Report to disclose five (5) independent expenditures totaling \$34,345.60, and two (2) 24-Hour Reports to disclose nine (9) independent expenditures totaling \$7,070.80<sup>1</sup> for the 2018 Primary Election held in the state of Texas (Images 201804109105540031-38).

On May 16, 2019, a Request for Additional Information (RFAI) was sent to the Committee referencing the original 2018 April Quarterly Report, received April 10, 2018. Among other items, the RFAI noted that the Committee may have failed to timely file one or more of the required 24- and 48-Hour Reports regarding independent expenditures. Two charts were included with the RFAI identifying five (5) independent expenditures totaling \$34,345.60 for which 48-Hour reports had not been timely filed, and nine (9) independent expenditures totaling \$7,070.80 for which 24-Hour Reports had not been timely filed (Images 201905160300040278-82).

On June 17, 2019, Logan Cheney, the Committee's consultant, called for guidance on how to respond to the RFAI referencing the Committee's 2018 April Quarterly Report. The Reports Analysis Division (RAD) Analyst advised that the Committee file an FEC Form 99 (Miscellaneous Electronic Submission) to explain why the referenced 24- and 48-Hour Reports were filed late (Attachment 3).

On June 18, 2019, the Committee filed an Amended 2018 April Quarterly Report. The report disclosed no change in independent expenditures on Schedule E (Images 201906189150088276-83).

On July 12, 2019, the Analyst left a voicemail for Mr. Cheney to inform him that the Committee had failed to respond to the issue of late filed 24- and 48-Hour Reports on the 2018 April Quarterly Report, and that the matter may be referred to another office within the Commission for potential further action (Attachment 3).

That same day, Mr. Cheney returned the Analyst's call and the Analyst reiterated the late 24- and 48-Hour Reports could be referred to another office within the Commission for further action (Attachment 3).

On July 31, 2019, Mr. Cheney called the RAD Analyst. The Analyst assisted with an unrelated filing question and took the opportunity to talk about the pending referable issues on the 2018 April Quarterly Report. In addition to other items, the Analyst

recommended that the Committee file an FEC Form 99 to address the late 24- and 48-Hour Reports (Attachment 3).

On August 1, 2019, the Committee filed an Amended 2018 April Quarterly Report. The report disclosed updated disbursement dates for independent expenditures on Schedule E (Images 201908019161349197-204).

Also on August 1, 2019, the Analyst called Mr. Cheney regarding the Committee's Amended 2018 April Quarterly Report, received August 1, 2019. In addition to other items, Mr. Cheney confirmed that he would submit an FEC Form 99 to give context for the late 24- and 48-Hour Reports (Attachment 3).

Later that same day, the Committee filed an FEC Form 99 in response to the RFAI referencing the 2018 April Quarterly Report. The Committee stated:

“The amendment to the April 15 2018 Quarterly Report fixed disbursement date inconsistencies with the 24 and 48 hour reports. These reports were filed by someone new who had never worked FEC file before, therefore reports were inconsistent and late (after the election). That person is no longer with us, and I have taken over FEC reporting for Fight for Tomorrow, and am working to fix any and all previous issues. My email and phone number are now listed under the Committee profile, feel free to contact me anytime” (Image 201908019161349267).

On August 2, 2019, the Committee filed an Amended 2018 April Quarterly Report. The report disclosed updated dissemination dates for independent expenditures on Schedule E (Images 201908029161354428-35).

To date, no further communication has been received from the Committee regarding these matters.
