A. Standard 5 – Excessive, Prohibited and Other Impermissible Contributions/Transfers:

2018 Amended M7, received 8/24/18	Schedule A supporting Line 11(c) disclosed a contribution totaling \$1,200 from a political action committee which was not disclosed on the contributor's disbursement schedule, resulting in an apparent prohibited receipt of \$1,200. Furthermore, Schedule B supporting Line 23 disclosed a contribution designated for the primary election of a federal candidate totaling \$3,000. This contribution was dated after the respective election. The prohibited contribution received and impermissible contribution made total \$4,200 or _____ of the total contributions received from other political committees and contributions made to federal candidates and committees.	
2018 Amended 30G, received 1/31/19	Schedule A supporting Line 11(a)(i) disclosed the receipt of prohibited contributions totaling \$6,357.30, or _____ of the total contributions from individuals. These contributions were received from an apparent corporation.

	Schedule B supporting Line 30(b) disclosed \$8,100.00 in disbursements for “Consulting - Direct Mail”, which were paid to an apparent direct mail firm. However, the Committee failed to clarify whether the activities met the conditions of exempt party activity.	
2018 12G	Schedule A supporting Line 11(b) disclosed transfers-in from national party committees; however, Schedule B supporting Line 30(b) disclosed payments for exempt activities totaling \$204,188.37. The transferred funds may have specifically funded the exempt activities.

E. Standard 12 – Federal Election Activity/Levin Funds:

Report Type	Violation (Description)	Points
2018 M10	Schedule B supporting Line 30(b) disclosed \$34,665.00 in disbursements for “Communications Consulting fee” but failed to clarify whether these disbursements were FEA public communications that promoted,	

supported, attacked or opposed federal candidates or if they expressly advocated the election or defeat of clearly identified federal candidates, which would require additional disclosure.

2018 12G Schedule B supporting Line 30(b) disclosed \$12,803.07 in disbursements for “Bulk Mailing” but failed to clarify whether these disbursements were FEA public communications that promoted, supported, attacked or opposed federal candidates or if they expressly advocated the election or defeat of clearly identified federal candidates, which would require additional disclosure.

Schedule B supporting Line 30(b) failed to disclose the address for three (3) disbursements totaling \$961.53.

The Committee failed to address an apparent impermissible transfer of \$912.45 from the non-federal account that occurred as a result of allocating payments between the federal and non-federal accounts on Schedule H4 for apparent Federal Election Activity (FEA). The apparent FEA Voter Identification activity was conducted in connection with an election in which one or more candidates for federal office appear on the ballot.

(AF # 3408) The Committee was assessed a civil money penalty of \$4,685.00 for failing to timely file the 2018 May Monthly Report. The Committee paid the fine on July 2, 2019 and the matter is now closed.

(MUR # 7600): The Committee was eligible for an audit for cumulative errors during the 2015-2016 election cycle, but was instead referred to OGC upon Commission approval. This matter is still active.

The Committee was a respondent in MUR 7304, which was closed April, 25, 2019.
