III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to File 24-Hour Reports)

Human Rights Campaign Equality Votes (“the Committee”) failed to timely file two (2) 24-Hour Reports totaling \$31,350.00 to support six (6) independent expenditures made after the 20th day but more than 24 hours before the 2018 General Election, disclosed on the Amended 2018 30 Day Post-General Report received January 16, 2019 (Attachment 2).

On October 26, 2018, the Committee filed one (1) 24-Hour Report to support two (2) independent expenditures totaling \$6,811.44 disseminated on October 26, 2018 (Image 201810269133544063).

On October 30, 2018, the Committee filed one (1) 24-Hour Report to support five (5) independent expenditures totaling \$45,000.00 disseminated on October 29, 2018 (Images 201810309133558040-42).

On December 3, 2018, the Committee amended the 24-Hour Report filed on October 30, 2018. The amendment increased the total independent expenditures to ten (10) independent expenditures totaling \$52,811.44 disseminated between October 25, 2018 and October 29, 2018. The amended filing also included a memo text stating, “Amended to add

cost for video editing accidentally omitted from original filing” (Images 201812039133903695-700).

On December 6, 2018, the Committee filed the 2018 30 Day Post-General Report covering the period from October 18, 2018, through November 26, 2018, which included a Schedule E (Itemized Independent Expenditures) disclosing forty-one (41) independent expenditures totaling \$1,090,854.80 made in support or opposition to seventeen (17) federal candidates (Images 201812069134825251-71).

On January 3, 2019, the Committee filed an Amended 2018 30 Day Post-General Report. The Amended Report disclosed no changes to Schedule E (Images 201901039143706805-25).

On January 16, 2019, the Committee filed an Amended 2018 30 Day Post-General Report, which included a Schedule E disclosing forty-three (43) independent expenditures totaling \$1,091,204.80 made in support or opposition to seventeen (17) federal candidates. The Committee failed to timely file two (2) 24-Hour Reports totaling \$31,350.00 to support six (6) independent expenditures for the 2018 General Election (Images 201901169143832210-31, Attachment 2).

On the same day, the Committee amended the 24-Hour Report filed on October 26, 2018. The amendment increased the total independent expenditures to four (4) independent expenditures totaling \$7,161.44 disseminated on October 26, 2018. The amended filing also included a memo text stating, “Amending to include expenses inadvertently omitted from the original filing (2 payments of \$175.00 each to Associated Press)” (Images 201901169143831938-40).

On June 4, 2019, a Request for Additional Information (RFAI) was sent to the Committee referencing the Amended 2018 30 Day Post-General Report, received January 16, 2019. Among other items, the RFAI noted that the Committee may have failed to file or timely file one or more required 24-Hour Reports regarding independent expenditures. Charts were included with the RFAI identifying six (6) independent expenditures, totaling \$31,350.00 for which a 24-Hour Report had not been filed or timely filed (Images 201906040300041302-05, Attachment 2).

On July 24, 2019, the RAD Analyst contacted David Swanson, a Representative of the Committee, to discuss the RFAI sent on the Committee’s Amended 2018 30 Day Post-General Report, received January 16, 2019. Mr. Swanson stated the Committee would respond to the RFAI as soon as possible, but admitted the Committee did appear to miss a few required filings, and would explain further in their response. The Analyst explained the Committee could be referred to another office for potential further action for failing to file or timely file 24-Hour Reports outlined in the RFAI unless an adequate response was received (Attachment 3).

On the same day, the Committee filed one (1) 24-Hour Report to support one (1) independent expenditure totaling \$30,000 disseminated on October 30, 2018. The filing also included a memo text stating, “This expenditure was reported on Schedule E of the

2018 Post-General Report, however, the filing of (this) 24hr report was inadvertently omitted (Images 201907249151654224-5).

On July 25, 2019, the Committee filed an Amended 30 Day Post-General Report covering the period from October 18, 2018, through November 26, 2018. The Amended Report disclosed no changes to Schedule E (Images 201907259151657461-82).

On the same day, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the Amended 2018 30 Day Post-General Report. The Committee stated, in part:

“You have noted on item number 2, that Human Rights Campaign Equality Votes may have failed to timely file required 24-hour reports. We have reviewed the filings and regret the administrative error. The PAC filed two late 24-hour reports, FEC-1289627 on December 3, 2018, and, FEC-1304998 on January 16, 2019, as soon as we became aware of each omission. There is an additional late filing that we were unaware of until receiving this RFAI. This filing has been made on July 25, 2019, FEC-1343735. Expenses referenced on these 24-hour reports were all timely disclosed on Schedule E of the post-general report. HRC timely disclosed 24-hour and 48-hour reports for numerous expenditures made during the 2018 mid-term season. Furthermore, we have instituted additional internal training and procedures to ensure that all independent expenditures are timely filed” (Image 201907259151658876).

To date, no further communication has been received from the Committee regarding this matter.
