III. BACKGROUND:

Failure to Provide Supporting Schedules (Failure to Timely File 48-Hour Reports)

Free Forever Political Action Committee (“the Committee”) failed to timely file one (1) 48-Hour Report totaling \$110,050.00 to support four (4) independent expenditures disclosed in the 2020 April Quarterly Report, made up to and including the 20th day before the 2020 Primary Election held in the state of Kansas (Attachment 2).

On April 15, 2020, the Committee filed the original 2020 April Quarterly Report covering the period from January 1, 2020 through March 31, 2020. The report included a Schedule E (Itemized Independent Expenditures) disclosing four (4) independent expenditures, totaling \$110,050.00, made in opposition to one (1) federal candidate (Images 202004159219592770-71).

On May 21, 2020, a Request for Additional Information (RFAI) was sent to the Committee referencing the 2020 April Quarterly Report. The RFAI noted that the Committee may have failed to file one (1) or more of the required 48-Hour Reports for

independent expenditures disclosed in the report. A chart was included with the RFAI identifying the four (4) independent expenditures totaling \$110,050.00, for which a 48-Hour Report had not been filed (Images 202005210300071509-11).

On June 30, 2020, the Committee filed an Amended 2020 April Quarterly Report. The report disclosed no change to Schedule E from the original report (Images 202006309244226717-18).

On the same date, the Committee filed one (1) 48-Hour Report to support four (4) independent expenditures, totaling \$110,050.00, disseminated on March 9, 2020. A memo text was included with the report stating, in part:

“This report is being filed in response to the RFAI received [sic] 5/21/2020. There was an oversight and this was not filed in a timely manner on the 48 hr form but was properly disclosed on the quarterly report. New procedures have ben [sic] put in place [sic] to keep this from happening again” (Images 202006309244226704-06).

Later on the same date, the Committee filed an FEC Form 99 (Miscellaneous Electronic Submission) in response to the RFAI referencing the 2020 April Quarterly Report. The Committee stated, in part:

“An Amended Q2 2020 Report was filed as well as a 48 hr Report from Q2. This report is being filed in response to the RFAI received [sic] 5/21/2020. There was an oversight on our end by myself. The 48hr Notice was not filed in a timely fashion. It was properly disclosed on the quarterly report. New procedures have been put in place to keep this from happening again” (Image 202006309244226743).

On July 7, 2020, the Reports Analysis Division (RAD) Analyst attempted to call Patrick Krason, the Committee’s Treasurer, using the phone number disclosed on the Statement of Organization (“FEC Form 1”); however, the phone number had been disconnected (Attachment 3).

On the same date, the Analyst emailed Mr. Krason to inform him that the outstanding matter relating to the late 48-Hour Report for independent expenditures disclosed in the 2020 April Quarterly Report may be referred to another Commission office for potential further action. The email requested Mr. Krason call the Analyst to discuss the matter (Attachment 3).

Later the same day, Mr. Krason called the RAD Analyst. The Analyst explained the Committee’s failure to timely file the 48-Hour Report may be referred to another Commission office for potential further action. The Analyst explained that Mr. Krason could provide an additional FEC Form 99 with clarifying information. Mr. Krason explained that he had already filed an FEC Form 99 and amended the 2020 April Quarterly

Report. Mr. Krason said he had nothing else to clarify on the issue, but he would amend the FEC Form 1 to provide a current phone number (Attachment 3).

To date, no further communications have been received from the Committee regarding this matter.
