

- 1) Contributions received for the 1994 General Election, prior to the June 6, 1994 Primary Election, \$48,000.
- 2) Contributions received from June 7, 1994 to the date of Congressman Gallo's withdrawal from the General Election, \$55,612.
- 3) General Election expenditures from June 7, 1994 to Congressman Gallo's withdrawal from the General Election on August 23, 1994, \$47,632.56.
- 4) General Election expenses from August 24, 1994 to date, September 12, 1994, \$9,930.69.
