WE THE PEOPLE OF THE REFORM PARTY OF ALASKA STATE COMMITTEE PETITION TO REQUEST LEGAL ADVISORY OPINION OF THE STATE PARTY STATUS OF THE REFORM PARTY OF ALASKA STATE.

PURSUANT TO RULE OF STATUTORY LAW: 2 USC 431 (15), 11 CFR 100.14 (a), 2 USC 437 (f) (c), and, F.E.C.- A.C.R. PRECEDENTS, SAME AS PREVIOUS, 1997-3, 1997-7, 1996-51, 1996-43, 1996-27, 1995-49, 199236 A.O.R..

SINCE, THE REFORM PARTY OF ALASKA SECURED ELECTION BALLOT ACCESS VOTE OF OVER THREE PERCENT OF THE TOTAL VOTE CAST IN THE 1996 ELECTION FOR TWO FEDERAL CANDIDATES, PRESIDENT AND VICE PRESIDENT, FACTS OF THE PUBLIC RECORD AND F.E.C. RECORDS, BY ALASKA STATE ELECTION STATUTE, THE REFORM PARTY QUALIFIED AS A LIMITED STATE POLITICAL PARTY WITH BALLOT ACCESS OF FEDERAL CANDIDATES, WITH HONOR TO MR. ROSS PEROT. THE FOUNDER.

THE REFORM PARTY OF ALASKA HAS DRAFTED PARTY BYLAWS TO BIND THE PARTY TO RESPONSIBILITIES OF PARTY-BUILDING EFFORTS AND RELATIONSHIP DUTIES BETWEEN THE STATE PARTY COMMITTEE AND THE PARTY MEMBERS. OR PEOPLE.

ANY F.E.C. CRITERIA OF AFFILIATION OF A STATE COMMITTEE WITH A NATIONAL COMMITTEE AS A PRECONDITION OF F.E.C. STATE COMMITTEE STATUS, WOULD CONSTITUTE AN INVALID PRECONDITIONAL DOUBLEBIND, SINCE, THERE MUST BE SIX MINIXUM STATE COMMITTEES STATUS DETERMINED BY THE F.E.C. PRIOR TO THE AFFILIATION AND APPROVAL OF A NATIONAL COMMITTEE, AND NOT IN THE REVERSE ORDER.

THE PRIOR F.E.C. -A.O.R. PRECEDENTS INCLUDE PRECONDITIONS OF SIGNATURES OF EMPLOYEES OF TEXAS PLUTOCRATIC ORGANIZATION AFFILIAT--ION REQUESTED OF STATE PARTY COMMITTEE STATE DETERMINATION, WHICH COULD BE CONSTRUED AS LOSS OF IMPARTIALITY.
