Ms. Shin,

I have reviewed the statements from our telephone conversation on Wednesday, March 12, 2008 and find them to be accurate to the best of my knowledge, with the exception of statement (4). It states:

You have one family car. Due to the shortage of space in certified daycare facilities near your home, you anticipate that you will need to travel about 40 miles/day to take your child(ren) to and from daycare. This travel will result in additional mileage on the family car and gas expenses.

A review of facilities in the area after our conversation shows that the mileage was over estimated; and to provide accurate information for the commission the following text "about 40 miles/day" should be changed to "about 20 miles/day". Dear Mr. Goldup,

In a telephone conversation on Wednesday, March 12, you provided us with additional information regarding your request for an advisory opinion. We have set out below our understanding of certain points that you made during this conversation. We would appreciate it if you would please review the statements below and either confirm their accuracy or correct any misperceptions.

- (1) You have two children: a seven-year old and a three-year old.
- (2) You are at the beginning stages of your campaign and do not currently travel very frequently. However, you anticipate that you will travel on a full-time basis throughout the 20th Congressional District of New York for campaign purposes.
- (3) Due to your anticipated campaign travels, your three-year old child will require full-time daycare at about \$200/week. Your seven-year old will require occasional after school day care, and once school is out for the summer in June, she will require full-time daycare at about \$200/week.
- (4) You have one family car. Due to the shortage of space in certified daycare facilities near your home, you anticipate that you will need to travel about 40 miles/day to take your child(ren) to and from daycare. This travel will result in additional mileage on the family car and gas expenses.
- (5) You also anticipate that you will incur additional mileage on the family car once you begin traveling full-time throughout the 20th Congressional District of New York for campaign purposes.
- (6) The daycare and additional travel costs would not exist but for your candidacy.
- (7) Your wife works full-time and is unable to take care of your two children during working hours.
- (8) You had no earned income during the year prior to becoming a candidate.
