Dear Mr. Olson-

Thank you for your email granting an extension of the 60-day deadline for responding to this advisory opinion request until November 1, 2013. I just want to clarify the point that I was making to Mr. Miles during our telephone conversation yesterday. There is certainly no requirement that Citizens for Joe Miller grant the Commission an extension in order to have three weeks to submit comments in response to the comments the Commission received from the Alaska Dispatch. I was merely pointing out that, considering that the Commission was originally scheduled to consider this advisory opinion request at its September 26 Open Meeting, if Citizens for Joe Miller were to submit comments on September 25, that would not provide the Commission a meaningful amount of time to consider those comments carefully and make any changes to the draft advisory opinion that it deems necessary to incorporate any relevant information into the final advisory opinion. An extension until November 1 will give the Commission the opportunity to fully consider your request and other submissions at an Open Meeting on October 10 or October 31.

In your telephone conversation with Mr. Miles of our office yesterday, you indicated that our client, the requester, Citizens for Joe Miller (FEC ID No. C00522730), could have the three weeks it requested to submit comments in reply to those submitted by the Alaska Dispatch in AOR 2013-11 only if it agreed to extend -- to November 1, 2013 -- the Commission's 60-day deadline under 2 U.S.C. section 437f(a)(1).

On behalf of the requester, we agree to an extension of the Commission's deadline to issue an Advisory Opinion under 2 U.S.C. section 437f(a)(1), to November 1, 2013.

Accordingly, it is our understanding that the requester will have three weeks, or until September 25, 2013, within which to submit comments in response to the comments submitted by the Alaska Dispatch in this matter.
