RE: Advisory Opinion Request 2018-06 (Shirley)

Dear Ms. Stevenson,

We write in support of the request of Liuba Grechen Shirley and her campaign committee that campaign funds may be used for childcare expenses so that she may engage in campaign activities as part of her campaign for Congress. In the circumstances described in Ms. Shirley's letter, and assuming that she maintains accurate records, the childcare that she obtains in order to engage in campaign activities would not constitute "personal use" under 11 C.F.R. § 113.1(g) because it would not "exist irrespective of the candidate's campaign." This follows almost inexorably from AO 1995-42 (McCrery).

But there are larger considerations at stake. The struggle for political equality for women did not end in 1920 with the passage of the Nineteenth Amendment. Women face many structural barriers in running for elective office.<sup>2</sup> Many of these barriers are particularly acute for women of color.<sup>3</sup> These barriers include difficulty reconciling work and family obligations with a political career, including child care while running for office.<sup>4</sup> The child

care obligations of many women candidates today are at least as substantial as, and often more extensive than, those presented by then-Congressman Jim McCrery in 1995.

Much progress has been made over the past century towards achieving political and workplace equality for women. Yet much still remains to be done. Allowing Ms. Shirley and others like her to use campaign funds for child care where necessary for the candidate to run for office is a small step that the Commission should be proud to take.
