I have noticed that google and its employees have engaged in a campaign to benefit one candidate over another, such as when Eric Schmidt formed a company called "the groundwork" https://en.wikipedia.org/wiki/The_Groundwork to assist hillary clinton in her campaign, while simultaneously censoring information in its products critical to hillary clinton which was released by the organization Wikileaks.

Therefore it is my concern that Google will use a set of arbitrary criteria that are open to subjective analysis, to favor some candidates over others based upon their ideology. It may very well be that google would consider its terms of use or "illegal". One example would be the dissemination of information about hunter biden's laptop or ashley biden's diary, which it may consider to be "illegal content", which for example Project Veritas has been accused of "misprision of a felony" for the dissemination of allegedly stolen materials. However these materials present serious issues of public interest, with regards to selling influence over Joe Biden by Hunter Biden.

There are also other ways that the company could portray messages as illegal, for example about the election fraud investigations, of which I had personally located dead voters voting in pennslyvania as "incitement to riot" or "sedition" or "seditious conspiracy". Moreover ideas such as "build the wall" might be portrayed as a violation of international human rights, to deny people asylum in the United States, or messages promoting or banning abortion depending on the state, i.e. conspiracy to violate human rights or conspiracy to engage in abortion.

Moreover I do not see anything about the "program requirements" and while they may not be directly targeting a political party, they may be able to indirectly target a political party based on the ideological content of that party. See e.g. the User Content and Conduct Policy <https://support.google.com/googlecurrents/answer/9680387?hl=en> see also "hate speech policy" <https://support.google.com/youtube/answer/2801939> see also Election Misinformation policy <https://support.google.com/youtube/answer/10835034> Cyberbullying policy <https://support.google.com/youtube/answer/2802268>

As such, I believe that these "viewpoint based restrictions of speech" are the most egregious types of censorship under our constitution, and that google's use of these policies while not targeting parties on their face, should be analyzed under a disparate impact analysis, so as to not discriminate against parties and their candidates.




