SUMMARY OF ALLEGATIONS

In the complaint, it is alleged that the Sam Gejdenson for Congress Committee (the Committee) violated 11 C.F.R. § 104.2 by failing to identify the name of the employer for many of its itemized contributors on the October 10, 1979 Quarterly Report, 1979 Year End Report, and the April 15, 1980 Quarterly Report.

FACTUAL AND LEGAL ANALYSIS

2 U.S.C. § 434(b)(3) (formerly 2 U.S.C. § 434(b)(2)) requires each report to disclose the identification of each person who makes a contribution to the reporting committee during the reporting period, whose contribution or contributions have an aggregate amount or value in excess of \$200 (formerly \$100) within the calendar year. (See also 11 C.F.R. § 104.3 (formerly 11 C.F.R. § 104.2) Pursuant to section 431(13), the term "identification" means, in the case of an individual, the name, the mailing address, and the occupation of such individual, as well as the name of his or her employer. (See also 11 C.F.R. § 100.12)

In its first three reports, the Committee, as alleged by the complainant, failed to name the employer of many of its contributors. However, on May 20, 1980, ten days prior to receiving a copy of the complaint, the Committee filed three amended reports disclosing the required information for most of its contributors.

In his response, David Silverstone, attorney for the respondent, stated that the Committee was relying on the instructions given on the reporting forms which call for the "principal place of business" of the contributor. 1/ (See Attachment 1) This was construed to mean the location and not the name of the company, etc. However, once the mistake was realized, amended reports were filed.

Therefore, it appears the Committee has committed a technical violation of the Act and has since achieved substantial compliance. Accordingly, the General Counsel recommends the Commission find reason to believe the Committee violated 2 U.S.C. § 434(b)(3) and 11 C.F.R. § 104.3 and close the file.

Recommendations

1. Find reason to believe the Sam Gejdenson for Congress Committee violated 2 U.S.C. § 434(b)(3) and 11 C.F.R. § 104.3 and take no further action.
2. Close the file.

1/ The instructions on Schedule A Revised, January, 1978, call for the occupation and principal place of business. Schedule A Revised, March, 1980 gives the definition of "identification", and asks for the name of the employer.

Dear Mr. Steele:

We represent the Sam Gejdenson for Congress Committee in the above-captioned matter. We are in receipt of your letter of May 27, 1980 as well as the May 19, 1980 letter complaining about an alleged violation of regulations promulgated by the Federal Election Commission. The letter of May 19, 1980 states that there has been a violation of Section 104.2 of your regulations. Section 104.2, however, refers to the use of certain forms by a campaign committee. As you can see by the enclosed copy of the campaign filing by the Committee, the forms as required by your Commission have been utilized.

However, upon review of the use of these forms it appears to us that the forms were incompletely filled out in that the place of business of the contributor was identified by town and not by company. As I am sure you will agree, the form only calls for the "principal place of business" of the contributor. While it is true that your regulations appear to require identification of not only the place of business and the occupation of the contributor, but also the employer, (Section 100.12 et. seq.), the form is ambiguous in this regard.

I think it is important to point out that there has never been an intent by the Committee to conceal the employer of the contributor. It should be noted in this regard that many of the contributors to the Committee work in small towns where the identification of the contributor himself or herself is a clear delineation of the employer as well. Further, several of the entries refer to the place of business as "Hartford, Connecticut" and then refer to the occupation as "state employee". What had been left out was that the employer was the State of Connecticut. However, it is clear that a state

employee in Hartford, Connecticut is an employee of the State of Connecticut.

There are other instances where the name of the contributor and the name of the business is identical. For example, the contributor, Sam Kofkoff, was identified as an executive in Fitchville, Connecticut. What had been omitted was that he was an executive with the Kofkoff Egg Farm. It is clear that this omission was not done with the intent to deceive but rather by an interpretation of place of business to refer to the location and not the company itself.

In any case, upon realizing the possible error that had been made, the Committee immediately filed with the proper state and federal officials forms correcting any omissions that may have occurred. This filing was made on May 20, 1980, ten days prior to the receipt of your letter by the Committee. I have enclosed for your information a copy of the amended filing. The additional information has been entered in manuscript and can be identified as such.

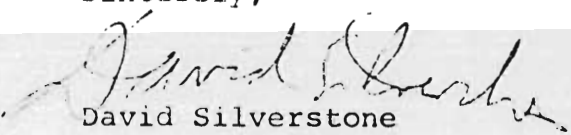
Under the circumstances stated above we believe that the Committee, if it was in violation, was in such technical violation due to a literal reading of the Federal Election Commission form and not with any intent whatsoever to deceive anyone. The unintentional technical violation, if any, was corrected immediately, prior to any communication from the Commission. The Committee intends to complete future reports in a manner consistent with the amended filing enclosed herewith.

The Committee is now and has always been in substantial compliance with the Federal Election Campaign laws. Under the circumstances, therefore, we believe that the complaint should be dismissed.

As per the letter of representation which is being sent to you under separate cover, we would appreciate it if notifications and communications from the Commission could be sent directly to us so that a prompt response can be made.

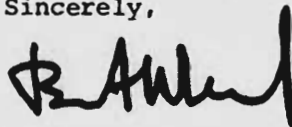

We represent the Sam Gejdenson for Congress Committee in the above-captioned matter. We are in receipt of your letter of May 27, 1980 as well as the May 19, 1980 letter complaining about an alleged violation of regulations promulgated by the Federal Election Commission. The letter of May 19, 1980 states that there has been a violation of Section 104.2 of your regulations. Section 104.2, however, refers to the use of certain forms by a campaign committee. As you can see by the enclosed copy of the campaign filing by the Committee, the forms as required by your Commission have been utilized.

However, upon review of the use of these forms it appears to us that the forms were incompletely filled out in that the place of business of the contributor was identified by town and not by company. As I am sure you will agree, the form only calls for the "principal place of business" of the contributor. While it is true that your regulations appear to require identification of not only the place of business and the occupation of the contributor, but also the employer, (Section 100.12 et. seq.), the form is ambiguous in this regard.

I think it is important to point out that there has never been an intent by the Committee to conceal the employer of the contributor. It should be noted in this regard that many of the contributors to the Committee work in small towns where the identification of the contributor himself or herself is a clear delineation of the employer as well. Further, several of the entries refer to the place of business as "Hartford, Connecticut" and then refer to the occupation as "state employee". What had been left out was that the employer was the State of Connecticut. However, it is clear that a state

employee in Hartford, Connecticut is an employee of the State of Connecticut.

There are other instances where the name of the contributor and the name of the business is identical. For example, the contributor, Sam Kofkoff, was identified as an executive in Fitchville, Connecticut. What had been omitted was that he was an executive with the Kofkoff Egg Farm. It is clear that this omission was not done with the intent to deceive but rather by an interpretation of place of business to refer to the location and not the company itself.

In any case, upon realizing the possible error that had been made, the Committee immediately filed with the proper state and federal officials forms correcting any omissions that may have occurred. This filing was made on May 20, 1980, ten days prior to the receipt of your letter by the Committee. I have enclosed for your information a copy of the amended filing. The additional information has been entered in manuscript and can be identified as such.

Under the circumstances stated above we believe that the Committee, if it was in violation, was in such technical violation due to a literal reading of the Federal Election Commission form and not with any intent whatsoever to deceive anyone. The unintentional technical violation, if any, was corrected immediately, prior to any communication from the Commission. The Committee intends to complete future reports in a manner consistent with the amended filing enclosed herewith.

The Committee is now and has always been in substantial compliance with the Federal Election Campaign laws. Under the circumstances, therefore, we believe that the complaint should be dismissed.

As per the letter of representation which is being sent to you under separate cover, we would appreciate it if notifications and communications from the Commission could be sent directly to us so that a prompt response can be made.

Thank you very much for your consideration in this matter. If you have any questions in this matter, please do not hesitate to contact us at your earliest convenience.

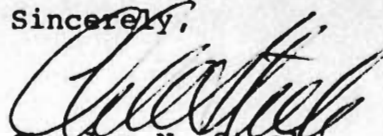

On behalf of Patricia Hendel, candidate for United States Representative for the Second Congressional District of Connecticut, and the Pat Hendel for Congress Committee, I am requesting that you investigate a possible violation of the Federal Election Campaign Act by the Sam Gejdenson for Congress Committee, Box 1890, Fitchville, Connecticut. That Committee is the candidate committee for Samuel Gejdenson, a candidate for United States Representative from the Second Congressional District of Connecticut.

It is my belief that under Section 104.2 of the Regulations the Committee improperly failed to identify the company and/or business affiliations of self-employed persons who contributed \$100 or more to the Committee in its quarterly reports for periods prior to December 31, 1979.

Also, the Committee appears to have been in violation of the identification requirements for some employees and self-employed contributors of \$200 or more in its report for the period ending March 31, 1980. There are many contributors listed as "businessmen" without indication of the type of business or the name of the business. Several calls by members of our Committee to the FEC regarding what information is required properly

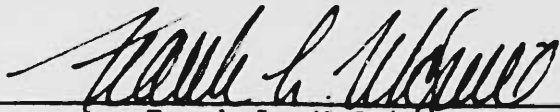

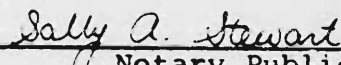
