Dear Sirs:

The enclosed letter is a copy mailed to Mr. Richard Bennett on April 19th, 1976 by registered mail. Mr. Bennett is a candidate for Democratic nomination to the U. S. Congress from the sixth district of South Carolina. Mr. Bennett refuses to talk with me, or any other person whom he has an obligation to. The rent on his campaign headquarters in Florence has been paid by him only once in the five months it has been in existence; now I have found out the headquarters has been rented to college students for living quarters by Mr. Bennett for the past two months. The telephones have been disconnected. Loans he has made from individuals on his campaign committee have not been repaid and he refuses to talk with these people.

I resigned on March 30th of this year as Campaign Coordinator after finding out in part the type of individual he really is. My two co-managers had resigned approximately thirty days earlier after they alleged misconduct by Mr. Bennett.

Mr. Bennett still refuses to contact me and now I find myself in personal financial straits while trying to pay off campaign debts that I feel a moral obligation for, because credit was extended in some cases only because of my involvement in the campaign. The lease on Bennett Campaign Headquarters now has to be satisfied and Mr. Bennett will not contact me about it. He does not have a telephone and says he doesn't intend to have one installed. I have been unable to get mine and other former campaign workers office furnishings out of the headquarters building. An eviction notice will be served on the occupants of the building tomorrow morning. I certainly have suspicions that all of the bills I have had to pay does not show up on the campaign reports filed by Mr. Bennett but I can not know for sure until I see the reports.

Mr. Bennett continues his campaign while ignoring his responsibilities. He is making a mockery out of the Federal Election process and I do not believe the Federal Election Commission condones such actions by a candidate for election to a federal office. I worked very hard for eight months in Mr. Bennetts' campaign and after finding out the type of person he really is I now feel a responsibility to the people in this district that I might have helped influence, to let them know what this candidate is trying to do.

Dear Mr. Bennett,

All efforts to contact you the past two weeks have been futile. You undoubtedly have chosen to ignore all my requests for you to contact me. Your decision makes it necessary for me to look for other means of recovering some of the money I am still paying out for your campaign debts.

The first step I am taking is to send the Federal Election Commission in Washington a detailed explanation of my complaint and requesting any relief they might be able to provide. This is being done this date. I hope this is all that will be necessary, but I will take other steps if the Federal Election Commission is unable to help in this matter.

The gasoline bill you charged to my credit card is \$366.00 and the PYA bill that I must pay now is approximately \$427.00. In addition there is the \$300.00 advertising bill to be paid to Mr/Nattles. This along with the unpaid bills for pictures, hair cuts, etc. are items that I feel obligated to pay for now. And of course there is the hundreds of dollars that I have already had to pay out to cover campaign debts that I was to be reimbursed for.

As I have stated to you many times before, communication with those involved in your campaign is vital and for you to continue to ignore your responsibilities in this matter is incomprehensible. Since you have decided not to communicate with me at all, then I hope the Federal Election Commission can convince you to do otherwise.

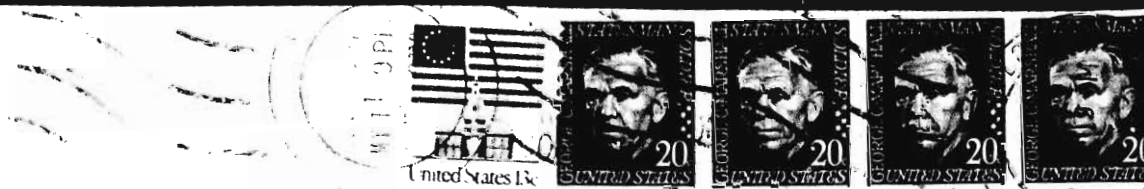
