PRELIMINARY LEGAL ANALYSIS

The complaint is based solely on information and beliefs and fails to indicate any factual basis in support of the allegations. Absent such information there is no basis for further action. Loans by a candidate to his campaign do not violate the Federal Election Campaign Laws. See Buckley v. Valeo, 424 U.S. 1(1976) at 46, n. 57; §100.10(c), proposed Commission regulations.

Close file with attached letters; should additional information be discovered in the course of the Commission's investigation of MUR 156 (76), the matter may have to be reopened.

In accordance with Public Law 94-283, Section 109, I am herewith filing a further sworn complaint against Robert E. Badham, Republican primary candidate from the 40th California Congressional District. This is in addition to the complaint which I have previously filed with your Commission, and which I respectfully request you also continue to consider.

The basis for this additional complaint is Mr. Badham's use in his primary campaign of borrowed funds or of extensions of credit, but failing to report such as required by law.

Examination of the Badham Congressional Committee Report of Receipts and Expenditures for a Candidate or Committee Supporting any Candidate(s) for Nomination or Election to Federal Office dated July 1, 1976, reveals that Mr. Badham made a loan of \$10,000 to the Badham Congressional Committee; and, that on June 4, 1976, Mr. Badham made a further loan to that Committee in the sum of \$4,000.

I am informed and believe and based thereon state that Mr. Badham was without funds, resources or credit to enable him to extend the aforesaid loans to the Badham Congressional Committee out of his own funds. I am further informed and believe and based thereon state that said sums represent proceeds

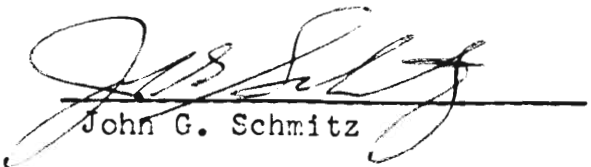
