III. BACKGROUND:

Failure to File a Required Report of Receipts and Disbursements

The Friends of Frank Hutchinson ("the Committee") has failed to file the 1990 October Quarterly Report of Receipts and Disbursements. Prior Notices were sent August 17, 1990 and September 21, 1990, informing the Committee that the report was due on October 15, 1990 (Attachment 2). A Non-Filer Notice was sent to the Committee on November 7, 1990, for failure to file the report (Attachment 3). The Non-Filer Notice informed the Committee that failure to file this report might result in audit or legal enforcement action.

The Committee filed an amended 12 Day Pre-Primary Report on November 20, 1990. The cover letter of the amendment states that "the candidate lost the September 22 primary. The next quarterly report and a termination report will accordingly follow." (Attachment 4). The Reports Analysis Division analyst attempted to telephone the treasurer, the assistant treasurer, and the candidate on December 10, 1990. The long distance telephone operator informed the analyst that there was no listing for the candidate, Franklin Hutchinson Jr. or the assistant treasurer, James Dornan. The analyst was told that the treasurer, Carl Berger, had an unpublished telephone number. The analyst was also told that the telephone number for the Committee was no longer in service (Attachment 5).

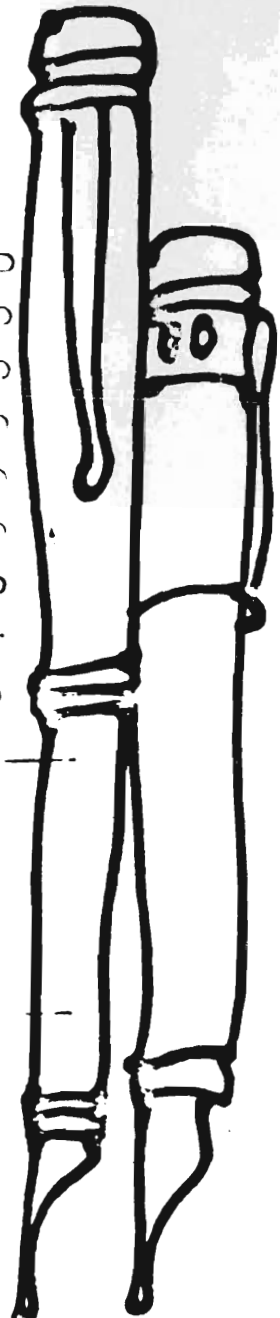

WHO NEED NOT FILE

Principal campaign committees of candidates not active in the 1990 elections (i.e., committees active in past or future elections) do not file the October Quarterly Report. Instead they report semiannually. The next semiannual report is due January 31, 1991.

WHAT MUST BE REPORTED

All financial activity (not previously reported) that occurred during the reporting period.

REPORTING FORMS

Candidate committees use FORM 3 (enclosed). If the campaign has more than one authorized committee, the principal campaign committee must also file a consolidated report on FORM 3Z.

WHERE TO FILE

Consult the instructions on the back of the Summary Page of Form 3. Note State filing requirements also.

LAST-MINUTE CONTRIBUTIONS

Committees which receive a contribution of \$1,000 or more, after the 20th day, but more than 48 hours before an election, must report it within 48 hours of its receipt. The notice must reach the appropriate Federal and State filing office within 48 hours of the committee's receipt of the contribution.

*Reports sent by registered or certified mail will be considered filed on the date of the U.S. postmark. Reports hand delivered or mailed first class must be received by the filing date.

This committee properly submitted a preprimary Report of Receipts and Disbursements For an Authorized Committee on September 7, 1990. However, a few errors existed in that report and, therefore, enclosed is an amendment. ¹ (Schedule A, Itemized Receipts, Schedule B, Itemized Disbursements, and Schedule D, Debts and Obligations Excluding Loans, are merely photocopies of the earlier report, since no information is different, but Schedule C, Loans, has changed.)

Schedule C, Loans, of the earlier report incorrectly listed a total of \$5,000.00 in loans from Mr. Franklin G. Hutchinson, Sr., the candidate's father. The senior Hutchinson did indeed loan the candidate the \$1,00.00 listed on part B of

page two of said schedule C, but the remaining \$4,000.00 of such loans were actually from the candidate himself. Also, the previous report incorrectly listed a total of \$3,500.00 in loans from Ms. Pat Tennant, but Ms. Tennant actually loaned the campaign only \$1,000.00, and the remaining \$2,500.00 of such loans were from the candidate himself. The error in the submitted report resulted from miscommunication between the candidate and myself: the respective \$4,000.00 and \$2,500.00 were repayments of personal loans the candidate had made to the senior Hutchinson and Ms. Tennant. This allowed the candidate to loan more to his campaign.

I of course apologize for this error and regret inconvenience caused by it. Please feel free to contact me should you have any questions or comments regarding this amendment.

The candidate lost the primary election, held in Hawaii on September 22, 1990, with 43 percent of the vote.

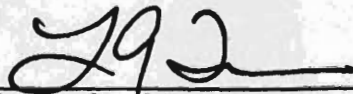

Dear Mr. Berger:

On January 30, 1991, the Federal Election Commission found that there is reason to believe Friends of Frank Hutchinson ("Committee") and you, as treasurer, violated 2 U.S.C. § 434(a)(2)(A)(iii), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against the Committee and you, as treasurer. You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath.

In the absence of any additional information demonstrating that no further action should be taken against the Committee and you, as treasurer, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.

If you are interested in expediting the resolution of this matter by pursuing preprobable cause conciliation and if you agree with the provisions of the enclosed agreement, please sign and return the agreement, along with the civil penalty, to the Commission. In light of the fact that conciliation negotiations, prior to a finding of probable cause to believe, are limited to a maximum of 30 days, you should respond to this notification as soon as possible.

Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of the General Counsel ordinarily will not give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

This matter will remain confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

For your information, we have attached a brief description of the Commission's procedures for handling possible violations of the Act. If you have any questions, please contact Jeffrey Long, the staff member assigned to this matter, at (202) 376-5690.

The Federal Election Campaign Act of 1971, as amended ("the Act"), provides that for principal campaign committees of candidates for the House of Representatives, such committees shall file quarterly reports in a calendar year in which a regularly scheduled general election is held. 2 U.S.C. § 434(a)(2)(A). Quarterly Reports are to be filed no later than the 15th day after the last day of each calendar quarter. 2 U.S.C. § 434(a)(2)(A)(iii). Thus, the due date for the 1990 October Quarterly Report was October 15, 1990. The Friends of Frank Hutchinson and Carl Berger, as treasurer, ("Committee") was notified on August 17 and September 21, 1990, that the report was due on October 15. The Committee did not file the 1990 October Quarterly Report. The Committee was notified again on November 7, 1990, that the report had not been received. To date the Committee has not filed the 1990 October Quarterly Report.

Therefore, there is reason to believe that the Friends of Frank Hutchinson and Carl Berger, as treasurer, violated 2 U.S.C. § 434(a)(2)(A)(iii).

GENERAL COUNSEL'S REPORT

I. BACKGROUND

On January 31, 1991, the Commission found reason to believe Friends of Frank Hutchinson and Carl Berger, as treasurer, ("Respondents") violated 2 U.S.C. § 434(a)(2)(A)(iii) for the failure to file the 1990 October Quarterly Report. Frank Hutchinson was a candidate for the House of Representatives in the September 22, 1990, Republican Primary in Hawaii. He lost the primary election with 43 percent of the vote.

II. ANALYSIS

On March 15, 1991, the treasurer filed the 1990 October Quarterly Report disclosing \$3,040.37 in receipts and \$5,274.00 in disbursements for the period from September 3, 1990, to September 30, 1990. The remaining activity for the period from July 1, 1990, had been reported in the Pre-Primary Election Report. At the time the treasurer filed the 1990 October Quarterly Report, he stated:

I must admit a grave error in judgement: over the past few months I have neglected to promptly attend to FEC correspondence that has arrived, believing the October 15 report and termination report were submitted as required and that this committee no longer formally existed. I have recently reviewed all material addressed to my attention and, of course, much to my embarrassment, the reports in question were obviously

not submitted.

I sincerely apologize for this irresponsible oversight and ask that no financial penalty be levied upon this committee or myself, for certainly no malfeasance was intended.

Along with the 1990 October Quarterly Report, the treasurer also filed a termination report covering the period from October 1, 1990, through January 31, 1991. This report showed total receipts of \$12,796.91 (consisting solely of contributions from the candidate) and total disbursements of \$14,561.23, nearly all in loan repayments resulting in zero cash on hand and zero debts owed by the committee. Because this enforcement matter was still open, the Respondents were informed that they could not terminate until this matter was closed.

Based on the updated reporting, the Respondents raised an aggregate total of \$32,196.18 in the 1990 election cycle and spent a like amount.

We note that the candidate participated in only the September 22 primary election. Thus, the late filing of the October Quarterly Report (due on October 15) did not deprive the voters in the primary election of any relevant information regarding the committee's financial activity. We also note that the treasurer has blamed the late filing on his mistaken belief that the report had been filed and that the committee had terminated. The late report itself disclosed less than \$10,000 in aggregate financial activity. The campaign as a whole raised and spent only \$32,196.18. The committee otherwise appears eligible to terminate.

Based on these circumstances and taking into account the

limited resources presently available to further pursue this matter, this Office recommends that the Commission take no further action with respect to the Respondents and close the file in this matter.²

III. RECOMMENDATIONS

1. Take no further action against Friends of Frank Hutchinson and Carl Berger, as treasurer.
2. Close the file.
3. Approve the appropriate letter.
