III. BACKGROUND:

Failure to File Forty-Eight Hour Notifications

The Wellstone for Senate committee ("the Committee") has failed to file the required Forty-Eight (48) Hour Notifications ("48-Hour Notices") for forty-two (42) contributions totalling \$60,350 received prior to the 1990 General Election.

The candidate was involved in the 1990 General Election held on November 6, 1990. Prior Notice was sent to the Committee on October 1, 1990 (Attachment 2). The Notice includes a section titled "Last-Minute Contributions". This section reads "Committees must also file special notices if contributions of \$1,000 or more are received during the period of October 18 through November 3, 1990. The notices must reach the appropriate Federal and State offices within 48 hours of the committee's receipt of the contributions."

Schedule A of the 1990 30 Day Post-General Report indicates that the Committee failed to file forty-two (42) 48-Hour Notices for contributions received during the aforementioned period (Attachment 3). The following is a list of the contributions for which no 48-Hour Notices were filed:

On January 8, 1991, a Request for Additional Information ("RFAI") was sent to the Committee (Attachment 4). The RFAI notes on an informational basis that the Committee may have failed to file one or more of the required 48-Hour Notices for "last minute" contributions of \$1,000 or more. The notice requests the Committee to review their procedures for checking contributions received during the aforementioned time period. In addition, the notice states that although the Commission may take legal steps, any response would be taken into consideration.

On March 1, 1991, the Committee responded by letter stating "We have reviewed our procedures for checking our contributions during the period between two and twenty days before an election, so that they will be reported to the commission within 48 hours of receipt" (Attachment 5).

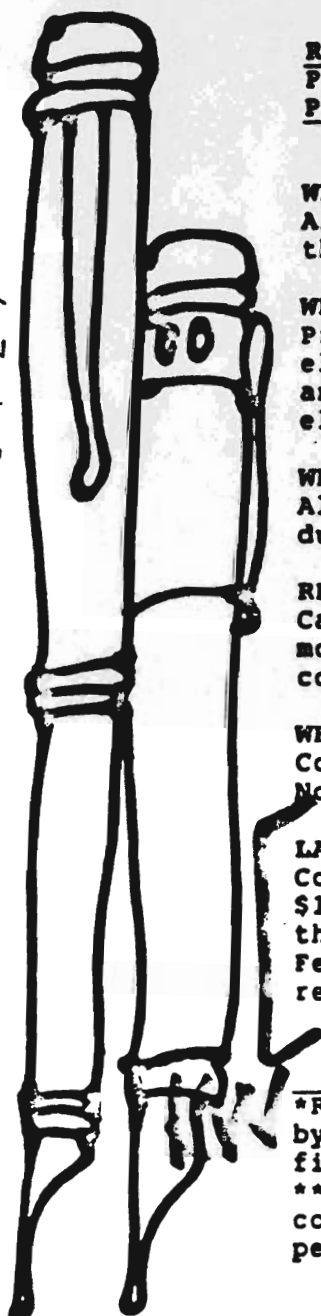

**The period begins with the close of the last report filed by the committee. If the committee has filed no previous reports, the period begins with the date of the committee's first activity.

On July 18, 1991, the Federal Election Commission found that there is reason to believe the Committee and you, as treasurer, violated 2 U.S.C. § 434(a)(6)(A), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

Under the Act, you have an opportunity to demonstrate that no action should be taken against Wellstone for Senate ("Committee") and you, as treasurer. You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath.

In the absence of any additional information demonstrating that no further action should be taken against the Committee and you, as treasurer, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.

If you are interested in expediting the resolution of this matter by pursuing preprobable cause conciliation and if you agree with the provisions of the enclosed agreement, please sign

and return the agreement, along with the civil penalty, to the Commission. In light of the fact that conciliation negotiations, prior to a finding of probable cause to believe, are limited to a maximum of 30 days, you should respond to this notification as soon as possible.

Requests for extensions of time will not be routinely granted. Requests must be made in writing at least five days prior to the due date of the response and specific good cause must be demonstrated. In addition, the Office of the General Counsel ordinarily will not give extensions beyond 20 days.

If you intend to be represented by counsel in this matter, please advise the Commission by completing the enclosed form stating the name, address, and telephone number of such counsel, and authorizing such counsel to receive any notifications and other communications from the Commission.

This matter will remain confidential in accordance with 2 U.S.C. §§ 437g(a)(4)(B) and 437g(a)(12)(A), unless you notify the Commission in writing that you wish the investigation to be made public.

Wellstone for Senate ("Committee") is the principal campaign committee for Paul Wellstone, the successful 1990 U.S. Senate candidate in Minnesota. The Federal Election Campaign Act, as amended, ("the Act") requires a candidate's principal campaign committee to file special notices of contributions of \$1,000 or more received after the 20th day, but more than 48 hours before, an election in which the candidate is running. The 48-Hour Notices must reach the appropriate federal office within 48 hours of the committee's receipt of the contributions. These last-minute contributions must also be itemized on the committee's next scheduled report.

2 U.S.C. § 434(a)(6)(A) and 11 C.F.R. § 104.5(f).

The Act defines a "contribution" as any gift, subscription, loan, advance, or deposit of money or anything of value made by any person for the purpose of influencing any election for Federal office. 2 U.S.C. § 431(8)(A)(i).

The General Election for Minnesota was held on November 6, 1990. In followup to our conversation of this date and in reply to Chairman McGarry's letter dated July 31, 1991, the Wellstone for Senate Committee proposes as follows:

In mitigation of the penalty, I respectfully submit the following with the understanding that these items are not to be considered alibis or excuses but merely circumstances surrounding the violation.

1. The violation was unintentional but is not disputed.
2. Many more contributions were reported within the 48 hours allowed than were omitted.
3. Good faith efforts toward complete compliance were attempted. This was the first federal campaign for this committee.

4. The majority of the noncompliance occurred when the volume of contributions received increased geometrically outpacing the procedures that the Committee had set up to try to comply with the law.
5. Most participants in the process were volunteers who did not get the contribution to the treasurer in a timely manner despite request.
6. All contributions were reported to the FEC in the regular campaign reports and the violation was limited to the 48-hour notification matter.
7. The Committee has committed itself in writing to the FEC to take all steps possible to avoid repetition and will meet that commitment.
8. The Committee is currently in debt approximately \$45,000.00 with a commitment not to accept any political action committee money through 1994. The treasurer is a person of very moderate means.
9. The Committee is currently cooperating to the best extent of its ability.

CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that Wellstone for Senate and Richard S. Kahn, as treasurer ("Respondents") violated 2 U.S.C. § 434(a)(6)(A).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a)(4)(A)(i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. Wellstone for Senate is a political committee within the meaning of 2 U.S.C. § 431(4) and is a principal campaign committee within the meaning of 2 U.S.C. § 431(5).

2. Richard S. Kahn is treasurer of Wellstone for Senate.

3. Pursuant to 2 U.S.C. § 434(a)(6)(A), political committees authorized by a candidate must file special notices identifying contributors who make contributions of \$1,000 or more received after the 20th day, but more than 48 hours before, an election in which the candidate is running, and must file these special notices within 48 hours of the committee's receipt of such contributions.

4. Respondents were required to file special notices identifying contributors who made contributions of \$1,000 or more received after October 17, 1990 but before November 4, 1990. Respondents failed to file special notices for last-minute contributions totaling \$60,350.00, received prior to the 1990 General Election in Minnesota.

V. Respondents failed to file special notices for \$60,350.00 in last-minute contributions in violation of 2 U.S.C. § 434(a)(6)(A).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Six Thousand Dollars (\$6,000), pursuant to 2 U.S.C. § 437g(a)(5)(A), such penalty to be paid as follows:

1. One initial payment of \$1,000 due on September 15, 1991;
2. A second payment of \$1,000 due on October 15, 1991;
3. A third payment of \$2,000 due on November 15, 1991;

4. A fourth payment of \$2,000 due on December 15, 1991.

5. In the event that any installment payment is not received by the Commission by the twentieth day of the month in which it becomes due, the Commission may, at its discretion, accelerate the remaining payments and cause the entire amount to become due upon ten days written notice to the respondents. Failure by the Commission to accelerate the payments with regard to any overdue installment shall not be construed as a waiver of its right to do so with regard to future overdue installments.

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed this agreement and the Commission has approved the entire agreement.

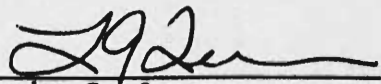

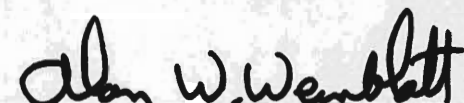
