COMPLAINT OF CENTER FOR RESPONSIVE POLITICS

1. This complaint charges that the respondent has violated the Federal Election Campaign Act, 2 U.S.C. § 431 et seq., as amended ("FECA"), by making aggregate contributions in excess of the limits permitted by the FECA.

PARTIES

2. The complainant, the Center for Responsive Politics, is a nonprofit, nonpartisan research group incorporated in the State of Iowa and headquartered in Washington, D.C., that studies Congress and related issues. Founded in 1983, it was designed to research matters concerning the organization and operation of Congress as an institution and to examine potential reforms that could improve both its internal operation and its responsiveness to the American public. The patterns of contributions of money to federal candidates has been one of its chief areas of study.

3. The respondent is an individual contributor to various candidates and political committees.

APPLICABLE STATUTES AND REGULATIONS

4. The FECA limits contributions by any one individual to an aggregate total of \$25,000 per calendar year. Contributions to a candidate or the candidate's authorized committee made in a year other than the calendar year of the election with respect to which the contribution is made are considered to be made during the calendar year in which such election is held. 2 U.S.C. § 441a(a)(3); 11 C.F.R. § 110.5.

GROUND FOR COMPLAINT

5. According to FEC records, respondent Edmund A. Stanley, Jr. made contributions subject to FECA in the amounts and to the persons identified in the list attached to this complaint as Exhibit 1. Attached as Exhibit 2 are copies of the FEC records for each contribution listed in Exhibit 1. All exhibits reflect the records on file at the FEC as of December 15, 1993.

6. On information and belief, respondent Edmund A. Stanley, Jr. made contributions attributed to the 1992 calendar year in the amount of \$51,700. These contributions exceeded by \$26,700 the \$25,000 contribution limit imposed by the FECA and Commission regulations on all contributions by any individual in a calendar year.

RELIEF

7. The Center for Responsive Politics respectfully urges the Commission to conduct a prompt and thorough investigation into the allegations in this Complaint, and to declare that the Respondent has violated the FECA and Commission regulations.

This firm has been retained by Mr. Edmund A. Stanley, Jr. in connection with a Complaint brought against him by the Center for Responsive Politics. The enclosed Designation of Counsel statement is submitted pursuant to your letter to Mr. Stanley of January 28, 1994. (See Exhibit A)

Mr. Stanley has always intended to fully comply with applicable campaign finance laws and regulations. To that end, when he first learned that his contributions exceeded allowable limits, he promptly requested refunds of donations made during the period in question. He has now received refunds totalling \$33,250, reducing his contributions during the relevant period to \$17,450. (See Exhibit B) This is well below the \$25,000 cap.

Mr. Stanley voluntarily requested these refunds for the express purpose of bringing his total contributions into compliance with applicable law. Refunds were requested on or before November 19, 1993, well before the Center for Responsive Politics' Complaint was filed. (See Exhibit C)

Some committees were able immediately to process and send refund checks, while others took several weeks. In fact, Mr. Stanley received and deposited all but one of the refund checks well before the Center for Responsive Politics' Complaint was filed. The sole exception is the refund from the Democratic National Committee ("DNC"), which took somewhat longer. Mr. Stanley requested a refund from the DNC on November 2, 1993. On January 6, 1994 the DNC notified Mr. Stanley that it had agreed to provide a refund check in the amount of \$13,000. It apparently took some time for the DNC to process the refund check, since it was not received until February 8, 1994. The attached affidavit of

a DNC official confirms that the refund was requested by Mr. Stanley and approved by the DNC well before Mr. Stanley became aware that any Complaint would be filed. (See Exhibit D)

At the time he made the donations in question, Mr. Stanley was not aware of the \$25,000 cap. We would respectfully add that Mr. Stanley recalls that none of the numerous written solicitations he received from PACs and candidate committees during the relevant period mentioned the \$25,000 cap, even while such solicitations often provided detailed explanations of other legal requirements. Further, some of the campaigns contacted by this firm in November 1993 apparently remained unaware of the cap at that late date. Although Mr. Stanley recognizes the mandate of the FEC and the importance of fully complying with all applicable rules and regulations, under these circumstances his unfamiliarity with the cap does not seem unreasonable.

We further note that in many instances Mr. Stanley could have greatly reduced his excess contributions by contributing jointly with his wife, Jennifer Stanley, who supports many of the same political efforts as does Mr. Stanley. As you know, joint contributions in the name of both the husband and wife are permitted under applicable regulations, with the result that one-half of the contribution counts toward the spouse's total. That Mr. Stanley did not avail himself of this option further demonstrates that he was simply unaware of the cap at the time he made the donations.

Mr. Stanley voluntarily undertook to bring his contributions within the allowable limit long before he received any complaint or threat of legal action. He has acknowledged the oversight, and admitted that his contributions exceeded the cap. Mr. Stanley is now in compliance with the \$25,000 cap. We therefore respectfully request that no further action be taken against Mr. Stanley.

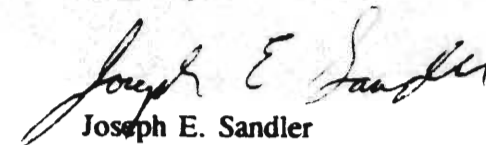

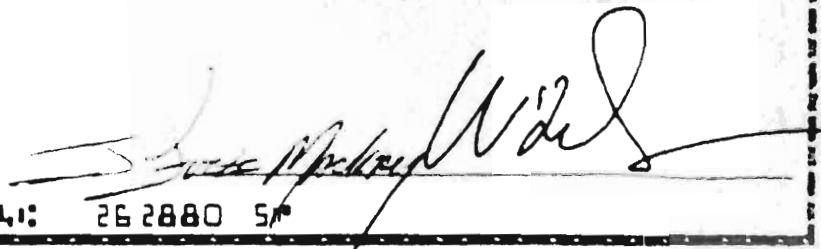

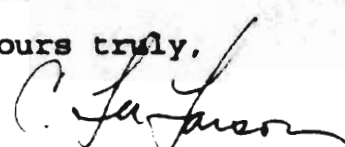

Pursuant to our conversation, I am writing to you on behalf of our client, Mr. Edmund Stanley, Jr., to confirm our request for a refund of any contributions that he made to your committee for the 1992 campaign year. As I explained, Mr. Stanley was unaware of the annual limit placed on political contributions by the Federal Election Commission and unknowingly has exceeded that limit.

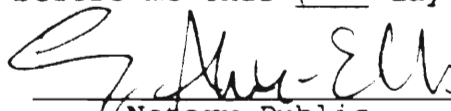
AFFIDAVIT OF JOSEPH SANDLER, ESQ.

2. As part of my responsibilities at the DNC, I am familiar with fundraising, including the receipt and handling of donations to the DNC.
3. I am also familiar with requests for refunds which the DNC receives from time to time.
4. On or about November 8, 1993 the DNC received from Mr. Edmund A. Stanley, Jr. a letter dated November 2, 1993 requesting a refund of Mr. Stanley's 1992 contribution of \$13,000. The DNC thereafter began to process that request.
5. I was in periodic contact with Mr. Stanley's representatives, who telephoned at various times seeking to know when the refund would be approved and a check sent to Mr. Stanley. 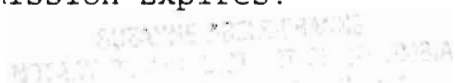

GENERAL COUNSEL'S MONTHLY REPORT

I. INTRODUCTION

This report is the General Counsel's Report to recommend that the Commission no longer pursue the identified lower priority and stale cases under the Enforcement Priority System.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 10 cases which do not warrant further pursuit relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively low priority and consequent recommendation not to pursue each

case is attached to this report. See Attachments 1-11. As the Commission requested, this Office has attached the responses to the complaints for the externally-generated matters and the referral for the internally-generated matter following the narrative. See Attachments 1-11.

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 34 cases that

do not warrant further investment of significant Commission resources.² Since the recommendation not to pursue the identified cases is based on staleness, this Office has not prepared separate narratives for these cases. As the Commission requested, in matters in which the Commission has made no
