To the General Counsel:

Please be advised that the Friends of Marjorie Margolies-Mezvinsky campaign is filing a complaint against the Jon D. Fox for Congress campaign and the Horsham (Pennsylvania) Republican Party for violations of Federal election law. The complainant's full address is: P.O. Box 157, Narberth, Pennsylvania, 19072.

The specific violations committed by Respondent A (Fox for Congress) are the following:

1) The Fox for Congress Committee has received \$2,000 from a local party committee (Horsham Republican Party) that has not registered with the Federal Election Commission, as required by Federal law.

A. Horsham Republican Party donated \$1,000 on 3/21/94 (Fox for Congress, April 15 Quarterly Report)

B. Horsham Republican Party donated \$1,000 on 5/27/94 (Fox for Congress, July 15 Quarterly report)

2) The Fox for Congress Committee has failed to disclose the required employer information for contributors who donated \$86,595 as reported in the Fox for Congress committee quarterly reports, April 15 and July 15, 1994.

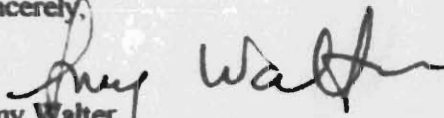
3) The Fox for Congress Committee has failed to disclose the required occupation information for contributors who donated \$55,645 as reported in the Fox for Congress committee quarterly reports, April 15 and July 15, 1994.

The specific violations committed by Respondent B (Horsham Republican Party) are the following:

1) The Horsham Republican Party donated \$2,000 to the Fox for Congress committee during the calendar year of 1994 and \$1,500 to the Greenwood for Congress (\$500 on 4/20/94 and \$1,000 on 5/27/94) without registering with the Federal Election Commission. The Horsham Republican Party thereby exceeded the spending threshold for local party committees on behalf of Federal candidates.

On behalf of the Friends of Marjorie Margolies-Mezvinsky, I urge the Federal Election Commission to take immediate action to address these charges.

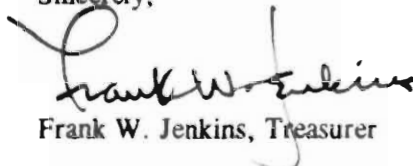
The Fox for Congress Committee ("Committee") wishes to respond to the the above referenced complaint filed by the Friends of Marjorie Margolies-Mezvinsky.

In response to Part 1 of the complaint, the Committee was not aware at the time of receipt of the 5/27/94 contribution that the Horsham Republican Party ("Party") was not registered with the Federal Election Commission ("Commission"). Upon discovery of this information, the Committee notified the Party of the laws and procedures under the Federal Election Campaign Act ("the Act") related to this matter and refunded the full \$2,000 in contributions. It is the Committee's understanding that the contribution it received from the Horsham Republican Party on 3/21/94 was allowable under Federal election law. A refund of the full \$2,000 was made in an effort to demonstrate good faith in complying with the Act and until such a time that the Party may become registered.

In reference to Parts 2 and 3 of the complaint, the Committee wishes to assert that many of the names listed as missing employer information (23 names), clearly do not require employer information (ie., Retired, Homemaker, Partnership). In addition, the Committee has previously supplied the Commission with copies of sample solicitations requesting such information as well as follow-up letters to those who did not supply the information with the initial request (copies are again included). The Committee was waiting for a sufficient number of responses to its request for information letter before sending memo versions of Schedule A with the supplied information. This information has been received for many individuals following second and third requests and the Committee has prepared the enclosed schedules for filing with the Clerk of the House.

The Committee feels that, in light of the information above, the Commission has no reason to take further action in this matter.

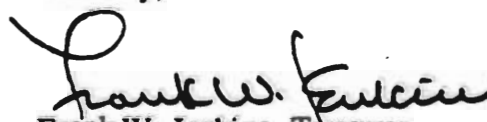

**I. INTRODUCTION**

This report is the General Counsel's Report to recommend that the Commission no longer pursue the identified lower priority and stale cases under the Enforcement Priority System.

**II. CASES RECOMMENDED FOR CLOSING**

**A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission**

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 10 cases which do not warrant further pursuit relative to the other pending cases.<sup>1</sup> A short description of each case and the factors leading to assignment of a relatively

#### B. Stale Cases

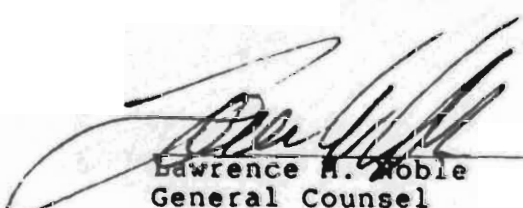
