I, Elizabeth Michael, Treasurer of the Guy Wilson for Congress campaign, and both authorized to act on its behalf, and specifically requested to act in this instance, am filing a formal complaint with the Federal Election Commission concerning the FEC filings of Congressman Walter Tucker III of California, 37th District, Committee number C00261289, during the period of January 1, 1992 through June 30, 1994. There are two counts directly addressed in the complaint: though we see other possible violations in the returns of Mr. Tucker, these two constitute the most egregious. The complaint is as follows:

COUNT ONE: On the filing of May 18, 1994, the Tucker campaign claimed unitemized expenses of \$22,701.51 out of net operating expenses during the period of \$32,448.23. This \$22,701.51 constituted 70% of expenditures, and would have required a minimum of 113 separate and distinct recipients over a period of six weeks to be legitimately non-itemable, the threshold for reportability being \$200 per calendar year.

It is the unanimous belief of the campaign that this

incident is not a simple failure of bookkeeping, or an understandable error, but probably represents deliberate and criminal intent to conceal the identities of the disbursees and conceal the purpose of the disbursements. The activity is wholly inconsistent with the remainder of Mr. Tucker's filings, and wholly inconsistent with a campaign of this size. We also note that this activity occurred during a heated contested primary election.

COUNT TWO: From the period of January 1, 1992 to June 30, 1994, the Tucker campaign failed to provide addresses, employers, and occupations for hundreds upon hundreds of contributors and vendors, at least two hundred separate incidents. A few of the contributors and vendors are readily identifiable and discoverable; however, the vast majority of such items are from unknown persons at unknown addresses with unknown connected industries. We do not believe that all of these individuals failed or refused to provide this legally required information.

We can readily see that very bad bookkeeping has occurred; nevertheless, this failure to report is a violation of federal election laws. But the campaign is not interested in charging the Congressman with bad bookkeeping.

Rather, the effect of the Tucker committee's inaction is to utterly deny the public their right to know the nature of the individuals, corporations, and organizations by impairing the public's ability to investigate and determine which individuals, corporations, and organizations exercise influence over Mr. Tucker. And specifically, Mr. Tucker's opponents' rights, of which Guy Wilson is one, have been violated by this extreme excess of improper bookkeeping.

The Wilson campaign is therefore encouraging the Federal Election Commission to investigate these violations, as both civil and criminal violations, and to initiate said investigation promptly, considering the nature of the counts and their direct relevancy to the November 8th election, and considering the Justice Department has already indicted Congressman Tucker for acts performed as mayor of Compton, California.

This campaign shall forward copies of this complaint to the Justice Department for further criminal investigation and to the House Ethics Commission for consideration as to whether Mr. Tucker should be expelled from the House of Representatives.

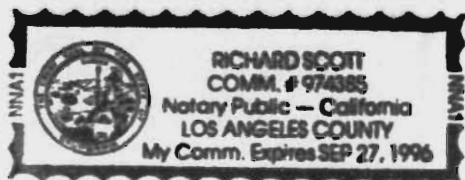

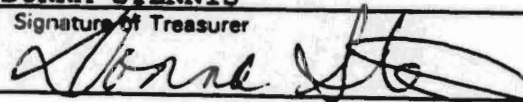

GENERAL COUNSEL'S REPORT

I. INTRODUCTION

This report is the General Counsel's Report to recommend that the Commission no longer pursue the identified lower priority and stale cases under the Enforcement Priority System.

II. CASES RECOMMENDED FOR CLOSING

A. Cases Not Warranting Further Pursuit Relative to Other Cases Pending Before the Commission

A critical component of the Priority System is identifying those pending cases that do not warrant the further expenditure of resources. Each incoming matter is evaluated using Commission-approved criteria and cases that, based on their rating, do not warrant pursuit relative to other pending cases are placed in this category. By closing such cases, the Commission is able to use its limited resources to focus on more important cases.

Having evaluated incoming matters, this Office has identified 10 cases which do not warrant further pursuit relative to the other pending cases.¹ A short description of each case and the factors leading to assignment of a relatively

B. Stale Cases

Investigations are severely impeded and require relatively more resources when the activity and evidence are old. Consequently, the Office of General Counsel recommends that the Commission focus its efforts on cases involving more recent activity. Such efforts will also generate more impact on the current electoral process and are a more efficient allocation of our limited resources. To this end, this Office has identified 33 cases that
