III. BACKGROUND:

Failure to file Forty-Eight Hour Notifications

Hoyer for Congress ("the Committee") has failed to file 48-Hour Notifications totalling \$140,550 prior to the 1994 General Election.

The candidate was involved in the 1994 General Election held on November 8, 1994. Prior Notice was sent to the Committee on October 3, 1994 (Attachment 2). The Notice includes a section titled "48 Hour Notices on Contributions". This section reads "Notices are required if the committee receives contributions (including contributions and loans from the candidate's personal funds; and endorsements or guarantees of bank loans) of \$1,000 or more, during the period of October 20 through November 5. The notices must reach the appropriate federal and state filing offices within 48 hours of the committee's receipt of the contribution(s)."

Schedule A of the 1994 30 day Post-General Report (Attachment 3) indicates that the Committee failed to file 48-Hour Notices for contributions received during the aforementioned period. The following are the contributions, as reported by the Committee, for which 48-Hour Notices have either not been filed or not received by the day before the election:

To ensure that the Commission is notified of last minute contributions of \$1,000 or more to your campaign, it is recommended that you review your procedures for checking contributions received during the aforementioned time period. Although the Commission may take legal action, any response you wish to provide concerning this matter will be considered. (11 CFR §104.5(f))

-Your report includes computer produced formats of Schedule A. Computer produced formats may only be used upon prior approval of the Commission. You should submit a separate sample format with a cover letter requesting approval. Until your format has been approved, FEC forms must be used. (11 CFR §104.2(d))

Steny Hamilton Hoyer won the 1994 General Election in the Fifth Congressional District in the State of Maryland with fifty-nine percent of the vote.

The Factual and Legal Analysis, which formed a basis for the Commission's finding, is attached for your information.

You may submit any factual or legal materials that you believe are relevant to the Commission's consideration of this matter. Please submit such materials to the General Counsel's Office within 15 days of your receipt of this letter. Where appropriate, statements should be submitted under oath. In the absence of additional information, the Commission may find probable cause to believe that a violation has occurred and proceed with conciliation.

In order to expedite the resolution of this matter, the Commission has also decided to offer to enter into negotiations directed towards reaching a conciliation agreement in settlement of this matter prior to a finding of probable cause to believe. Enclosed is a conciliation agreement that the Commission has approved.

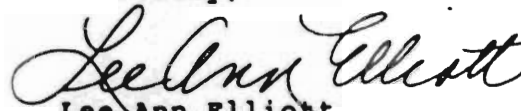

This matter was generated based on information ascertained by the Federal Election Commission ("the Commission") in the normal course of carrying out its supervisory responsibilities. See 2 U.S.C. § 437g(a)(2).

The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, the Clerk of the U.S. House of Representatives or the Commission, as appropriate, and the Secretary of State, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date, of receipt, the amount of the contribution, and the identification of the contributor. Id. The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B).

The General Election in the state of Maryland was held on November 8, 1994. Pursuant to the Act, the Respondents were required to notify the Commission, in writing, of all contributions of \$1,000 or more received from October 20 to November 5, 1994, within 48 hours of their receipt. A review of

the Committee's 1994 30 Day Post-General Report identified 87 contributions received between October 20, 1994 through November 4, 1994, of \$1,000 or more, and totaling \$140,550.00. The Committee submitted 48 Hour Notices for 18 of these contributions totaling \$28,000.00, on November 8, 1994, and 48 Hour Notices for 24 of these contributions totaling \$38,250.00, on November 9, 1994. The Committee did not submit 48 Hour Notices for these contributions prior to election day. Furthermore, the Committee never submitted 48 Hour Notices for 45 of the contributions totaling \$74,300.00.

Therefore, there is reason to believe that Hoyer for Congress and William I. Garner, Jr., as treasurer, violated 2 U.S.C. § 434(a)(6)(A) by failing to report campaign contributions of \$1,000 or more, received after the 20th day, but more than 48 hours before the primary/general election, within 48 hours of receipt of the contributions.

Dear Ms. Elliott:

This will acknowledge receipt of your letter dated May 24, 1995 copy of which I received on May 31, 1995.

I was surprised to receive this first notification that we had not filed the 48 hour notices in a timely fashion. As a result of the receipt of your letter and attachments, we made an extensive review of the transactions in question.

First, let me state emphatically that it has been the consistent policy of our campaign organization to comply with the 48 hour rule. We are very cognizant of its importance and Mr. Hoyer, his Chief of Staff, and I have made it abundantly clear that any contribution of ONE THOUSAND (\$1,000.00) DOLLARS or more should be reported in a timely fashion under the 48 hour rule. However, as you point out, our review indicates that this may not have occurred in every instance. To the extent that that is true, it was absolutely inconsistent with the directions to our campaign personnel.

I have been Mr. Hoyer's Treasurer since 1974. Since that time, we have attempted to comply with every statute and regulation applicable to the filing of our State and/or Federal forms.

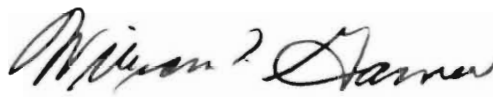
In reviewing the facts surrounding the filings for 1994, it appears that although the transactions were handled in the office in a timely fashion, there was, apparently, a failure to mail some of the reports in a timely fashion and others, inexplicably, appear not to have been mailed or, at least, were never received by the Clerk of the House of Representatives. As you will see from the enclosed Affidavits, it was the policy and procedure of our campaign office to immediately log in any campaign contribution in excess of ONE THOUSAND (\$1,000.00) DOLLARS, fill out a form for filing with the Clerk of the House of Representatives immediately, and have the appropriate form signed and mailed on the same day. As the Affidavits will reflect, Mary Barksdale, an individual who has worked in our campaign office for over 14 years, was responsible for preparing the forms. She would then give them to Lisa Constantino, an individual who has worked for the Congressman for over 10 years and who is employed by the campaign to manage the campaign office throughout the year. Ms. Constantino, would sign them, and then either mail them personally or have them mailed the same day.

Unfortunately, as you indicate in your correspondence, it appears that some of the forms were not mailed on the date they were signed and other forms, signed in a timely fashion, cannot be confirmed as having been mailed and/or received by the Clerk's office. We have included a copy of the forms with this letter which, as set forth in the Affidavit of Ms. Constantino, were signed by her on the date indicated. Notwithstanding the required procedure, however, because the letters were not mailed registered or certified mail, we cannot establish the mailing of some of the forms.

I would reiterate that it was the absolute policy of this office to comply with all of the requisite requirements regarding the disclosure of contributions covered by the 48 hour rule in a timely fashion. To the extent that that was not done, it was contrary to the policy set forth for our campaign office and we can only assume, if the mailings were not effected pursuant to our policies, that it happened either through inadvertence or mistake.

I would look forward to talking to your office and the appropriate individual with reference to this matter at their convenience.

AFFIDAVIT OF WILLIAM I. GARNER, JR.

I solemnly declare and affirm under the penalties of perjury that:

1. I have been the campaign treasurer for various campaign committees of Steny H. Hoyer since 1979. During that time it has been our policy to fully, completely, and excessively disclose all contributions received by Mr. Hoyer and to disclose them in a timely manner. In fact, as the records will reflect, it is Mr. Hoyer's policy to report every nickle that he receives and specifically attribute such contributions to the contributor.

2. It was and is Congressman Hoyer's policy to have me and all persons who work with the campaign to comply with all the requirements of the statute and of the Federal Election Commission in a complete and timely manner.

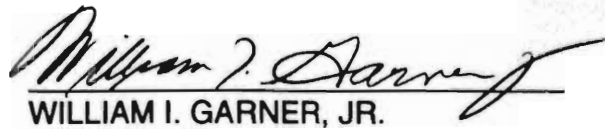
3. In October of 1994 it was the policy of the campaign to have contributions sent directly to the campaign committee. Upon their receipt, they would be logged in, a form for filing with the Clerk of the House of Representatives would be filled out by Ms. Mary Barksdale, and that form would be signed by Lisa Constantino and then immediately mailed to the Clerk of the House of Representatives. Until the receipt of the notice from the Federal Election Commission dated May 24, 1995 and received by us on May 31, 1995, it was my belief and conviction that we had fully complied with all requirements. After receiving the FEC notification, and reviewing our records, as well as those of the Clerk of the House of Representatives, it is obvious that we cannot corroborate the mailing of some of the required reports. While we have copies of the documents asserted by Ms. Constantino to have been mailed by her or at her direction in a timely fashion, we neither have a mailing receipt nor records in the Clerk's office to support that assertion.

4. I can state, however, unequivocally that if the filings were not made in a timely fashion such failure was absolutely contrary to our policy, to the direction received by Ms. Constantino from myself and from Mr. Hoyer's Chief of Staff, William Black, and it is my conviction that if such a failure occurred it occurred through inadvertence and mistake and was not in any way a willful attempt to evade the requirements of law or to hide in any way contributions received.

5. As the campaign finance reports will reflect, Mr. Hoyer received over one million dollars in contributions during the period in question. The receipts in the last month of the campaign were similar to those received previously. I can state

absolutely that there was neither either intent nor direction to do anything other than fully disclose in a timely fashion all contributions received by our campaign.

AFFIDAVIT OF LISA CONSTANTINO

I solemnly declare and affirm under the penalties of perjury that:

1. I have been employed by Congressman Steny H. Hoyer for the past ten (10) years. I initially worked in his Congressional office and after having my first child I began to work part time in his Congressional Campaign office, which is maintained year round. I worked approximately twenty (20) to thirty (30) hours per week.

2. One of my primary responsibilities was to maintain the financial records of the campaign, see to the preparation, execution, and filing of all appropriate forms in a timely fashion. In this capacity, I cooperated closely with and acted under the direction of William I. Garner, Jr., Mr. Hoyer's campaign treasurer. I have acted in this capacity for the last 3 campaigns.

3. I was personally aware of the forty-eight (48) hour rule and its requirement that certain campaign contributions be immediately reported to the Clerk of the House of Representatives upon receipt and in no instance more than forty-eight (48) hours after such receipt. I had been instructed by Mr. Hoyer's Chiefs of Staff, Mr. Sam Wynkoop and Mr. Bill Black, that such forms were to be filled out fully, accurately, and filed immediately upon receipt.

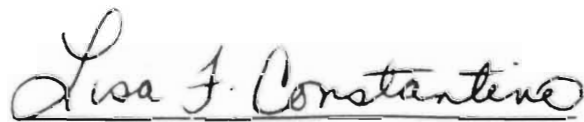
4. During the 1994 general election campaign, it was the responsibility of Mary Barksdale, a campaign volunteer who has worked with us for over 14 years to fill out deposit slips for campaign contributions and, at the same time, fill out forms for filing to comply with the forty-eight (48) hour rule. Once the forms were prepared by Ms. Barksdale, she would give them to me and I would sign them immediately. I would then either personally mail those forms or instruct another individual in the office to do so.

5. To the best of my knowledge, all such forms were, in fact, filed in a timely fashion. Having said that, I have reviewed the forms on file with the Clerk of the House of Representatives. It appears from their records that there were, in fact, forms filed late and some forms filed apparently were never received by the Clerk. Unfortunately, I am unable to explain either the lateness of certain mailings or the non-receipt of others. As I have stated above, it was the clear, unequivocal policy of our campaign to file a full report of every campaign contribution of ONE THOUSAND (\$1,000) DOLLARS or more filed within the time frame covered of the forty-eight (48) hour rule. If that was not done, it was

contrary to our policy and the specific directions I had received. Furthermore, if it was not done, that failure was due solely to the very heavy workload that our campaign experienced during October, 1994 and either I or those under my direction did not mail the forms as was our procedure.

6. I can state without any reservation that there was no reason or motivation not to file the disclosures in a timely fashion and, furthermore, that to have not done so would have violated the specific directions I had been given. It is still my belief that I did, in fact, fully carry out the directions given to me and the requirements of the law. However, as pointed out in the documents forwarded to us, I cannot corroborate that with any documentation in our office other than copies of the forms mailed to the Clerk's Office which we retained in our office. However, I recognize that my assertion that they were mailed is not supported by receipts or copies in the Clerk's Office. I cannot explain that fact.

4. During the general campaign of 1994, it was my responsibility to log in campaign contributions on the day they were received, fill out an appropriate form for filing with the Clerk of the House of Representatives and then give that form to Ms. Lisa Constantino who would sign them and mail them.

5. During the time in question, October 20th through November 5th, I did, in fact, log in, prepare the appropriate form, and give to Ms. Constantino the appropriate forms for reporting the contributions received, I can attest to the fact that all such forms were prepared immediately upon receipt of the contributions and were given on the same day to Ms. Constantino.

6. Furthermore, I can attest to the fact that it was Ms. Constantino's practice to sign said forms as soon as she received them from me. Some were signed the same day and some the next morning, depending upon how late we logged in the contributions.

7. I can further attest to the fact that it was the policy of the office to have such forms then mailed immediately to the Clerk of the House of Representatives. I have no personal knowledge, however, when or whether the

I. BACKGROUND

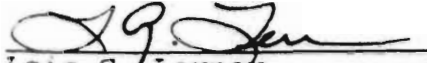
Between October 20, 1994 through November 4, 1994, Hoyer for Congress and William I. Garner, Jr., as treasurer, ("Committee" or "Respondents" or "Hoyer Committee") received 87 contributions of \$1,000 or more totaling \$140,550.00. The Committee submitted 48 Hour Notices for 18 of these contributions totaling \$28,000.00, on November 8, 1994, and 48 Hour Notices for 24 of these contributions totaling \$38,250.00, on November 9, 1994. The Committee did not submit 48 Hour Notices for these contributions prior to election day. Furthermore, the Committee never submitted 48 Hour Notices for 45 of the contributions totaling \$74,300.00. On May 16, 1995, the Federal Election Commission ("the Commission"), found reason to believe that Hoyer for Congress and William I. Garner, Jr., as treasurer, violated 2 U.S.C. § 434(a)(6)(A).

On January 29, 1996, the Federal Election Commission accepted the signed conciliation agreement and civil penalty submitted on your clients' behalf in settlement of a violation of 2 U.S.C. § 434(a)(6)(A), a provision of the Federal Election Campaign Act of 1971, as amended ("the Act"). Accordingly, the file has been closed in this matter.

The confidentiality provisions at 2 U.S.C. § 437g(a)(12) no longer apply and this matter is now public. In addition, although the complete file must be placed on the public record within 30 days, this could occur at any time following certification of the Commission's vote. If you wish to submit any factual or legal materials to appear on the public record, please do so as soon as possible. While the file may be placed on the public record before receiving your additional materials, any permissible submissions will be added to the public record upon receipt.

CONCILIATION AGREEMENT

This matter was initiated by the Federal Election Commission ("Commission"), pursuant to information ascertained in the normal course of carrying out its supervisory responsibilities. The Commission found reason to believe that Hoyer for Congress and William I. Garner, Jr., as treasurer, ("Respondents"), violated 2 U.S.C. § 434 (a) (6) (A).

NOW, THEREFORE, the Commission and the Respondents, having participated in informal methods of conciliation, prior to a finding of probable cause to believe, do hereby agree as follows:

I. The Commission has jurisdiction over the Respondents and the subject matter of this proceeding, and this agreement has the effect of an agreement entered pursuant to 2 U.S.C. § 437g(a) (4) (A) (i).

II. Respondents have had a reasonable opportunity to demonstrate that no action should be taken in this matter.

III. Respondents enter voluntarily into this agreement with the Commission.

IV. The pertinent facts in this matter are as follows:

1. Hoyer for Congress is a political committee within the meaning of 2 U.S.C. § 431(4), and is the authorized principal campaign committee for Steny H. Hoyer's 1994 congressional campaign.

2. William I. Garner, Jr., is the treasurer of Hoyer for Congress.

3. The Federal Election Campaign Act of 1971, as amended ("the Act"), requires principal campaign committees of candidates for federal office to notify in writing either the Secretary of the Senate, the Clerk of the U.S. House of Representatives or the Commission, as appropriate, and the Secretary of State, of each contribution totaling \$1,000 or more, received by any authorized committee of the candidate after the 20th day but more than 48 hours before any election. 2 U.S.C. § 434(a)(6)(A). The Act further requires notification to be made within 48 hours after the receipt of the contribution and to include the name of the candidate and office sought, the date of receipt, the amount of the contribution, and the identification of the contributor. Id. The notification of these contributions shall be in addition to all other reporting requirements. 2 U.S.C. § 434(a)(6)(B).

4. Between October 20, 1994 through November 4, 1994, Respondents received 87 contributions of \$1,000 or more totaling \$140,550.00. The Committee submitted 48 Hour Notices for 18 of these contributions totaling \$28,000.00, on November 8, 1994, and 48 Hour Notices for 24 of these contributions totaling \$38,250.00, on November 9, 1994. The Committee did not submit 48 Hour Notices for these contributions prior to election day. Furthermore, the Committee never submitted 48 Hour Notices for 45 of the contributions totaling \$74,300.00.

5. Respondents contend that any failure to file the 48 Hour Notices involved in this matter under review was inadvertent.

6. Respondents contend that it has procedures for completing and transmitting 48 Hour Notices to the Clerk of the House of Representatives consistent with applicable filing deadlines. Respondents contend that these procedures were followed with regard to the 48 Hour Notices required in this matter, and cannot explain why the Notices were, therefore, not received.

V. The Respondents failed to report campaign contributions of \$1,000 or more received after the 20th day, but more than 48 hours before the general election, within 48 hours of receipt of the contributions, in violation of 2 U.S.C. § 434(a)(6)(A).

VI. Respondents will pay a civil penalty to the Federal Election Commission in the amount of Fifteen Thousand Dollars (\$15,000.00), pursuant to 2 U.S.C. § 437g(a)(5)(A).

VII. The Commission, on request of anyone filing a complaint under 2 U.S.C. § 437g(a)(1) concerning the matters at issue herein or on its own motion, may review compliance with this agreement. If the Commission believes that this agreement or any requirement thereof has been violated, it may institute a civil action for relief in the United States District Court for the District of Columbia.

VIII. This agreement shall become effective as of the date that all parties hereto have executed same and the Commission has approved the entire agreement.

IX. Respondents shall have no more than 30 days from the date this agreement becomes effective to comply with and implement the requirement contained in this agreement and to so notify the Commission.

X. This Conciliation Agreement constitutes the entire agreement between the parties on the matters raised herein, and no other statement, promise, or agreement, either written or oral, made by either party or by agents of either party, that is not contained in this written agreement shall be enforceable.
