I. SUMMARY

Spike Wilson, Democratic candidate for Congress from Nevada, has either (1) developed revolutionary new techniques for fundraising and operating a political campaign *without expense* or (2) filed plainly deficient disclosure reports with the Federal Election Commission. The FEC should investigate Wilson's activities to determine whether his glaring filing omissions represent willful rejection of federal laws or negligent failure to inform Nevadans.

II. JURISDICTION

The NRCC, by and through its Executive Director, Maria Cino, brings this complaint pursuant to 2 U.S.C. § 437g(a)(1) (1994). The N.R.C.C. is located at 320 First Street, S.E., Washington, D.C. 20003.

III. FACTS

1. Nevadans for "Spike" Wilson ("Wilson Committee") is the principal campaign committee of Democratic candidate Thomas R.C. Wilson II, head of the Nevada State Ethics Commission who is running for Congress in the second district.

2. The Wilson Committee filed a second quarter report with the Federal Election Commission ("FEC") on July 13, 1996, covering campaign activity from March 1, 1996 through June 30, 1996. *See Wilson Committee 7/13/96 FEC Report Summary Page (Exh. 1)*

3. The Wilson Committee's second quarter report indicates that it raised \$51,665 over those three months in PAC and individual contributions. Id.

4. The Wilson Committee's second quarter report proclaims that it neither incurred nor received in-kind one cent in expenditures over these three months. Id.

5. Mr. Wilson filed his Statement of Candidacy with the Nevada Secretary of State's office on June 4, 1996. The filing fee for this submission was \$300. According to the Secretary of State's office, Mr. Wilson (or an agent of his campaign) paid in cash. See NV Sec. St. Receipt (Exh. 2).

IV. DISCUSSION

The July 13 public disclosure report filed by the Wilson Committee is blatantly false and/or woefully inaccurate. At the absolute minimum, the Wilson Committee received and paid \$300.00 to the Nevada Secretary of State office on June 4, 1996. See NV Sec. St. Receipt (Exh. 2). This expenditure must be reported, even if made by the candidate himself. See 11 C.F.R. 100.7(a)(1) (campaign expenditures from personal funds are reported as in-kind contributions from the candidate). Similarly, when a person pays for services on the committee or candidate's behalf, the payment is considered an in-kind contribution and must be reported as both a receipt and disbursement.

One may logically conclude that the Wilson campaign incurred some other costs in raising \$51,665 through the month of June. *Indeed, it boggles the mind to believe that Wilson could amass this sum without using one stamp, making one telephone call, paying one staffer, printing one request or borrowing any office space.* Any one of these expenditures would require disclosure, as "unitemized disbursements" at a minimum.

Federal rules explicitly demand that all FEC reports filed by candidates must include "reporting of disbursements." 11 C.F.R. § 104.3(b). This requirement is neither optional nor arbitrary, and the Wilson campaign is not exempt from disclosing its practices and activities to the voters of Nevada.

IV. PRAYER FOR RELIEF

The Commission should investigate the campaign practices of the Nevadans for "Spike" Wilson Campaign and demand that he reveal his campaign's disbursements and expenditures. How a campaign spends its resources reveals much about the candidate, and Nevadans deserve such insight into Mr. Wilson. The Commission should impose penalties as required under 2 U.S.C. § 437g(a) and take appropriate actions to deter future violations of the law.

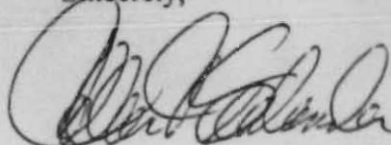

**RESPONSE OF NEVADANS FOR SPIKE WILSON AND
MICHAEL W. KERN TO THE COMPLAINT FILED BY THE
NATIONAL REPUBLICAN CONGRESSIONAL COMMITTEE**

Pursuant to 2 U.S.C. § 437 (g) and 11 C.F.R § 111, Nevadans for Spike Wilson (the "Wilson Committee") and Michael W. Kern, Treasurer for the Committee, respectfully submit this response to the Complaint (the "Complaint") filed by the National Republican Campaign Committee ("NRCC") and set forth the reasons why the Federal Election Commission ("FEC") should take no action regarding this Complaint.

INTRODUCTION

In a brazen attempt to derail the candidacy of Thomas R.C. ("Spike") Wilson for election to the United States House of Representatives from Nevada's second congressional district, the NRCC has filed a baseless and frivolous complaint against the Wilson Committee and its Treasurer, Mr. Kern. The only specific allegation in the complaint is that the Wilson Committee and Mr. Kern failed to disclose Mr. Wilson's personal payment of a \$300.00 filing fee to the Secretary of State of Nevada in its FEC report for the quarter ending June 30, 1996. Under applicable FEC law, that expenditure was not disclosable until the Wilson Committee reimbursed Mr. Wilson, who was not even a candidate until June 17, 1996 -- two weeks prior to the end of the

quarter. The Wilson Committee timely reimbursed Mr. Wilson for that expenditure after the disclosure period had ended and timely disclosed this expenditure, as well as all other expenditures and contributions, in its subsequently filed report dated August 19, 1996. In essence, the Complaint alleges failure to disclose debts that were not even due or reimbursed at the time that the July disclosure was filed. Under such circumstances, there can be no violation of FEC rules. To the contrary, the Wilson Committee and Mr. Kern have complied in all respects with the FEC's rules and regulations. Every penny that has been contributed and expended has been timely disclosed to the Commission.

STATEMENT OF FACTS

1. Thomas R. C. "Spike" Wilson, II is a candidate for Nevada's Second Congressional seat. Nevadans for "Spike" Wilson is his principal campaign Committee.¹

2. Michael W. Kern is the Treasurer of the Committee.²

3. On June 4, 1996, Mr. Wilson filed as a candidate with the Nevada Secretary of State as required under Nevada law. The Nevada law required Mr. Wilson to pay a candidate filing fee of \$300.00 to the Nevada Secretary of State. Mr. Wilson, from his personal funds, issued a \$300.00 check to the Nevada Secretary of State to comply with this requirement.³

4. At the time that Mr. Wilson filed with the Nevada Secretary of State, he was not an official candidate under Federal Election Law. Federal Election law does not recognize one as a candidate until that individual has received or expended \$5,000 in support of his candidacy.⁴

5. Not until June 17, 1996, did Mr. Wilson become an official candidate by virtue of surpassing the \$5,000.00 threshold for contributions.⁵ The funds raised up to that point, and

indeed throughout the remainder of June, did not result from any official fund raising activities. There was no direct mail solicitation, nor was there any organized phone bank operation. Rather, the money was contributed based on published media reports regarding the announcement of Mr. Wilson's candidacy as well as phone calls made by Mr. Wilson and friends seeking contributions.⁶

6. Pursuant to 11 C.F.R. 101.1, Mr. Wilson had fifteen days after becoming a candidate to designate a principal campaign committee. Accordingly, on June 26, 1996, he designated Nevadans for "Spike" Wilson as the principal campaign committee and identified Mr. Kern as the Campaign Treasurer.⁷

7. As Treasurer for the Committee, Mr. Kern was responsible for completing the FEC July 15, 1996 (the "July Report") Report of Receipts and Disbursements for the quarter spanning March 1, 1996 through June 30, 1996.⁸

8. In preparing the July Report, Mr. Kern reviewed the applicable Commission statutes and regulations. Moreover, he obtained all receipts of the Wilson Committee and sought out all records reflecting any disbursements. Based on his review of the applicable rules and his review of all available records, he completed the July Report and submitted it to the Commission on July 13, 1996.⁹

9. The report disclosed total contributions amounting to \$51,665.00. In addition, the report revealed that Mr. Wilson had loaned the campaign \$35,000.00. The \$35,000.00 loan was listed as a debt and obligation owed by the Wilson Committee.¹⁰ The July Report reflected that the Committee made no disbursements prior to June 30, 1996. The Wilson Committee simply did not make any actual disbursement prior to June 30, 1996. Nor had any debts or obligations of the Wilson Committee, such as the reimbursement for Mr. Wilson's payment of the \$300 filing fee,

come due prior to June 30, 1996. Finally, the Wilson Committee received no invoices from any source reflecting a debt or obligation prior to June 30, 1996. Accordingly, consistent with these facts and the FEC Rules, the July Report reflected no Wilson Committee disbursements prior to June 30, 1996.

10. Pursuant 11 C.F.R. § 104.5(c)(1)(ii)(A), the Wilson Committee filed its August Report on August 20, 1996, twelve days prior to the primary election.¹¹ The August report reflects all disbursements made thus far by the Wilson Committee since the inception of Mr. Wilson's candidacy including the Committee's reimbursement of Mr. Wilson for the \$300.00 filing fee.¹²

ARGUMENT

I.

THE \$300.00 FEE WAS A DEBT OF THE COMMITTEE NOT DISCLOSEABLE UNTIL REIMBURSED

Pursuant to 11 C.F.R. 104.11, any debt or obligation incurred by a campaign committee of \$500.00 or less "shall be reported as of the time payment is made or not later than sixty days after such obligation is incurred, whichever comes first."¹³ On June 4, 1996, prior to becoming a candidate under FEC law, Mr. Wilson paid the \$300.00 filing fee from his personal funds, because his principal committee had not yet been formed.¹⁴ The Committee based on its review of the applicable FEC laws, treated Mr. Wilson's payment of the fee as a debt of the Committee that was not disclosable until it was reimbursed.¹⁵ Accordingly, as the Committee did not reimburse Mr. Wilson prior to June 30, 1996, this debt was not reflected, nor was it required to be reflected, in the July Report.

Contrary to the NRCC's baseless contentions, the facts demonstrate that the Wilson Committee timely disclosed payment of this debt. Pursuant to § 104.11, this debt of the Wilson Committee was not discloseable until it had been paid. The Wilson Committee reimbursed Mr. Wilson on August 1, 1996.¹⁶ Reimbursement of this sum is reflected in the August report. Accordingly, the Wilson Committee has fully and properly disclosed the Wilson Committee's payment of the debt.

II.

NO OTHER DISBURSEMENTS WERE DISCLOSEABLE PRIOR TO JUNE 30, 1996

Relying on base speculation and conjecture, the NRCC contends that the Wilson Committee, which was established on June 26, 1996, three days prior to the end of the quarter, somehow violated Federal Election Law by reporting that the Wilson Committee made no disbursements prior to June 30, 1996. That no disbursements were reported, however, should come as no surprise. Mr. Wilson did not become an official candidate under FEC law until June 17, 1996. He had no paid staff or leased headquarters prior to June 30, 1996.¹⁷ Moreover, no campaign debt or obligation of the campaign became due prior to June 30, 1996. Nor had the Wilson Committee received any invoices requiring reimbursement prior to the close of the quarter.¹⁸ Under such circumstances, Mr. Kern reported all debts or obligations that may have been incurred in late June but were not invoiced until after June 30 in the August Report.¹⁹

III.

MR. KERN EXERCISED HIS BEST EFFORTS IN COMPLETING AND SUBMITTING THE JULY 13, 1996 REPORT

The Commission's regulations provide that:

When the Treasurer of a political committee shows that best efforts have been used to obtain, maintain and submit the information required by the act of a political committee, any report of such committee shall be considered in compliance with the act.²⁰

Attached to this submission is the Affidavit of Michael Kern, the Wilson Committee's Treasurer. As set forth in Mr. Kern's declaration, he reviewed the applicable statutes and regulations and investigated the contributions received by the Wilson Committee as well as whether the Wilson Committee made any disbursements or expenditures during the relevant period. Mr. Kern concluded that the expenses incurred by the campaign prior to June 30, 1996 were not discloseable until the Wilson Committee had reimbursed them.²¹

Moreover, the Wilson Committee had not received any invoices reflecting amounts due prior to filing the July Report. Such invoices were submitted to the Wilson Committee subsequent to the filing of the July Report. Accordingly, the Wilson Committee's reimbursements and payment of debts, therefore are reflected in the August Report. As Mr. Kern attests, he in good faith believed that the July Report to be in full compliance with FEC regulations and laws. There is no evidence of any intent to deceive or mislead the Commission by Mr. Kern. To the contrary, as he attests, he put forth his "best efforts" to comply with the regulations when he filed the July Report.²²

CONCLUSION

The NRCC seeks to bolster the fortunes of the Republican candidates for this office by attempting to besmirch the untainted reputation of Mr. Wilson. This reckless intrusion into Nevada politics should not be countenanced -- especially where taxpayers money is being spent to

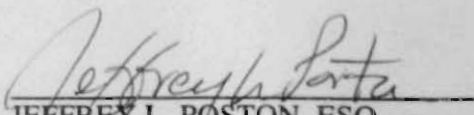

investigate these baseless and unfounded allegations. As the foregoing demonstrates, neither the Wilson Committee nor Mr. Kern have violated the spirit, intent or letter of the FEC regulations and statutes. Indeed, every contribution received and every expenditure disbursed by the Wilson Committee has been fully disclosed in total compliance with the applicable Commission rules and regulations. Accordingly the Commission should dismiss this frivolous complaint and take no action against the Wilson Committee and its Treasurer, Mr. Kern.

Having been duly sworn, Michael W. Kern states as follows:

1. I am the Treasurer of the Nevadans for Spike Wilson Committee (the "Wilson Committee"). The Wilson Committee is the principal campaign committee of Thomas "Spike" Wilson, a candidate for the United States House of Representatives from the Second Congressional District of the State of Nevada.
2. On August 9, 1996, I received the Complaint filed on July 30, 1996 by the National Republican Congressional Committee. I submit this Affidavit in response to that Complaint.
3. As Treasurer of the Committee, I have personally completed and filed with the Federal Election Commission two reports -- one in July and one in August -- disclosing all receipts and disbursements of the Committee.
4. On June 4, 1996, the deadline to file as a candidate for this Congressional seat, Spike Wilson filed as a candidate for Congress with the Secretary of State of Nevada. The State of

Nevada requires all candidates to pay a filing fee of \$300.00 for all filing candidates. Mr. Wilson paid this \$300.00 fee to the Nevada Secretary of State by writing a personal check from his personal bank account.

5. At the time that Mr. Wilson filed as a candidate, he did not have a principal campaign committee, any paid campaign workers, or any official campaign headquarters. In short, the campaign was in the start-up phase. Indeed, under Federal Election law, Mr. Wilson did not even become an official candidate until the contributions received in support of his candidacy exceeded \$5,000.00. On June 17, 1996, Mr. Wilson surpassed the \$5,000.00 threshold for contributions, and thus, became a candidate under FEC law.

6. Throughout June, 1996, the Committee had no official fundraising operation. Rather, contributions were made as a result of media reports announcing Mr. Wilson's candidacy, word of mouth and phone calls by Mr. Wilson.

7. On June 26, 1996, the Statement of Organization for the Wilson Committee was completed. The Statement of Organization identified me as the Campaign Treasurer.

8. One of my first duties as Treasurer was to complete the FEC July 15, 1996 Report the ("July Report") of Receipts and Disbursements for the quarter spanning March 1, 1996 to June 30, 1996. Essentially, it was my responsibility to report all receipts and expenditures of the Wilson Committee during this time period.

9. I undertook a thorough investigation to determine the amount of the Committee's receipts and the amount of its disbursements. I personally reviewed all records available to ensure the submission of a Report in total compliance with the Federal Election laws. I discovered in the course of my review that the Wilson Committee made no disbursements prior to June 30, 1996. The Wilson Committee had not been formally invoiced for any services provided or debts incurred during the relevant time period. Accordingly, I reported accurately that there had been no disbursements from the Wilson Committee prior to June 30, 1996.

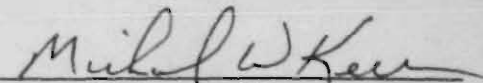
10. Based on my review of FEC statutes and regulations, it was my understanding that expenditures billed and paid after June 30, 1996 were to be reported in the next filing period.

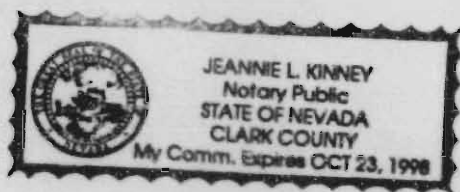
Accordingly, in the report filed on August 19, 1996 (the "August Report"), all such expenditures are reflected -- including the \$300.00 payment to Mr. Wilson. Indeed, the August Report reflects all receipts and disbursements of the Committee since its inception.

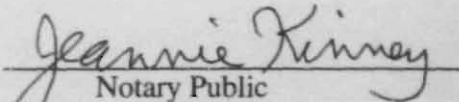

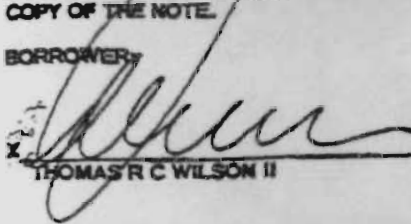

GENERAL COUNSEL'S REPORT

SENSITIVE

I. INTRODUCTION.

The cases listed below have been identified as either stale or of low priority based upon evaluation under the Enforcement Priority System (EPS). This report is submitted to recommend that the Commission no longer pursue these cases.

II. CASES RECOMMENDED FOR CLOSURE.

A. Cases Not Warranting Further Action Relative to Other Cases Pending Before the Commission

EPS was created to identify pending cases which, due to the length of their pendency in inactive status or the lower priority of the issues raised in the matters relative to others presently pending before the Commission, do not warrant further expenditure of resources. Central Enforcement Docket (CED) evaluates each incoming matter using Commission-approved criteria which results in a numerical rating of each case.

Closing such cases permits the Commission to focus its limited resources on more important cases presently pending before it. Based upon this review, we have identified 28 cases which do

not warrant further action relative to other pending matters.¹ Attachment 1 to this report contains summaries of each case, the EPS rating, and the factors leading to assignment of a low priority and recommendation not to further pursue the matter.

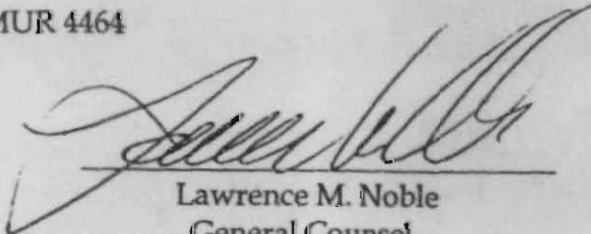

Maria Cino, Executive Director of the National Republican Congressional Committee, alleges that the second quarterly report filed by Nevadans for "Spike" Wilson ("Committee") disclosed that it raised \$51,665 but failed to report any expenditures. Ms. Cino states at a minimum, the report should have shown a \$300 payment to the Nevada Secretary of State for Mr. Wilson's Statement of Candidacy filing fee.

Nevadans for "Spike" Wilson responds that Mr. Wilson did not become a candidate until early June 1996, when he surpassed the \$5,000 threshold for contributions. He registered with the FEC on July 3, 1996. Mr. Wilson paid the \$300 state filing fee from his personal funds. The Committee reimbursed Wilson for the \$300 expenditure after the disclosure period for the July 1996 Quarterly Report had ended on June 30, 1996. This expenditure and others, as well as numerous subsequent contributions, were timely disclosed on its next report dated August 19, 1996.

The evidence indicates no serious intent to violate FECA. This matter is less significant relative to other matters pending before the Commission.
