Dear Madam Chairman:

The National Republican Senatorial Committee files this formal complaint which alleges violations of the Federal Election Campaign Act of 1971, as amended, 2 U.S.C. §§431 et seq. ("FECA" or the "Act"), and related regulations of the Federal Election Commission ("FEC" or the "Commission"), 11 C.F.R. §§100.1 et seq., by Congressman Tim Johnson and the "Tim Johnson for South Dakota" Committee (the "Respondent"). This complaint is filed pursuant to the authority found at 2 U.S.C. § 437g(a)(4)(A).

Based on an analysis of Respondent's reports filed with the Commission, serious questions are raised about possible violations of the Act (personal use of campaign funds and related reporting violations), as well as a violation of Rule 43, clause 6 of the Standing Rules of the U.S. House of Representatives (prohibited conversion of campaign funds for personal purposes); the Internal Revenue Code of 1986 (receipt of and failure to report and pay tax on additional personal income); and the Ethics in Government Act [Public Law 95-521] (acceptance of funds from a campaign committee for reimbursement of personal expenses not reported on personal financial disclosure statements).

BACKGROUND

A report in the October 6, 1996 edition of the Sioux Falls (South Dakota) Argus Leader (at page 4A) indicates that Congressman Johnson has spent over one hundred thousand dollars in campaign funds for countless trips across the country, lodging and meals at posh hotels, taxis and limousine services. A copy of the news article is attached for your review. Of even greater concern, the Argus Leader account suggests that Congressman Johnson's committee has paid more than \$71,000.00 for expenditures which it did not attribute to a lawful campaign purpose.

The Argus Leader report was based on its independent review of a study by the Gannett News Service ("Gannett") of both unexplained personal reimbursements and total unexplained travel and other expenses which were gleaned from the FEC reports of the Senators and Congressmen seeking election to the Senate in the November 5, 1996 general election. Indeed, when Gannett reviewed the Johnson committee's reports it found a number of unexplained expenditures, including the payment of \$1191.66 to the posh White Elephant Resort on the exclusive island of Nantucket and the payment of \$419.00 to "Dial-A-Mattress" in Laurel, Maryland.

VIOLATIONS OF FEDERAL LAW

This Complaint seeks the attention of the Commission to those issues within its jurisdiction. In particular, the Commission is requested to investigate the possibility that Congressman Johnson diverted to his personal use substantial sums of money -- in the tens if not hundreds of thousands of dollars. A large problem confronting any inquiry based solely on his reports is the variable and typically incomplete reporting of his expenses. This, in turn, would indicate the importance of an full field audit by the Commission's staff.

Personal Use

FECA and the regulations promulgated thereunder prohibit the personal use of campaign funds. 2 U.S.C §439a; 11 C.F.R. §113.2(d).¹ "Personal use" is defined as "any use of funds in a campaign account of a present or former candidate to fulfill a commitment, obligation or expense of any person that would exist irrespective of the candidate's campaign or duties as a Federal officeholder." 11 C.F.R. §113.1(g). Simply stated, the rule does not permit a candidate or officeholder such as Congressman Johnson to spend campaign funds for personal expenses he would have incurred anyway -- regardless of his candidacy or office-holding.

One example, specifically addressed by FEC regulation is meals. In promulgating its "personal use" prohibition, the Commission noted specifically the "potential for abuse in the use of campaign funds to pay for meal expenses." 60 Fed. Reg. At 7868 (Feb. 9, 1995). The rule broadly prohibits the use of campaign funds for meals consumed for the personal comfort and convenience of the candidate, and requires the Commission to consider on a case-by-case basis whether a meal has been consumed for an impermissible personal purpose. The same rule applies to the use of campaign funds for lodging or other expenses related to travel. 11 C.F.R. §113.1(g)(1)(ii)(C).

The Johnson Committee's reports to the Commission demonstrate why this review by the Commission is required. The Congressman's use of campaign funds to defray

personal lodging expenses at posh resorts around the country, including the Plaza Hotel in Boston, the Fairmont Hotel in San Francisco, the Luxor Hotel in Las Vegas, the Westwood Plaza Hotel in Los Angeles and the Las Vegas (Nevada) Country Club has been truly prodigious. The following is a list of hotel and resort reimbursements or expenditures paid by the Respondent to or on behalf of Congressman in the last two years alone:

The scale of the spending for these hotel and resort stays is staggering. Without any additional evidence, the numbers standing alone would justify a Commission investigation. There is, however, additional cause for concern about the lawfulness of certain of these expenses. The Argus Leader account suggests more than \$71,000.00 in unexplained disbursements by the Respondent. Such unexplained expenditures, and what they fail to disclose, may raise the most serious of questions about compliance with the statute.

Reporting Failures

The Respondent's reporting methods provide an additional reason for a Commission investigation and determination of liability, inasmuch as they appear calculated to obscure more than they disclose. A number of entries lump various "purpose" descriptions together, so that it is altogether unclear how much was spent for particular purposes. Examples are such combined entries as "travel" or "lodging". A Commission investigation of these entries is required in light of Section 104.3 of Commission regulations, mandating specificity in reporting such expenditures.

CONCLUSION

A thorough audit of the Respondent committee and the Congressman's previous reelection committees is clearly warranted, and enforcement action is urgently needed to address these apparent, serious and wide-ranging violations of the federal campaign spending laws.





Johnson can be frugal, but doesn't always give details

WASHINGTON — Senate hopeful Tim Johnson, D-S.D., isn't always diligent in explaining how he spends campaign funds, but he sometimes is frugal.

Just before his 1994 re-election to the House of Representatives, Johnson visited Saint Paul, where he stayed at the Super 8 Motel on West 41st Street. He went home again after the election to thank supporters, and this time, while in Aberdeen, he stayed at the Comfort Inn on 8th Avenue, S.E.

Johnson undoubtedly saved his

campaign a few dollars during these trips. But he never explained to reporters filed with the Federal Election Commission how the expenses related to his campaign.

An analysis of Johnson's campaign spending from 1987 through June 1993 shows \$71,123.86 in expenses which he did Johnson 7A

not attribute to election campaigning.

Most of that money went for travel — sometimes on chartered flights — and lodging, including \$1,750.36 worth of expenses that were noted as being incurred by Johnson himself.

On three occasions in 1982, campaign funds were used to reimburse Johnson for travel on planes totaling \$12,111. The campaign also reimbursed Johnson's wife, Barbara, twice for 1984 travel expenses totaling \$44.

Aide defers expense

Johnson, who is challenging Republican Sen. Larry Presser, was campaigning in South Dakota last week and unavailable for comment. Jim Jordan, Johnson's campaign spokesman, said all of the expenses in question were campaign-related.

Jordan said campaign officials estimated that 80 to 90 percent of the unitemized travel was by Johnson. "The remainder would be staff and, to a lesser extent, family coming out to campaign," Jordan said.

Johnson could not remember how he personally incurred reimbursable campaign expenses in 1982. Jordan said, because so much time has passed.

And it is difficult to locate every receipt because some financial records are still in the possession of Johnson's former treasurer, Jordan said.

But Jordan said Barbara Johnson probably was reimbursed for meals she used to acknowledge donations and campaign

events held on her husband's behalf.

"She had written a lot of thank you's, and that's almost surely what that is, but I wouldn't swear it's a court of law without the records in front of me."

It has been illegal since 1975 to convert campaign funds for personal use, but the FEC did not develop definitions on personal spending until 1980.

Federal law allows campaign expenses to be used for meals, media advertising, salaries, postage, travel, party fees, phone bills, travel expenses, travel expense reimbursement and lodging costs — if they pertain to election campaigning.

But a Grand Jury Service analysis of campaign spending by senators whose posts are up this year raised serious questions about whether some members of Congress routinely skirt the law.

GNS analyzed Johnson's spending because he is an incumbent U.S. Representative running for the Senate.

Skirting reporting is not a violation of the law. But critics say obscure regulations and lack of enforcement open the door to deceptive use of campaign funds by members of Congress.

"I'd guess there are probably gray areas in every single congressman's office," said Suzanne Knudson, a Sioux Falls resident who, with her husband David, gave \$250 to Johnson's Senate campaign. "But you make a decision as to whether you trust the people you are giving money to to be as upfront and ethical as they are supposed to be."

Johnson's campaign said he

supports stronger FEC reporting requirements for elected officials and candidates, and that Johnson sponsored a bill to that effect two years ago.

Push for stronger laws

The measure would have required House and Senate members to provide dates, departure, arrival and destination points, and identify travelers when reporting travel expenses.

Johnson's bill died in committee without a hearing.

There were occasions when Johnson and his staff ran up tabs at priors hotels without explaining those expenses on FEC reports. Earlier this year, he and staff were in Los Angeles where they stayed at the Westwood Plaza Hotel. Last year, the campaign incurred a \$1,100.00 bill for a trip to the White Elephant Resort in Monticello, Mont.

The campaign also chartered flights on several occasions without explanation. And there was \$697.00 in expenses at the House restaurant — and a \$44 tab at the Senate restaurant last year.

Jordan said the California trips were fund-raising, and the Monticello expenses were incurred during an event the Democratic Senatorial Campaign Committee held for candidates. The weekend included strategy sessions and meetings with party contributors.

Johnson charged the campaign when he dined in the House restaurant with staff, constituents and supporters of his campaign, and for a meal with Senate Minority Leader Tom Dardis, D-S.D. during which the two South Dakotans talked campaign strategy, Jordan said.







Dear Ms. Sealander:

This is in response to the complaint filed against Tim Johnson for South Dakota, Inc. and its treasurer, Berniece F. Mayer, by the National Republican Senatorial Committee ("NRSC").

This complaint represents a shabby effort to retaliate for a more serious complaint filed by the Democratic Senatorial Campaign Committee ("DSCC") against Senator-elect Johnson's campaign opponent, outgoing Senator Larry Pressler. Both complaints stem from a series of articles in the Sioux Falls Argus Leader, examining the spending practices in the South Dakota Senatorial race. To put this complaint in context, one need only look at the headlines. One article was headlined, "Sen. Pressler ranks No. 1 in payments to himself."¹ In contrast, the headline of the article cited in the complaint described Senator-elect Johnson as "frugal" in his campaign spending.

When the DSCC questioned Senator Pressler about a record described by an investigative reporter as "worse than any candidate I've studied,"² the NRSC responded with threats of retaliation if the line of questioning was pursued. This complaint is just the follow-through of those threats. Indeed, in a perverse sort of compliment, the instant complaint parrots the very words of the Pressler complaint, inappropriately since the expenditures by Senator-elect Johnson are in no way comparable to those of his predecessor.

The complaint at issue here questions the use of campaign funds for legitimate travel and meal expenses related to fundraising and meetings with supporters and elected officials. Disingenuously, the complaint even questions an expense which (as has been previously explained to the complainant) demonstrates Senator-elect Johnson's frugality, the \$419 payment to Dial-a-Mattress in Laurel, Maryland. The bedding in question was purchased for the campaign headquarters and made available to visiting campaign workers required to stay overnight. The decision was made to acquire bedding to avoid the cost of overnight stays at hotels or motels, which ultimately would have been more expensive.

Contrary to the unsubstantiated speculation in the complaint, all of the travel expenditures noted therein were incurred for legitimate fundraising purposes; none were for the impermissible "personal use" of Tim Johnson or anyone else. With respect to the alleged reporting failures, it is difficult to imagine what ambiguity the complainant perceives in a disbursement, for the stated purpose of "travel," to a hotel or car rental company. In fact, Commission regulations specifically approve of the description "travel" for these types of disbursements. 11 C.F.R. § 104.3(b)(3)(i)(B).

Nonetheless, the Committee is happy to provide more detail on each of the trips that the complainant describes as "questionable." For convenience, the expenses are listed in roughly the order in which they appear in the complaint; some expenses are grouped out of order because they pertain to a single trip.

On October 29, 1995, Senator-elect Johnson attended an event in Chicago, raising \$7,000 for his campaign.

While not mentioned in the letter of complaint, the disbursement records attached thereto also highlight various meals in the House of Representatives Dining Rooms and purchases of flowers. The meals were consumed with visiting contributors. The flowers were sent either as tokens of gratitude to individuals who hosted fund raisers on behalf of the Senator-elect or as expressions of sympathy to supporters who had suffered a loss. All of these are clearly permissible uses of campaign funds, even after the adoption of the personal use regulations (although a number of the expenditures were made before then). See, 11 C.F.R. § 113.1(g)(4).

The Commission's personal use regulations were designed to preclude the use of campaign funds "to fulfill a commitment, obligation or expense of any person that would exist irrespective of the candidate's campaign or duties as a Federal officeholder." 11 C.F.R. § 113.1(g). As has been amply demonstrated above, all of the expenditures identified in the complaint were directly related to the Senator-elect's fundraising for his campaign. The complaint is baseless exercise. We respectfully ask that it be dismissed.

Sen. Pressler ranks No. 1 in payments to himself

Campaign paid him \$125,351 since 1991

WASHINGTON — Sen. Larry Pressler, R-S.D., has spent hundreds of thousands of dollars in campaign funds for countless trips across the country, lodging and meals at posh hotels, parking tickets in Washington, opera tickets, even maid service.

Since 1991, Pressler has used his campaign war chest for nearly half a million dollars of such expenses — without specifying how they related to campaigning. Pressler has spent \$488,738, more than double any other senator up for re-election this year.

Many times, money has gone directly to Pressler or his wife, Harriet, as reimbursement for "travel" or "subsistence" expenses.

Pressler declined to talk about his campaign spending because, his office said, he is too busy.

But Ben Ginsberg, Pressler's

lawyer, said the expenses listed on the senator's Federal Election Commission reports are for campaign activities or other official business, and that his reporting methods comply with FEC requirements.

"If it were not a campaign-related expense, it would not appear on the FEC report, nor would campaign funds be used for it," Ginsberg said. "Senator Pressler knows what the rules are and abides by them scrupulously."

As public pressure slowly has forced reforms on Congress — bans on big fees for giving speeches and lobbyist-paid trips to luxury resorts

flexible restrictions on how members can spend campaign money can be seen as the last bastion of congressional perks.

Members of Congress insist such spending is related to their re-election efforts or official congressional duties, and thus is legal. Critics charge that all too often campaign money is, in reality, being converted to personal use — an illegal practice since 1975.

A computer-assisted analysis by Gannett News Service of reports filed with the Federal Election Commission by senators elected in 1994 — 18 of whom are seeking re-election next month — graphically shows how differently candidates use and account for money they solicit from supporters.

Pressler leads that class of senators in money reimbursed directly to him from 1991 through June 1994 — \$125,351. The second highest — \$77,352 — was reimbursed to Sen. Carl Levin, D-Mich.

When asked for records that detail how Pressler incurred some of his reimbursable expenses and other expenditures in FEC reports, Ginsberg said the campaign would try to locate them, noting that many are in South Dakota.

"We'll see what we can do," Ginsberg said, adding that a decision would hinge, at least in part, on how Pressler is treated in this newspaper article. "Basically, we'll see if it's a fair treatment or a gratuitous slam job."

A Gannett News Service analysis of 5½ years of campaign reports show that Pressler's campaign spent \$490,758.88 that it did not attribute to campaign activities.

The reports, dating to 1991, offer few clues to explain how or why Pressler and his wife incurred so many expenses that required reimbursement, or how any of the nearly \$500,000 spent related to campaign activities.

Pressler Pressler's total was significantly more than any other senator in the 31-member group studied. The second-highest was retiring Wyoming Sen. Alan K. Simpson, whose campaign spent \$243,974 that it did not link to campaign activities.

Congress declared personal use of campaign funds illegal in 1975. Persistent incidents of violations led to the FEC developing some regulations on personal spending in 1995.

continues to be accepted by the FEC, and a GNS analysis of campaign spending raises serious questions about whether some members of Congress routinely get around the law.

Federal law says funds can be spent on these campaign expenses: meals, media advertising, salaries, polling, travel, party fees, phone banks, travel expenses, travel expense reimbursement and catering costs if they pertain to election campaigning or official Senate business.

In instance after instance, the GNS analysis shows, Pressler and other senators do not detail on reports they file with the FEC the specific purpose of travel, meals and other items that could be converted to personal use.

Pressler's campaign picked up a \$4,250 tab at the Flamingo Hotel in Miami earlier this year. In 1994 and 1995, the campaign paid a Washington woman \$1,375.18 for cleaning services and twice for catering.

Another \$1,195 went for Washington Opera tickets. The D.C. Treasurer was paid \$219 for "parking expense" in recent years that turn out to be parking tickets.

Pressler also spent \$83,728.76 since 1991 on unitemized expenses. But no single vendor received more than \$200 in a given year, according to the senator's FEC reports, so Pressler did not have to detail how he spent that money.

During the period studied, Pressler was personally reimbursed \$125,351 in campaign funds for travel, lodging, meals and other expenses. The campaign paid Harriet Pressler another \$1,169.33 for similar expenses.

Ginsberg said that over the years, Pressler had preferred to use his personal credit card for campaign activities, then submit expenses for reimbursement rather than use credit cards issued to the campaign. He added, though, that Pressler might use a campaign credit card now, "as the campaign's heated up." Similarly, he said, Harriet Pressler's expenses were incurred when she accompanied her husband on campaign events.

Cooking, cleaning bills

The campaign paid Maxine McClain to clean the Presslers' Capitol Hill townhouse and to cook at times because he held fundraisers and entertained constituents there, Ginsberg said. She might have cooked and cleaned for the senator at other times, he said, but she would have been paid

with Pressler's own money.

Parking tickets probably were incurred when Pressler attended large fund-raising events in Washington, possibly hosted by the Republican Party, but Ginsberg said he would have to look at records to be more specific.

"The implication from the question is that Pressler was paying personal parking tickets off of it," he said. "Everybody swears up and down that was not the case in any way."

Opera tickets

When Pressler's constituents visited Washington, they were sometimes treated to an opera show, at campaign expense.

"Somebody got the idea — whether good or not — that this would be a good way to let potential donors spend some time with Senator Pressler," Ginsberg said. The program has since been discontinued.

Ginsberg said it's unfair to question expenditures not accompanied by an "arbitrary three words" that attribute expenses to fund-raising events or campaign activities because the notation isn't required by law. And, he said, members of Congress and candidates — and individuals within those campaigns — use different reporting methods. Nevertheless, words to that effect often accompany entries throughout Pressler's FEC reports; in those cases, GNS did not treat spending as unexplained.

While political action committees might not complain about how congressmen and senators spend money they donate to campaigns, Meredith McGehee of the citizens' lobby Common Cause said small donors might.

"They wouldn't be contributing if a candidate asked them to give money to my slush fund to support my lifestyle," said McGehee, Common Cause's legislative director.

Travel expenses

Soon after winning election to his third Senate term in 1990, Pressler was off traveling at the

campaign's expense. He was reimbursed for \$8,040.53 in "travel & subsistence" expenses in January 1991. Pressler continued to receive thousands of dollars in travel reimbursements every month for the next two years.

The pace resumed in July 1991, after a six-month hiatus during which Pressler received no reimbursements, FEC records show.

Where Pressler went, and what he did during those trips is not clear because none of that information was included in the campaign reports filed with the FEC.

In November 1991, Pressler was quoted in Roll Call, a semiweekly newspaper that covers Congress, as saying he started meeting with contributors and consultants shortly after the 1990 election to prepare for a six-year fundraising effort.

"We had a tough race last time.

... This time I'm not going to be caught like I did last time," the senator was quoted as saying. Pressler defeated Democrat Ted Muenster in that 1990 race with 52 percent of the vote — a decline from his showing in past Senate races.

Pressler's campaign reports list thousands of dollars in expenses paid to American Express and Citibank without explanation. Thousands more were paid to Exxon for "travel" and to two popular Capitol Hill liquor stores — all without explanation.

There were meals at the Holiday Inn and Minerva's Restaurant in Sioux Falls, and at the Ritz Carlton and La Brasserie Restaurant in Washington.

None of those spots was as popular as the U.S. Senate Restaurant, though. Pressler's campaign spent \$33,630.37 there between January 1991 and the end of June of this year, without explanation.

It was all tied to the campaign or the senator's official duties, Ginsberg said — no different from what other members of Congress do.

Pressler may have 'bent'

SIoux FALLS, S.D. (AP) — Sen. Larry Pressler wanted to talk Friday about flooding but instead received a flood of questions from reporters over allegations he used campaign funds for personal use.

Pressler, who called a news conference to discuss a proposal regarding the U.S. Army Corps of Engineers to compensate landowners for flooding along the James River, spent more than half an hour responding to allegations he used campaign funds for personal expenses.

The allegations surfaced this week

in an article on the Internet by Dwight Morris, an investigative reporter who has worked for the Los Angeles Times, The New York Times and the Atlanta Journal-Constitution.

The article alleges that Pressler, a Republican, "appears to have bent" federal election laws.

Pressler, who is running for a fourth term against Rep. Tim Johnson, D-S.D., denied any wrongdoing.

"I'm proud, proud, proud of my campaign records," Pressler said at least six times during the questioning.

The article claims that since Jan. 1, 1991, Pressler paid for 128 lunches and dinners costing more than \$16,000

at up-scale Washington restaurants. Morris also claims that Federal Election Commission reports show the campaign has also spent more than \$33,000 for meals at the Senate restaurant.

But Pressler explained that the meals involve large campaign events and that the meals at the Senate restaurant are for constituents from South Dakota who visit Washington. He also said that events are held with other members in an attempt to draw attention to issues that might affect South Dakota.

Pressler said if the allegations about the extravagant meals were true, "I'd be a lot heavier than I am."

Morris claims Pressler's FEC reports show more than \$345,000 in unitemized expenses, which he claims is 10 times more than anyone in Congress.

"I don't know if that's true," Pressler said.

Morris, considered an expert on FEC reports, said what he found in Pressler's records were extraordinary.

"It is worse than any candidate I've audited," Morris told Sioux Falls television station KJLO earlier this week.

"These are expenses that were legal, proper and they were run through an accounting firm," Pressler said.

Also in question was the fact that

Pressler raised more than \$482,000 in the first four years of the election cycle, \$185,000 less than he spent.

"It's a very difficult life to meet all those requirements and I do it by spending a lot of money. I have an accounting firm that goes through every single bill. I've been in Congress 22 years and I've never been found in violation of any campaign spending laws."

"I have to report where my plane lifts off the ground, where it lands, there's no life in America more reported than that of a United States senator," Pressler said.

Jim Jordan, Johnson's campaign spokesman, issued a statement earlier this week criticizing Pressler.

"Even a casual examination of Senator Pressler's FEC reports raises very, very serious questions about his use of millions in campaign funds," Jordan said. "At a minimum, the senator is using his campaign to subsidize an excessive lifestyle of four-star restaurants and first class travel."

GENERAL COUNSEL'S REPORT

I. INTRODUCTION.

The cases listed below have been identified as either stale or of low priority based upon evaluation under the Enforcement Priority System (EPS). This report is submitted to recommend that the Commission no longer pursue these cases.

This is the first Enforcement Priority Report that reflects the impact of the 1996 election cycle cases on the Commission's enforcement workload. We have identified cases that are stale which are recommended for dismissal at this time. This is the highest number of cases identified as stale in a single report, and the highest number of stale cases recommended for closure at one time, since the inception of EPS in 1993.

II. CASES RECOMMENDED FOR CLOSURE

A. Cases Not Warranting Further Action Relative to Other Cases Pending Before the Commission

EPS was created to identify pending cases which, due to the lower priority of the issues raised in the matters relative to others presently pending before the Commission, do not warrant further expenditure of resources. Central Enforcement Docket (CED) evaluates each incoming matter using Commission-approved criteria, resulting in a numerical rating for each case.

Closing such cases permits the Commission to focus its limited resources on more important cases presently pending before it. Based upon this review, we have identified cases that do not warrant further action relative to other pending matters.³ Attachment 1 to this report contains summaries of each case, the EPS rating, and the factors leading to assignment of a low priority and recommendation not to further pursue the matter.

B. Stale Cases

Effective enforcement relies upon the timely pursuit of complaints and referrals to ensure compliance with the law. Investigations concerning activity more remote in time usually require a greater commitment of resources, primarily due to the fact that the evidence of such activity becomes more difficult to develop as it ages. Focusing investigative efforts on more recent and more significant activity also has a more positive effect on the electoral process and the regulated community. In recognition of this fact, EPS provides us with the

means to identify those cases which, though earning a higher rating when received, remained unassigned for a significant period due to a lack of staff resources for effective investigation. The utility of commencing an investigation declines as these cases age, until they reach a point when activation of a case would not be an efficient use of the Commission's resources.

We have identified cases that have remained on the Central Enforcement Docket for a sufficient period of time to render them stale. We are recommending the closure of cases based on staleness.⁶

Mr. Demio recently entered into a plea agreement with the Department of Justice (on which we were not consulted) in which he agreed, among other things, to waive the statute of limitations regarding civil violations of the FECA. Considering the age of the case and activity, the fact that DOJ has not formally referred this matter to us, and the Commission's continuing resource constraints, dismissal is the appropriate disposition of this matter.


