We are the attorneys for Longevity International Enterprises Corporation ("LIEC"), and this letter is in response to your letter dated December 6, 1996.

As set forth in your letter, your letter stated that LIEC can request extensions to answer the request. This letter is therefore requesting an extension.

The reason for the extension is that with respect to your letter dated December 6, 1996 with the enclosed documents, the letter was served on CT Corporation Systems in Los Angeles. LIEC is no longer a California Corporation, having been merged into a Hawaii corporation. Therefore, it is unclear to us why service of these documents were made in California. 
